A wedding, in most societies, is celebrated with openness and grandeur. It is encouraged in Islam, for instance, that marriage be announced publicly, so that it becomes a recognized and blessed bond within the community. The Prophet Muhammad (peace be upon him) emphasized the idea of public declaration by permitting simple musical instruments and encouraging lawful joy. This shows that weddings are not merely personal unions but communal acknowledgments of responsibility and family extension. They inspire people to think about building, creating, and contributing to the future. Funerals, on the other hand, awaken a sense of transience and the futility of excessive attachment to material possessions. This duality of experience, celebrating life's beginnings and contemplating life's ends, establishes a necessary balance.
