WOMEN RIGHTS IN WEST:

Women rights in west started from a suffrage movement in ~~sevent~~ nineteenth century. Later on, in late twentieth century, this movement started as a "feminist movement" in the west. This movement demanded the rights of women to be ensured and protected. Subsequently, in 1979 United Nations passed the "Convention on Elimination of Discrimination Against Women (CEDAW)" to protect women rights in a formal and documented manner.

DIFFERENCE BETWEEN WOMEN RIGHTS IN ISLAM AND FEMINISM IN THE WEST:

① EQUALITY :

Both Islam and the West oppose discrimination against women. Islam ensures equality of women with equity, whereas the western feminism concept complete equality in all domains. For instance, Islam state "women are equal to men" in respect and responsibilities, but not in life affairs. Men is responsible to take care of women financially, her health, her security. Whereas, women in West demand do not demand protection, feminism demand equality in all spheres of life.

② FINANCIAL EQUALITY :

Feminism states financial independance is must. Women must

not be dependant upon men either her husband, father or brother. On the other hand, men is obligated to provide women her needs, also her permissible demands and wants. Although, women can earn if they want to do so. Prophet (P.B.U.H)'s Wife Hazrat Khadija (R.A) was the most influential businesswoman of Arab. Also, women are still responsibility of her husband or father, even if she earns and no one has share from her earning or wealth. As Sahih Bukhari state- "A women is owner of her own wealth".

③ MATTERS OF MARRIAGE AND DIVORCE:

In Islam, there is no compulsion in marriage and not even in divorce but divorce is ~~not~~ considered as a least and disliked way.

④ INHERITANCE:
