LIBERAL INTERNATIONALISM AND ITS EVOLUTION THROUGH WILSON, ANGELL & ZIMMERN:

INTRODUCTION: In the 20th century the global crisis convinced scholars that war was neither inevitable nor rational, inspiring new ways to organize global politics. Liberal Internationalism emerged as a response to the failure of power politics, promoting cooperation, institutions and rule based order. Woodrow Wilson, Norman Angell and Alfred Zimmer each articulated ideas that shaped this intellectual tradition.
