'Dynastic politics is the most mockery of democracy'

"When defeat feels like an existential threat to politicians and their constituents, they grow desperate to avoid it," said Steven Levitsky, an American political scientist. The best way to avoid that threat is to remain in power. Thus, the prevalence of dynastic politics. Resultantly, the democracy is compromised. In the dynastic political setup, political participation is a distant dream for non-influential individuals. There is no concept of political pluralism due to lack of inclusivity. Free media face restrictions in this setup. Moreover, there is lack of accountability for those in power. Elections are rigged. Nepotism prevails in the dynastic political setup. Furthermore,

separation of power is compromised because of executive overreach. Fundamental rights of individuals are compromised due to autocratic tendencies of dynastic politicians. Reasons behind its prevalence include lack of education, dysfunctional local government, and lack of intra-party elections. Therefore, dynastic politics is the worst mockery of democracy, because it compromises all the fundamentals of the latter. However, it can be deterred by identifying key causes behind its prevalence and implementing strategic measures.

To start with, political participation is a distant dream for those not belonging to the influential families. In a dynastic political setup, only few families rule. An ordinary

individual in powerful position is a threat to their dynasty.

Moreover, they create such policies that prevent ordinary meritorious individuals from true participation.

These families are influential as well as rich at the same time.

In contrast, ordinary people lacks both of these vital elements of participation. One of the

examples is of Pakistan where

Bhutto family is ruling from

1971 and Sharif family from

1981. To date, these families

remain in power, hence, political

participation is a luxury for

those not belonging to influential families.

Second, this lack of inclusivity results in jeopardisation of the

core element of democracy that

is pluralism. Democracy is

all about giving equal

opportunity to everyone. However, this basic element is nowhere to be seen in countries that are ruled by dynastic politicians. One of the prime examples is of Rajapaksa family of Sri Lanka holding 40 percent of cabinet positions including key ministries. This clearly shows how pluralism is lacking in dynastic setups.

Third, free media face restrictions in a country where there is dynastic political system. Free media is an effective tool to spread awareness among the masses. This awareness may result in people questioning the status quo and can be a threat to their rule of existing dynasty. To prevent this from happening, those in rule enact harsh media regulations. For example, Haseena

wajid, dynastic politician who ruled Bangladesh introduced 'Digital security Act' to suppress voices coming from media. This clearly reflects how media face difficulties in dynastic political setup.

Moreover, there is no concept of free and fair elections when only few families are to compete in it. Elections are ~~core element of democracy.~~

~~Its purpose is to provide the opportunity~~ to all candidates from diverse backgrounds. However, in a dynastic system, true letter and spirit of fair elections is compromised. As per a research

paper published by University of Philippines, 70% of the candidates in Philippine's elections belonged to Marcos, Tolentino and Villars.

There are influential families of the country. Therefore, elections

are only in name where there is dynastic politics dominant.

Furthermore, dynastic politicians are not held accountable in their respective countries.

Resultantly, another key element of democracy is jeopardised that is the accountability. In a true democracy, no one is above the law. There ^{exist} is the rule of law. However, influential families are above the law in their

respective countries. One of the many examples is of the Amputian family of Philippines. When

people showed discontent regarding their rule and protested, government ordered 'shoot to kill'. This resulted

in the infamous 'Philippines

Massacre of 2009'. To date, no one is held accountable. This manifests how these families go unaccountable for their actions.

To add on, meritocracy, another key element of democracy is compromised due to dynastic politics. Those in power influence every sector and department to remain in power. The best way to do that is by appointing close relatives and aides to key positions. Resultantly, those deserving these positions remain under the influential and less qualified people. For example, Samajwadi Party in Uttar Pradesh of India is influenced by a single family and its family members are appointed in all of the key positions. Hence, dynastic politics is an impediment to meritocracy.

Additionally, preference of executive overreach by dynastic politicians results in compromised separation of

power. Introduced by Montesquieu, separation of power remains the ultimate parameter for checking the quality of democracy. This includes judiciary, parliament, and executive all accountable to one another. However, dynastic politicians prefer overdeveloped state structure with judiciary - one responsible for making the rulers accountable - as subordinate and encroached. Key example is of the Assad's regime of Syria where Al-Assad's policies made judiciary his government's subordinate. This is the clear manifestation of jeopardised separation of power in a dynastic political setup.

Lastly, in result of dynastic policies, fundamental rights are compromised.

Citizens with rights demand democracy in its true letter and

spirit. This will directly pose a threat to the politicians who are ruling for decades. Resultantly, they tend to rip the citizens of their rights including freedom of speech, freedom of expression, right to education, information and many more. Regime of Hosni Mubarak is one of the examples where quota in education system led to revolution by students. Therefore, citizens are deprived of fundamental rights in dynastic politicians led government.

The first and foremost reason is the lack of education and civic literacy amongst

the masses. Illiterate people do not question the status quo. They are easy to manipulate. That is why dynastic politicians devise such policies that keeps people uneducated and unaware. An assistant presiding officer wrote in Dawn newspaper of Pakistan that when he asked a person that why all of the people were voting for one party only. The person replied that the forefathers of that party gave many sacrifices. Hence, lack of education and civic literacy gives fuel to existing dynastic politics.

Second, a dysfunctional local government system is another cause of prevalent dynastic politics. Lack of local government system results in power to be centralised

at provincial or central levels, ultimately, it becomes easier for few individuals to be in charge of all the affairs.

Moreover, lack of participation at local level disempowers the citizens. In Pakistan, there is a growing talk of making LG system functional. However, governments prefer the power to be centralized. This clearly reflects how dynastic politicians prefer centralized power. Therefore, lack of strong local government system is another cause of dynastic politics in Pakistan.

Third, intra-party elections result in lack of internal democracy. In intra-party elections candidates from a single party compete with one another to fight in elections for the top slot. Resultantly,

internal democracy prevails and meritorious candidates gets to the top. However, dynastic politicians perceive it as a threat to their rule. This is one of the prime reasons behind dynastic politics in Pakistan where Article 17(2) requires parties to hold intra-party elections, but without proper oversight. Ultimately, no intra-party elections become key cause of dynastic politics.

While there are many causes behind prevalence of dynastic politics, they are not insurmountable. Following are the remedies to deter dynastic politics.

First and foremost step to be taken is to spread awareness among masses and educating them. Civil society plays an important role in doing the job.

literate masses will question the status quo and will demand change. As Thomas Jefferson said that an educated citizenry is a vital requisite for the survival as free people. Moreover, western democracies are free of the menace of dynastic politics. ~~This is because the people there are literate. Therefore, spreading awareness and promoting education among masses will deter dynastic politics.~~

Second, a functional local government system to promote grass root level participation.

This system will play an effective role. ~~it will give~~ it will impart opportunity to ordinary and meritorious individuals to rise to power. An effective LG system ~~deserve~~ requires devolving all powers from upper to

lower - local government - level, resulting in those weakened power of those in rule. Zohran Mamdani, an ordinary individual, became Mayor of New York through the very local government elections. This is an example of how local government system empowers the individuals other than the powerful elite. Hence, LG system will deter dynastic politics.

Lastly, making intra-party elections statutorily mandatory will become an effective way to promote internal democracy within the party. This can be done by making intra-

party elections **avoid writing in passive please** binding on all parties. Also, to ensure fairness, an independent election body will play a crucial role. One of the reasons that there is no dynastic

political setup in USA is strong intra-party elections. These elections are mandatory to become eligible for Presidential elections. Thus, intra-party elections will play a massive role to prevent dynastic politicians from coming into power.

In conclusion, dynastic politics is indeed the worst mockery of democracy - for it compromises the democratic values. From preventing political individuals from participation in politics to ~~promoting nepotism~~ **to promote** it serves as an impediment to democracy taking place in its true spirit. However, number of measures ~~could be taken~~ to deter dynastic politics from taking place. These include, spreading awareness, making local governments functional, and
