A just society and a just individual are those in which every part performs its assigned role without interfering with others. Thus, justice ensures stability, virtue, and overall well-being.

02 BACKGROUND OF PLATO'S IDEA OF JUSTICE

PLATO'S JUSTICE

- Plato's Theory of justice in Republic.

Plato developed his idea of justice as a response to the political instability and moral decay of Athens. He observed that democracy had failed to produce wise leadership and had instead encouraged corruption and emotional decision-making.

03 Justice As Harmony

For Plato, justice means harmony. It exists when different parts of a system work together in

balance. just as health is harmony in the body, justice is harmony in the soul and the state. Disorder and conflict indicate injustice. Thus, justice is not external enforcement but an internal condition of balance and order.

Justice In Individual

Plato divides the human soul into 03 Parts:

01. Reason (Wisdom)
02. Spirit (Courage & Honor)
03. Appetite (Desires & Passions)

Justice in the individual exists when reason rules, spirit supports reason, and appetite obeys. When each part performs its proper function without excess, the individual becomes just. If desires dominate reason, injustice emerges.

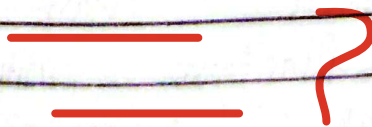

Justice In State

Plato compares the individual with the state. He divides the ideal state into 03 classes:

01. Rulers (Philosophes King)
02. ~~Guardians~~ (Soldiers)
03. Producers (Farmers, Traders, Artisans)

Justice in the state exists when each class performs its assigned duty and does not interfere in the functions of others. Rulers govern wisely, guardians protect courageously, and producers fulfill economic needs.

Principle Of Specialization

According to Plato, justice means "One Man, One Work." Everyone should do the task suited to his nature and ability. When individuals or classes interfere in other's roles, injustice arises. This principle ensures efficiency, stability and social harmony.

Philosopher King & Justice

Plato argues that true justice is

only possible when philosophers rule
philosophers possess knowledge of
the form of the Good, which
enables them to govern justly.
Unlike ordinary rulers, philosophers
are free from greed and personal
interests.

Justice And the Forms

Plato links justice with his
theory of forms. Justice is an
ideal and perfect form that
exists beyond the material world.
Human laws and actions are
just only to the extent that
they reflect this ideal form.
