entire mankind"






These two treaties ensure that mutual co-existence exists in humanity and humans created tolerance to each.

Madina, Holy Prophet^ﷺ bestowed Harzad
All with responsibility to return the
Goods to right-ful owners.

4.2. Right to Life and Prop Liberty

Islam abhors anyone who kills or harms anyone unlawfully. It seeks to create a just, tolerant & society with mutual co-existence. This can be seen in the same of case of "~~Charter of Madinah~~"; where Prophet Muhammad^ﷺ create a constitution, where everyone would get equality. and The Holy Quran says;

4.3. Protection of human dignity

Mutual co-existence is created through protection of human dignity. Individuals in Islamic Society should ensure that they protect each other's dignity, do not falsely blame any one, spread lies or any defamation. This is asserted in Holy Prophet^ﷺ

Quran where Allah said

"Whenever a disobedience person comes to you with information, investigate".

This statement affirms that Authorities should investigate before lying on anything. Islamic Society states that ~~regardless~~ regardless of anything, all individuals are equal in Islamic Society.

4.4. Right to Practice Religion

In Islamic Society, Individuals have to right their own religion.

It is evident in Charter of Madinah, where Holy Prophet ^ﷺ granted ~~every~~ ^{every} individuals to practise their own religion. Islam abhors any forced conversion in Islam as Holy Quran says,

"There shall be no compulsion in religion", - Al-Quran.

This statement affirms that Muslims should not force anyone and learn to live in mutual co-existence.

4.5. Right to Justice

In Islamic Society, Mutual Co-existence can be granted upheld if there is right to justice, fair trial, no biasness. Islam emphasises fair trial, and asserts that in any Islamic Society, Justice should prevail.

This can be seen in the case of where a noble & Jewish woman stole and the people asked Holy Prophet^ﷺ to forgive her, the Prophet^ﷺ responded.

~~"Even if Fatima, daughter of Prophet^ﷺ were to steal, I would cut her hands off"~~

This statement asserts that Islam always upholds Justice.
