Women with greater political rights and participation opportunities help in stabilizing and shaping the societies for the better. A prominent evidence in this case is that of Liberian women who drove their government towards peace talks with the rebels in



Ghana. Their continuous peaceful ~~democracy~~ demonstrations resulted in a promise from the then president of Liberia, Charles Taylor, that he would sit on the negotiating table with the rebels. This incident is a stark example of how women can contribute to social progress and harmony.

Women also play a productive role in administrative spheres. They are more aware of the ground realities and the problems of the women who make up half the population. They are not only capable of making more gender-inclusive policies but also more efficient ones as women tend to showcase transformative leadership style as per World Psychological Survey of Leadership, 2017. Hence, women not only make better policies but also address the issues ignored by men with more intricacy. This results in overall smoother governance and social progress.

One of the most alarming issues in Pakistan is that of population. The population growth is alarming and only projected to worsen. Social safety and rights are also and essential element that escalate the role of women in contributing to the society. Public Sector Development Programs such as Benazir Income Support program have proved that focusing on women development results in the development of their households and ultimately the society. As individuals with lesser opportunities in education and formal sector employment, it is important for government and non-governmental organisations to consider the development of women so that they can in return contribute in the development

Legal safety measures are a pre-requisite of increasing women's confidence in the society and the governmental structure that incentivises them to increase their participation in the public sector and hence social progress. Some of the legal measures that have done so, are reforms in the Husband ordinance in 2006 which criminalized the sexual violence crimes by moving them from religious to legal subjects. Workplace Harassment Act 2016 and Honor killing Act 2016 are other such examples. These legal measures make women feel more safe in the public sphere and their strict adherence must be ensured to increase the participation of women in the progress of society.

The Economist in their documentary "Why Nations that Fail Women Fail?" suggest that discriminatory treatment of women in societies leads to increased fragility and instability.

They establish the fact by analyzing the trends of misogyny in different countries in comparison with their position on the Global Fragile State Index. The countries which have lowest possible misogyny rates such as Sweden are among rich democracies. However, the countries like Pakistan, Sudan, Yemen which have higher levels of misogyny are very fragile. For instance, Pakistan has a misogyny score of 15 and falls 27th on the Fragile State Index. Therefore, it is important to realize that women are a major force in driving social change and achieving social progress and should be given their due rights.
