Constitutionally, the creation of new provinces requires approval by two-thirds of the concerned provincial assembly and both houses of parliament. Securing such consensus is difficult and risk deepening inter-party hostility.

Key Reasons for militancy in KPK

Militancy in Pakistan is directly linked with the militancy in KPK.

1- Political and Governance Issues

In the merged districts, which were previously a part of the Federally Administered Tribal Area, the twin districts of Waziristan, Khyber, Mohmand, Bajaur, Bannu and Lakki Marwat are particularly vulnerable to terrorist attacks. There is an ineffective local governance, outdated legal system (like the old Jirga system) and lack of accountability for elected officials.

Dialogue and Peace Process

While security is essential, Pakistan must scale back military operations in Balochistan against BLA (Baluch Liberation Army) and TTP (Tehreek-e-Taliban Pakistan), but a peaceful approach focused on political solutions and community engagement.

The government should engage with Baluch nationalist groups and insurgent factions in meaningful, unconditional talks and should involve respected neutral mediators to help broker negotiations ensuring all stakeholders have a seat at the table, including political leaders, tribal chiefs, and insurgent groups. Provide pathways for militants to lay down their arms and reintegrate into society through amnesty programs, and rehabilitation.
