II: US Upper House as the Most Powerful House in the World:

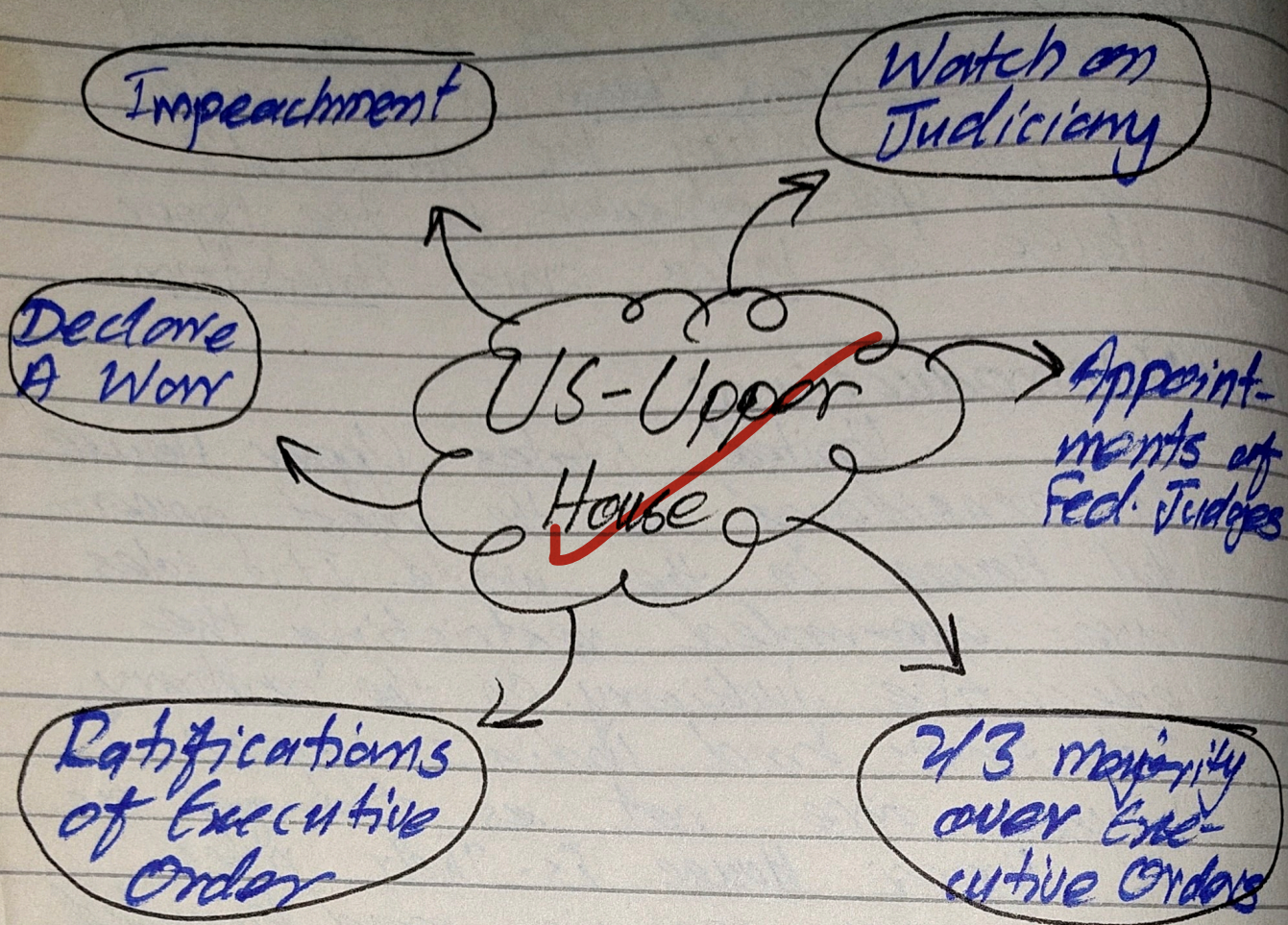
a: Power of Impeachment:

US Upper House has the authority to file impeachment against federal ^{ministers} and president.

c: Ratifications of Executive Orders:

The ~~Upper~~ House of US also ratify the orders of a president by 2/3 majority.

The house additionally ensures the ~~appointment~~ of judges for the country.

e: Two third Majority to Annul Executive Orders:

Moreover, if the house disagree to any orders of executive, can annul that order by $\frac{2}{3}$ majority.

The house can bring amendments if Congress and other houses also pass it by $\frac{2}{3}$ majority.

III: Rajya Sabha and Senate Powers:

a: No Impeachment Powers:

Both Upper Houses of India and Pakistan lack direct impeachment powers; however, can set a judicial committee.

b: Assents Lower House's Bills:

They are supposed to assent the bills of their lower houses. They cannot annul rather than can modifications.

c: Lack of Jurisdiction for Financial Bills:

Upper houses in Indian and Pakistan lack jurisdiction to initiate or dissent finance bills.

d: Declaration of War:

These house can declare a war with $\frac{2}{3}$ majority along with the support of lower houses.

e: Limited Role to Watch-On Judiciary:

tot Rajya sabha & Senate cannot overview or watch-on the judiciary.

f: Lack of Jurisdiction in Initiating the Bills:

These house are not able to initiate any bills. They either modify or assent the bills of lower houses.
