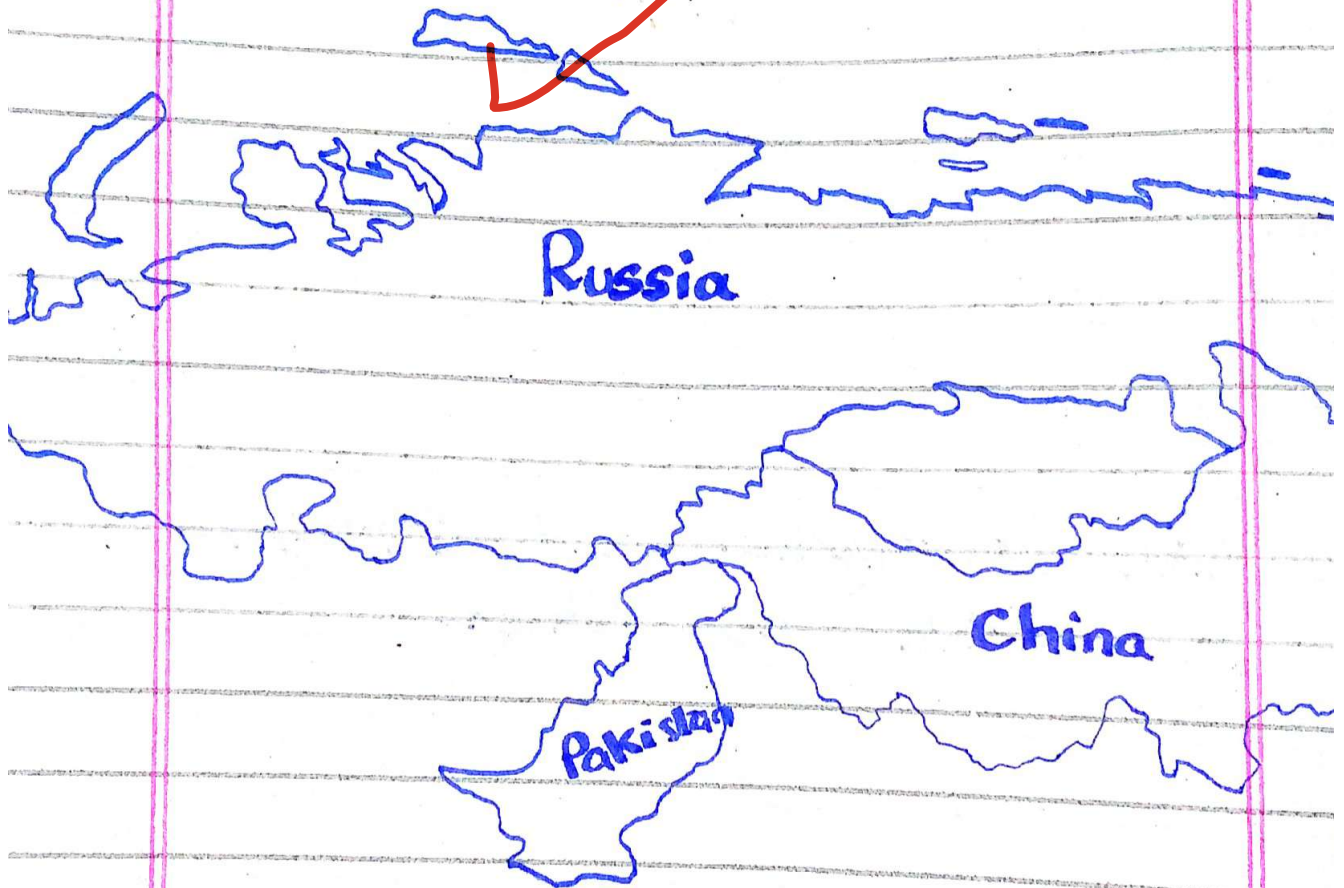
## (18). Convergence and Divergence with EU Policy:-
