young girls, dragging them to eternal physical and mental stress. Women today endure the hardest consequences of climate change because of their exclusivity from climate governance. There are limited females in climate crisis teams which adds to the headache of women. Apart from this, there are climate change takes away the limited employment opportunities from women. This is further aggravated by the patriarchal social norms and the surge in gender based crimes in climate affected frustrated families. Women are also excluded from early warning systems in climate crisis due to their limited access to technology. Other than that, women are ill-trained to adopt to climate change and their limited health care facilities increase women hardships in climate change many folds. manifolds. All these consequences can be reversed by



climate governance inclusive to women,  
training of women to adapt to climate  
change, financial assistance and inclusion  
of women in rescue and rehab teams.

In the era where climate change is at  
its peak, women - as first-hand  
receivers - are subject to the hardest  
consequences of it. Lack of training,  
financial constraints, limited technological access,  
patriarchal social norms and their exclusion  
from climate governance has further increased  
the pressure of climate change on women.

Pakistan is ranked the 1<sup>st</sup> climate  
vulnerable index country in 2025 by  
World Climate Risk index. Whereas it  
is ranked the last - 148<sup>th</sup> - out of  
148 countries in global gender gap  
index 2025. This stark contrast in  
statistics shows how vulnerable and  
affected women are and can be  
from climate related crises.



Women endure the maximum consequences of climate change because of their minimum participation in climate governance. The climate governance which formulates and implements climate policies lack women representation. When women are kept out of policy formulation and implementation, their concerns won't be heard. Men can very little advocate for issues women face due to climate change. According to a report on climate resilience and adaptation by Greenwich Institute on climate crisis only 17% of women makes up the part of climate governance. This indicates the climate exclusive governance of women which adds to grave consequences.

Along with minimum participation, women ratio in climate crises rescue teams is negligible. Negligible rescue



members mean lack of comfortability of women in climate crises. Many women often reject help that is offered by male rescue members posing serious life threatening consequences. According to Economy survey of Pakistan 2025, only 2 percent women form the total in Law Enforcement Agencies in Pakistan, which quite often works as rescue teams. This shows that women participation in rescue teams is negligible in climate change events.

Other than minimum participation in rescue, women also face economic constraints coming from climate crises that takes away employment opportunities.

Many of the rural women participate in agriculture as workforce. When climate crisis is like floods take away the agricultural land, they affect the women most as women are limited



~~just to fields~~. According to Economic Survey of Pakistan 2025, women workforce only makes up 20 percent of the total which is severely affected by climate induced crises. ~~This implies that climate change has posed grave consequences on women by constraining employment opportunities.~~

Besides financial constraint, women are often sidelined in climate change consequences due to patriarchal social norms. ~~In a patriarchal society, women's safety is risked at the hands of family norms and cultural subjugation. Women are supposed to cover up in rural areas in scorching heat to maintain their family conditions.~~ woman

Besides patriarchal social norms,  
there is a surge in climate frustrated  
families being involved in gender based  
crimes. Climate change has hit economic  
wealth of families badly. They feel  
frustrated and burdened which leads  
to gender based crimes like early  
childhood marriage of girls. This ease  
of the burden of climate affected families.  
For example the rising concept of  
"climate brides" in parts of South Asia  
shows that climate affected families wed  
off minor girls to reduce their burden.

Along with surging climate induced gender based crimes, limited access to technology deprives women of climate warnings. Governments usually issue warnings on mobile phones and televisions.

women who do not have access to technology are often left out to receive warnings and act upon

it. They often miss out the earliest yet the most important step in climate crisis prevention. According to Mobile Gender Gap Index 2025, 53 percent of women have access to mobile phones compared to 86 percent men. This statistic is enough to highlight how many women are excluded from climate warnings due to their deprivation from technology.

Other than technological deprivation, women are ill-trained to adapt to climate change consequences. They are



often aware of the consequences only once they are uncontrollable. This ill ~~pretraining~~ to deal has increased the consequences many ~~for~~ manifolds. Rainfalls, floods, ~~heatwaves~~, ~~wildfires~~ and many other climate change scenarios require ~~to~~ people to act promptly to ~~save~~ prevent maximum destruction. ~~Whereas~~ women are often kept away from this ~~pretraining~~ which poses grave consequences. During the flash flood in Texas 2025, 27 girls died in the camp because of lack of ~~training~~ to deal with climate situations. This ~~creates~~ room for the argument that climate ~~change have grave consequences on~~ women due to their lack of training.

One of the most serious issue is the ~~minimum~~ health care facilities for women that poses greater health risks. Women ~~are~~ made in the way that

they are affected greatly even in minor climate change scenarios. They are subject to monthly menstruation and they also experience pregnancy. This further adds delicacy to women's health. When women are exposed to climate crisis their mental and physical health are affected the most. Meagre facilities for physical health care and neglected mental health care leaves women to be exploited the most by consequences of climate change. In the August - September 2025 floods, 59 camps were set to provide relief to people across Punjab with none separate for females (PDMA Punjab). This shows that negligible health care facilities have lead to harshest consequences on women in climate crises.

Non governmental organization, governmental organization and public private partnerships should provide women the necessary assistance for self sustainability.

Only through financial assistance can women be empowered to fight the harshest consequences of climate change.

Last but not the least, women should be included in rescue and rehabilitation teams during climate
