This statement reflects the deep connection of peace and justice. Peace in traditional context is the silent guns, no wars and no any kind of uprising or conflicts. But in contemporary context, it is all about regional or local stability in terms of prosperity, economic equality and non-discriminatory environment. Without these factors society would only have short-term calmness and peace, not effective long-term peace. Where there is justice there is healthy environment. Justice is a very interdisciplinary term, it denotes ensuring equality in society and economic context, treating marginalized fairly, prevailing an environment of accountability and rule of law, ensuring protection of freedom, rights and liberty related to people etc.

These factors ultimately lead to a calmness, cohesion, equalitarian cohesiveness in a society. A perfect just and equality-based society can be achieved by introducing reforms and policies for legal institutions, regulation economy equally and ensuring rule of laws and accountability. Thus, it can be remarked that Peace is not the only requirement of the prosper state but justice should be attained in order to built a prosperous nation. Now, there is a justified
reasons which highlight that

This can also be refuted by the fact that without justice i.e. equal division of wealth, economic means would only be a fate of elite ones. ~~This would create further chaos.~~ Therefore, justice is a fundamental requirement of peaceful society. For instance, China being a developed and prosperous country, still there is a protest by labourers - who demands their fair wages and economic equality.

After realizing that fact that justice is an essential and inavoidable element of any peaceful society. There should be a focus on how to achieve a just society. First, government should introduce reforms and policies which obliged the legal institutions to be just and fair towards people. ~~Courts should be independant of political factors,~~
