It can be illustrated by an recent example that is evident from Al-Jazeera report that many parents were reluctant to inculcate HPV vaccine to their daughter claiming it a forcing propaganda to induced country's population. Some is the situation that Pakistan is facing in Polio virus vaccine due to ignorance and lack of knowledge. By educating a woman is not merely enlightening an individual but results in welfare of whole generation. its personality. For instance, a knowledgeable mother will not prefer grades and positions but promotes its healthy participation and hardwork. Similarly, is the case with cousin marriages, which leads to many medical complications like thalassemia, disability etc and early marriage not only affects physically but also mental distortion. This could only be eradicated by the consciousness of the subjects of the country.

Woman universities or institutes are significant to motivate the females of tribal and feudal families to get education. A single educated woman will stand firm for the rights of her community. For instance, this will allow a woman to challenge those traditional norms of their community which is significant in my feudal home by Tehmina Durrani. She discloses many oppressions of a woman living within that community.

But the situation is even more grave by illustrating Kano-Kani incident in Balochistan shows that still a woman is being exploited by such non-state actors. Thus, this should be eradicated by the authorities concern to protect them from such subjugation.

But all these outcomes will only be possible by initiating comprehensive policy implementation that would ensure the women participation.

The Federal and Provincial government should provide flexible schedules for women. For instance, a women should be given an opportunity to get education through online classes and if not then her accommodation by the institutes should be safe and clean that would be satisfied by her guardians as well. Also, scholarship and safe transportation should also be insured for their convenience and ease. These steps will surely increase women's contribution in country's progress.

Also the rural and tribal areas are more vulnerable to government policies to educate them the significance of education, religious scholars can play their role. They can convince the people of that particular area by referencing from Quran and Sunnah.
