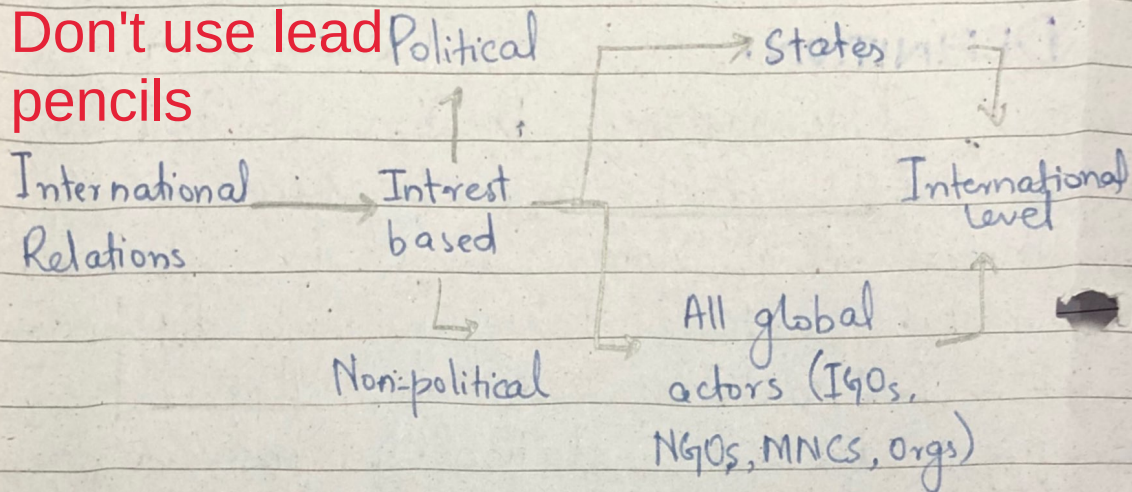
INTRODUCTION:

This treaty established key principles for the secular and independent government in Europe. This theory is also known as "Nation-State System".

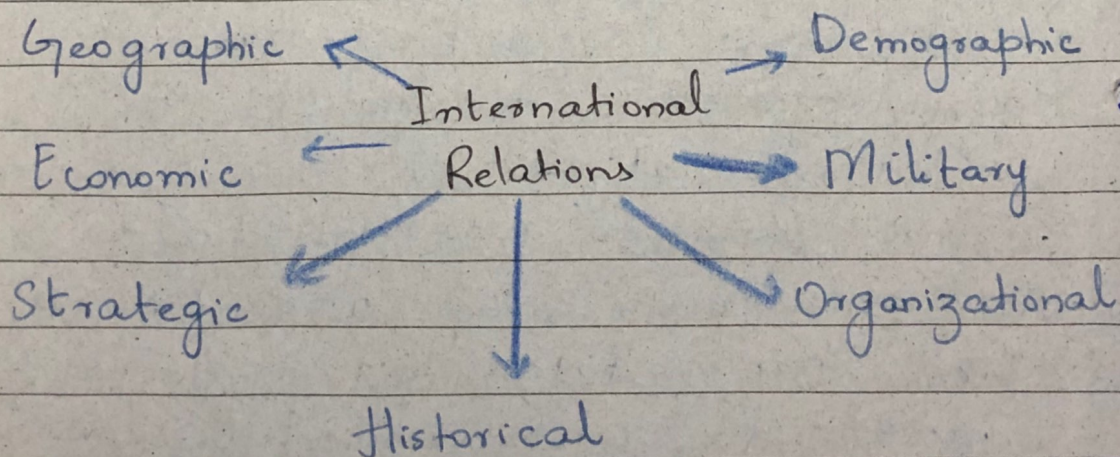
MULTILATERALISM:
