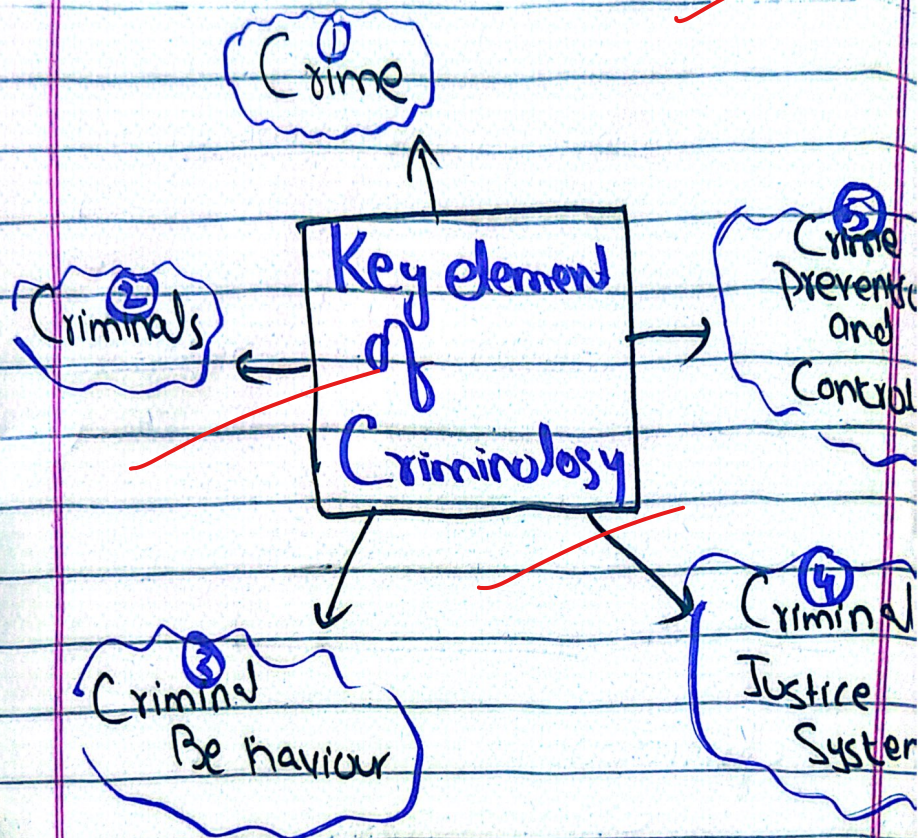

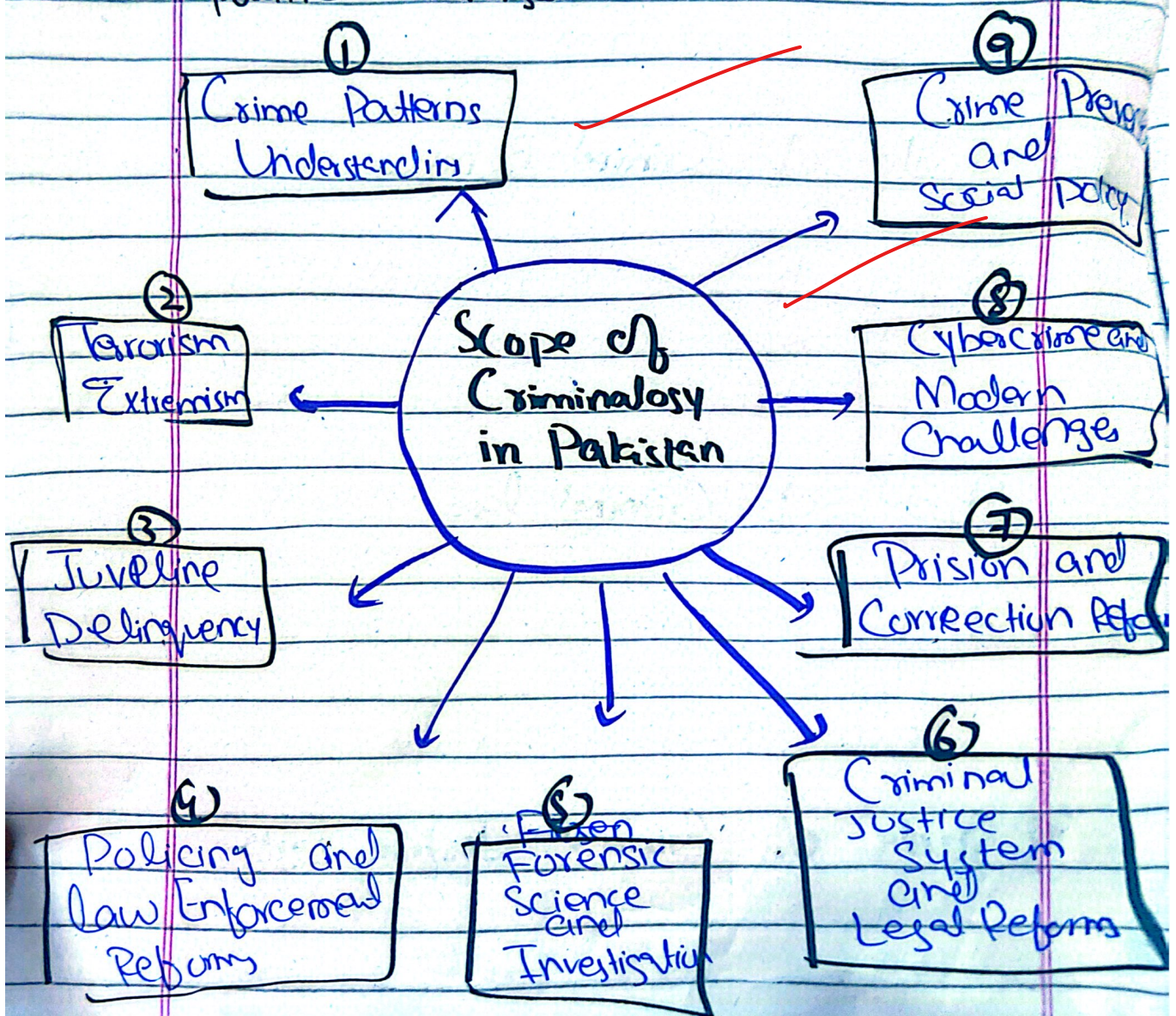

Understanding Crime Patterns in Pakistan

Criminology help in analyzing crime trends in Pakistan such as street crime, terrorism, Cybercrime and organized crime. Through statistical analysis and research it identifies patterns related to time, place and offenders. This understanding assists policymakers and law enforcement agencies in designing targeted crime control strategies.

Terrorism and Extremism.

Criminology plays an important role in studying terrorism and extremism by examining causes like radicalization, social exclusion and ideological indoctrination. It helps in understanding recruitment patterns and motivation of militants. This knowledge supports counter-terrorism policies and deradicalization programs in Pakistan.

Juvenile Delinquency.

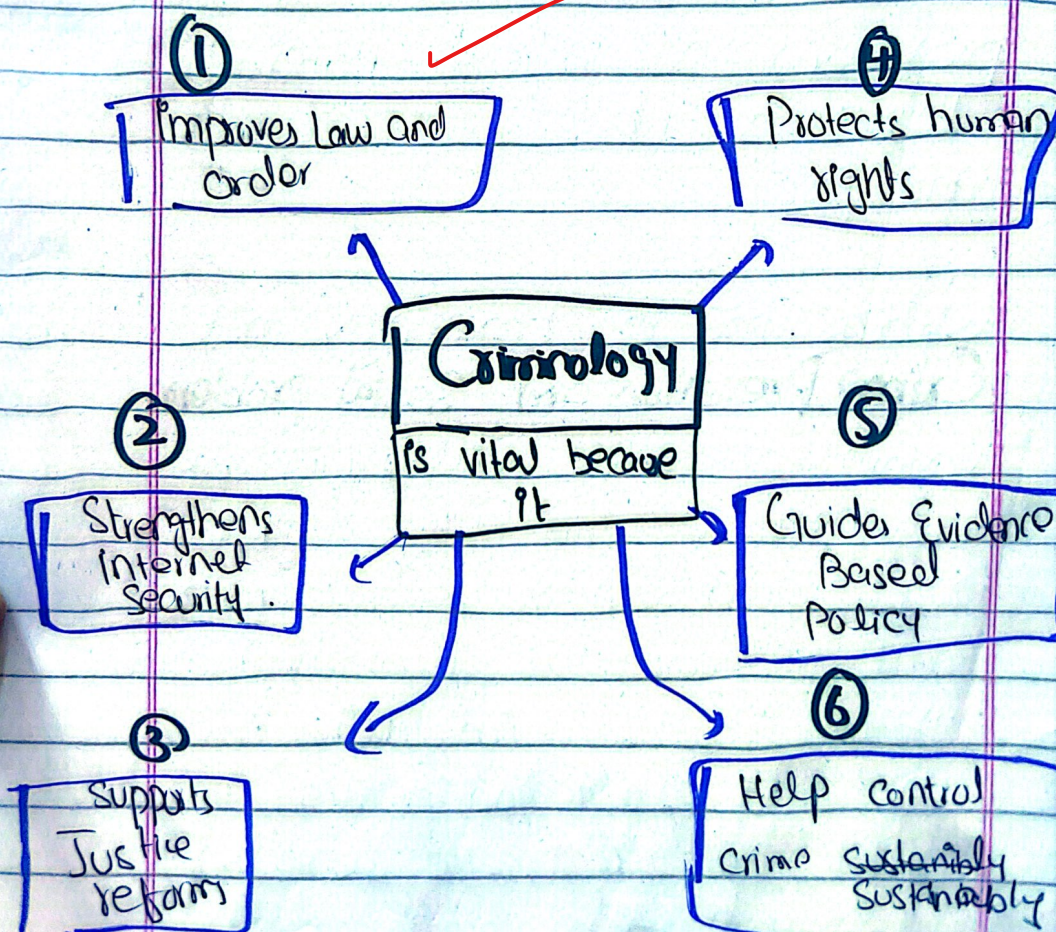
Cybercrime and Emerging Crimes Crime Prevention and Social Problem.
