INTRODUCTION:

On January, 2024, Iran struck in Pakistan claiming to target terrorist camp. Iran claimed that these ~~attack~~ terrorist groups were carrying out terrorist attacks on Iran. Therefore to protect its own national interest, the attacks were carried out without taking Pakistan's authority into confidence. This violated the sovereignty of Pakistan, thus, in response to it, Pakistan ~~also~~ attacked terrorist camps in Iran which were operating cross-border terrorism in Pakistan. This event violated both country's sovereign principle and territorial integrity ~~without~~. However, the terrorist issue could be resolved bilaterally.

REALIST SCHOOL OF THOUGHT:

The ~~realist~~ theory Neo-Realist theory of International Relations has

its root in the 3rd Great Debate of IR. (1960s - 1970s). This theory emphasizes on the state-level analysis. Generally, realism theory states that, the world's system is based on anarchy (absence of International authority), therefore, every interest state secure its national interest by maximizing its power.

Similarly, there are two forms of realism: Offensive realism (power control for hegemony) and defensive realism (power control for self-preservation).

Co-RELATION OF REALISM AND PAKISTAN - IRAN INCIDENT 2024:

NATIONAL INTERESTS:


Both countries immediately secured their national interests and also their sovereignty. The violation of principle of non-intervention, lead to strengthening national security.
