Great nations do not fall because of external invasions - they fall when their own foundations weaken. The Soviet Union, once a superpower rivaling the west, did not collapse under the weight of American missiles or NATO forces but due to political corruption, economic crisis and loss of public trust. It crumbled from inside before the world even saw it fall. Undoubtedly, nations die from internal rottenness rather than external invasion. A nation dies from corruption, national disintegration and political instability. Moreover, ineffective governance, injustice, economic instability, civil war and gender inequality also contribute to the downfall of a nation. Contrarily, some people claim that external invasions vanish the foundation of nations, spoil the economy and create civil war. The reality is entirely different from the critics stance. Nations with strong internal system always defend their countries. Economic instability and civil war are directly associated with the internal rottenness of a country. Therefore, nations die from internal rottenness rather than invasions.

Corruption is the destruction of a nation. Nations have fallen in the history of the world due to corruption. Afghanistan's democratic government is one of the ideals for the world. According to Reuters report

named "The Fall of Kabul" clearly exposed the Afghan National Army's involvement in corruption. Consequently, corruption vanished, the morale of troops and Taliban took over the Kabul. Therefore, corruption is one of internal issues which destroys the nation.

Similarly, national disintegration contributes to the downfall of nations. Countries fall due to national disintegration. Disintegration among masses on the basis of religion, ethnicity and economy push nations into downfall. According to Anatol Lieven's book "Pakistan: A Hard Country" the fall of East Pakistan was the result of national disintegration.

A national disintegration in any country pushes the collapse of nation. In short, national integration is responsible for the destruction of nations.

Additionally, political instability contributes to the breakdown of a nation. Political instability not only brings chaos but also spoils the existence of a nation. The recent case study of International Crisis Group (ICG) named "Sudan's Political Crisis" clearly projected the crisis of Sudan to be the provision of political instability. Truly, the former U.S President said in 2016 before the U.S Congress "We must put an end to political instability of our allies; if we fail to end, they will become our enemies." Political

instability is the only factor of destruction of nations. In nutshell, political instability boosts the destruction of countries around the world.

Furthermore, ineffective governance results in the downfall of a country. Good governance is a basic stone of foundation of nations. Countries with ineffective governance always collapse. For example, ineffective governance gives gap to criminals, terrorists and enemies of the state to harm the people.

Afghanistan's **Noristan Province** is one of the best examples of ineffective governance. According to **Reuters** the ineffective governance of **Talibans** gave gap to **ISK** to over the province. Therefore, nations die from ineffective governance.

Besides, injustice contributes to vanish the nations. Injustice is one of aspects of internal rottenness. It terrorizes the masses against own nation. **The Fall of Al-Asad Regime 2024** was one of the consequences of injustice. The injustice of **Al-Asad Regime** on the basis of sect, ethnicity and status terrorized the masses. Thus, injustice is one of the factors behind the downfall of a nation.

Economic instability creates the vacuum of chaos. Economic stability plays one of the fundamental roles for nations existence. Economic crisis often causes brain drain, inflation, intervention of world organization such as **IMF**. Consequently, rottenness in economic crisis makes vulnerable to downfall. The economic vulnerability

pushes nations to downfall. Therefore, economic instability vanishes the existence of a nation.

Moreover, civil war which is one of the provisions of internal rottenness spoils nations. Civil wars have vanished the existence of nations in human history. Afghan Civil war in 1991-1993 resulted in horrible consequences. Similarly, Syrian Civil war also resulted in political, spiritual and moral fall of Syria. Civil war pushes the nations to breakdown. Therefore, civil war boosts the downfall of a nation.

Furthermore, gender inequality vanishes the progress of a country. Gender equality plays one of the key roles in the prosperity of a country. Nations with gender based violence such as sexual violence, economic violence and physical violence soon meet its downfall. Truly, F. Kennedy said "when women are free from violence, families are stronger, communities are safer and economies thrive." Gender equality assists every nation to achieve its progress. Similarly, gender inequality pushes a country towards downfall. Thus, gender inequality pushes a nation to be broken down.

Contrarily, the opponents say that external invasions foundation of nations. Invasions not only destroy the foundation of a nation but also causes massive casualties.

According to the critics that Gaza's Crisis 2023-25 is one of the examples of invasions. The invasion on Gaza resulted in 48000 deaths, vanished infrastructure such as hospitals, schools, homes and mosques. Invasions bring deaths to nations. Thus, nations die from invasions.

Similarly, foreign invasions spoil the economies of a nation. External invasions always impact the economies. Israel's raids on Jabaliya, Khan Youns, Rafah and Hourin resulted in the destruction of agriculture based economy of Gazans. Invasions entirely spoil the economic activities of natives. Consequently, food shortages erupt, inflation hiles and starvation becomes a cause of death for a nation. Thus, nations' deaths are associated with foreign invasions on economies.

Civil war which causes profound casualties is the provision of foreign interventions. Giant powers such as Russia, China, EU, India and the U.S.A. intervene in the internal issues of other nations for national interests. Consequently, the scenarios of civil war takes place. The involvement of the giant powers fuel the flame of civil war rather than internal causes responsible for the war. Therefore, civil wars which bring deaths to nations is the result of foreign involvement.

Realistically, the opponents claim lacks reality, internally strong nations defeat their

countries through numerous ways. Nations with enormous military, economy, political stability and national integration defend their countries from foreign invasions.

For example, Israel's strikes 2024 on Iran resulted in quick retaliation from Iran. Having tremendous internal power makes the protected. Thus, internally strong nations can easily defend their nations.

Similarly, internal factors are responsible for the destruction of economy rather than foreign invasions. The critics' stance is illogical, economic instability is entirely associated with political instability, trade deficit, water crisis, energy crisis rather than foreign invasions. Economic crisis has no interconnection with the invasions. Israel that has been fighting on numerous fronts such as Yemen, Lebanon, West Bank, Syria, Iran, Gaza and Iraq although the economy of Israel is existing. Thus, economy has no relations with invasions.

Besides, civil war is the result of internal rottenness. The opponents' stance has no reality, civil war is the result of internal rottenness such as national disintegration, political instability and economic instability. Whenever, a country lacks political unity, public trust and national integration, the gap place to foreigners to intervene. There is no reality in the claim of critics that foreign nations involve directly in the

internal issues of other nations. Thus, civil war is the result of internal rottenness rather than invasions.
