## The barbarity of Ethnic Cleansing

Around forty-five thousand palestinian lost their lives, approximately have been internally displaced and one million sought repugee in Egypt. The ongoing genocide in Gaza is a night marre to all. Ieveraging Israeli government to make - Great Israel. The death toll and displacement count in Gaza is a vivid explanation to what ethnic cleansing means. Israel aims to evadicate all palestinians to establish zionist dominancy in Israeli occupied Palestianian land. It has devastating impacts to global peace and prosperity. Ethnic cleansing is one of the most cruel attempts by dominanting and

powerful group to suppress or undermine the weak. Is it even the justified act of weak. Is it even the justified act of dominanting? Does ethnic cleansing has clear ends of sufremacy for powerful ethnic classes? The aftermaths of ethnic ethnic classes? The aftermaths of ethnic ethnic cleansing are confined to particular territory or it has global outbreak?. Therefore, it is justified to claim that ethnic cleansing is one of the most barbarious act, cleansing is one of the most barbarious act, because it undermines basic human rights, because it undermines basic human rights, aggravates psychological distress, enforces mass acre and large scale displacement, and exacerbates social tension.

Before delving into the excelating cruelties of ethnic cleaning, it is pertinent to understand what ethnic cleans in grows. In simple words, it is systematic removal or percecution of particular ethnic group, often through violence, and forced displacement. It alms to completely disregard diversity of ethnic classes in a particular region. According to social construction of identity theory, social groups are divided on the basis of language, norms, values, and tradition which

differentiate them from other social group. Thereby, inculcating a sense of " Us Vs Them" which justifies discriminatory actions against target group, resulting in large-scale ethnic cleaming. Proponent of opponent schools of thought believe that ethnic oleansing is not a barbarious act, but need of a nation. They argue that ethnic cleaning is a prerequisite. to attain sovereignty of any nation. It focuses on dominancy of dominanting group by ethnically eliminating minor. ethnic groups for Instance, the ongoing genouse in Gaza is predominantly backed by notion PM Benjamin Netangahu by making. Great Israel. Zionist dominanting group alms to continue war until last palestinian breaths. mough endless fires of ballistic missiles by Israel on Gaza has increased the fatalities toll to forty-five thousand and millions have been internally and externally displaced. Israel government claims to attain national sovereignty of Jews through ethinic cleaming. Moreover, critics believe that heterogeneous ethnic groups in any nation.

paves ways for social unrest which underming social progress of anny fration. Chinese government continually uses from hands to undermine ethnic group of uyghur muslims.

Thereby, restricting the uyghuris to practice their traditions which would harm social progress of China. Furthermore, the protests led by uyghuri muslims in china have posit threat to chinate global Standing by providing political vaccum to the united states to misure ethnic groups against Chinese global dominancy. Hence, ethnic cleansing is justified to restrict social tension, thereby facilitating social progress.

Hence, ethnic cleansing cruelly deprives people to pratice their basic fundamental rights. Additionally , the practice of ethnic Cleansing and continual suppression faced by minority ethnic axoups result in aggrawated Psychological distrem. According to American Psychology Association report , 2023, the Suppressed ethnic amoups have severe traces depression, hopelessness, and Learned helplessness. The Peristent subjugation and violent diminish their hope for relieve from acts endless sufferings inflicted upon them because. of their ethnic label. Theroby, they start to adopt the struction with severe psychological. travina. World Health Organization Claims that ethnic cleaning is a crime to humanity as it targets Physical and mental wellbeing of any

It deprives ethnic groups to have access to humanitarian agristance to satury basic. necessities of life. For Instance, Gaza Siege filk to be the best example. Israel and Us led humanitarian aid assistance organizations have deprived Gaza residents to have basic survival essentials with concession with Israel. As Per UNDP report, 2024, twenty-fire thousand palesthrians lost life due to no medical assistance and malnutrition. Thus , it is evident that ethnic cleaning restricts ay meany of survival even the reachability. to humanitarion assistance.

Ethnic cleanising marks the contral concept to massacre and large-scale displacement of discriminatory ethnic orroups. After the fall of kabul in 2021, Tallbam government has force fully removed around 1.6 million refugees

Afghan refugee cross border with an alm to expansion of Afghanistan western border towards Pakistam. The refugees have different ethnic beliefs with respect to Taliban government. Moreovers the Robingya muslims in myammar for forcefully displaced to seek refugee in Bangladesh. According to . UNHER, one million Rohingyan muslims flee to seek refugee in Borngladesh, making the world largest Camp. Therefore , the massive displacement of ethnic groups make ethnic deasing a barbaric act. urreover rethnic clearing escalates extremism and fundamentalism. The socialty constructed norms waives and identities widens the ethnic gap between groups. The leading ethnic groups mains to practice dominancy without temperance to any violation of ethnic Standards. Hindutva, extremist Hindu group in India , suppresses an ethnic groups which socially set Hindu traditions, Hindutia, devlate remove and inflict violent acts you aining to muslim of India to live and practice their. religion in India. The mustime are forced but of their properties and not regarecognized as.

extremist ideologies to prevail and reduces extremist ideologies to prevail and reduces temperance and moderation, thereby practicing fundamentalism.

Furthermore, the menace of ethnic cleansing extends over restriction of autonomy and self-determination. It tends to maintain supremary of dominariting ethnic group. For Instance, revoking of article 370, 35-A on 5th August , 2019, by BJP part of Pin Narenda modi of India, is a clear indication of restricting autonomous existence of kashmiki people and erad eliminating their right to self-determination. Through revoking of articles pm modi aumed to suppress ethnics of kashmini and fully recognizing It under Indian government. Moreover, entruced disappearance of Balochi nations is also a ... relevant example to restriction of self-determination through ethnic claiming. The non-state actors orge to eradicate Baloch dominamy in Balochistom Province of Pakistan by forceful. disappearance of Baloch youths consequentlys ethnic cleansing results in consmount autonomy. and self-determination.

Ethnic Cleansing alms to monginalize minorities within international system of states. The minorities are prosecuted through MoTence to undermine their existence in a particular nation. In particular, Newson Mendela highlighted the ethnic and racial discriminations; faced by Blacks of south America. The urge of ethnic deprivation by whites of America undermined Blacks in ay domlars of life - They were often labeled as: classless or statelex groups in America. Moreover, Blacks were considered dirty and criminals whom have caused social oprising in America. The marginalization faced by Blacks were called through Blacks live Matter movement which gain world-wide recognization. Hence, the fifty years of Blacks was based on ideology of ethnic cleaming which aimed to marginalize the minorities. Additionally, ethnic cleansing prenomenon exacerbates social onrest and tension . It distrubs the social pabric of society; thereby enhancing projudice and hatred. For instance, Hazara community in Balochistan often faces violence based on ethnic division.

The Hazara community is excluded from main ethnic groups in Balochistan strey are repeatly attacked through coerdre means which have lastly impacts on Balochistom. The attack on university bus having twenty Hazara girls In Quetta is one of the example of theter ethnic cleansing inflicted upon Hazarra commonity in Balochistan . Similarly, the sectanian rift aided by ethnic discrimination unprecedently targets different religious sects. Altacks in Kurram district in Khyber Pakhtinkhiva, Pakhtam salm to cleanse shia groups from KP which also comes under umbrella of ethnic cleaming. Thereby causing social tension and orrest. Moveover, the practice of ethnic cleansing has spill over affects on other regions, thereby undermining geo-politics. For example, Gaza conflict has completely disturbed social, Political and economic wellbeing of middle-East , resultantly distribing geo-politics. It has engulf Iran, lebanon, syrja and Iraq in war against Israel and Jaca. Similarly, Robingy a crisis has devastating Impacts over social fabric of Bangladesh

Indian region. The spills over of ethnic cleanising aggrawates ethnic discrimination. in different areas of world which completely distrubs Peace and prospectly. Therefore, it ethnic cleaning is one of the most barrbanious act practice by dominating ethnic ordups. The brutalities engaged with ethnic cleaning need vigent solutions to minimize its barbariou nature on larger scales: Collective initiatives are ineed to swengthen international jurisdiction and polluling committee. The International solution to ethnic cleansing restricts the practice and change arrbritarry against inflicting groups. In relating to this o, Interpol and ICJ should be strengthen to have their own coercive means to Charge and ponish groups which intern practice ethnic dearnsing. Marcover, ICJ should strictly adhere to international laws which determine humanitarian protection rights during peace and war. Moreover, There should be reforms to International Institutions to have equal respresentation of each party to voice out their sufferings

caused by discriminations among ethnic groups. Reforms should be proceed processed in the United Nations Security council. The in the United Nations Security council. The power of veto should be undermine or the permanent members should be extended by addition of GIV counties. This would reduce down the misuse of Veto power against against against of on in ole cision proposal. Therefore a reforms are needed in International institutions to voice down out the isofferings of subjugated ethnic groups.

Additionally, to undermine the menace of ethnic cleanising states should empower non-governmental organizations which would objectify to facilitate minorities and suppressed ethnic groups. For instance, Minority Rights

Group (MRG), works under the united kingdom, holds the rights of ethnic, religious, and avoid this expression please linguistic groups by increasing their opportunities and representation in economy and Politics.

Moreover, the goals of UNITRE should be allamed through proper supervision of conditions of ethnic groups and consuming their basic

fundamental rights.	
To sum up , the barbarious nature
