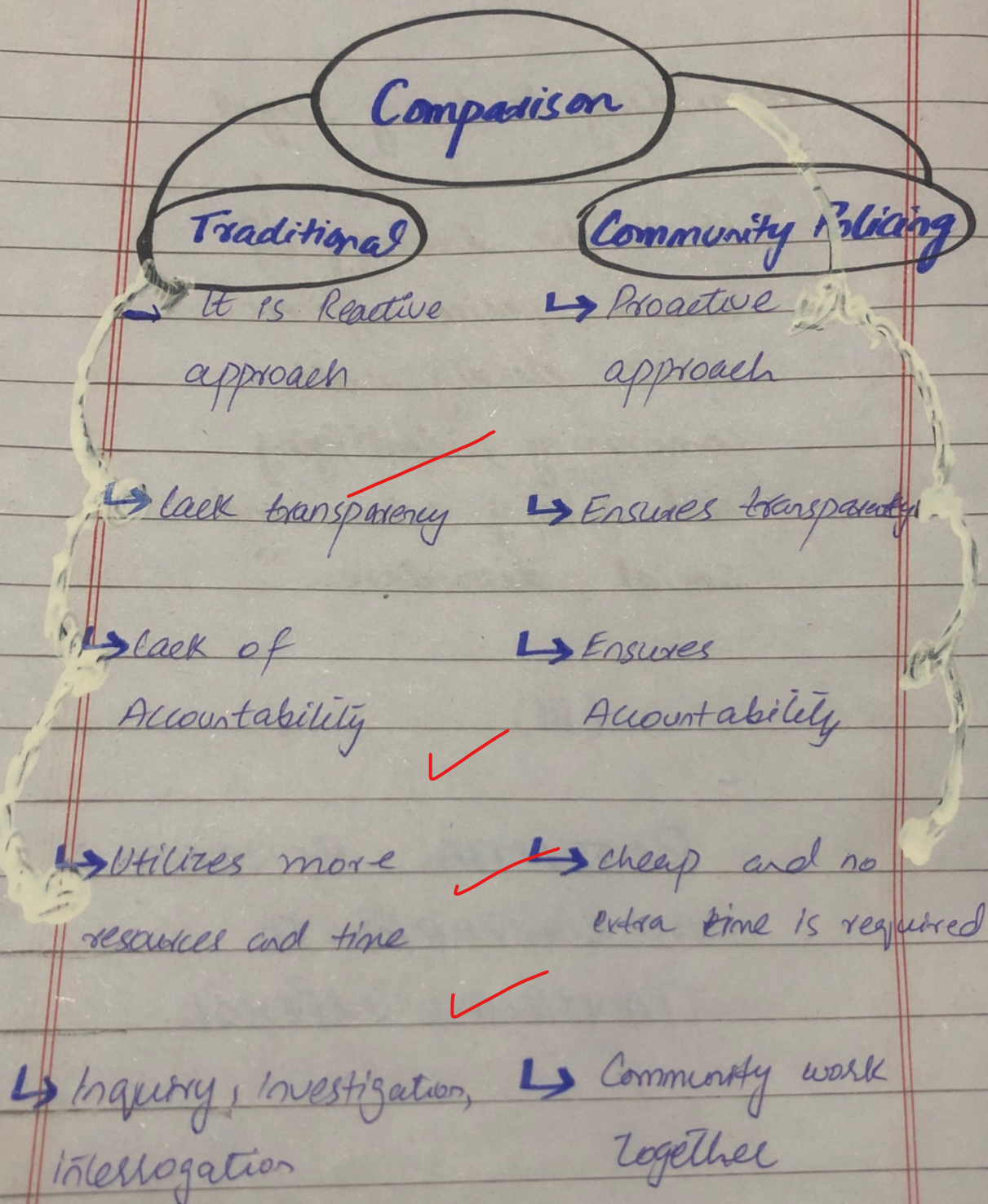

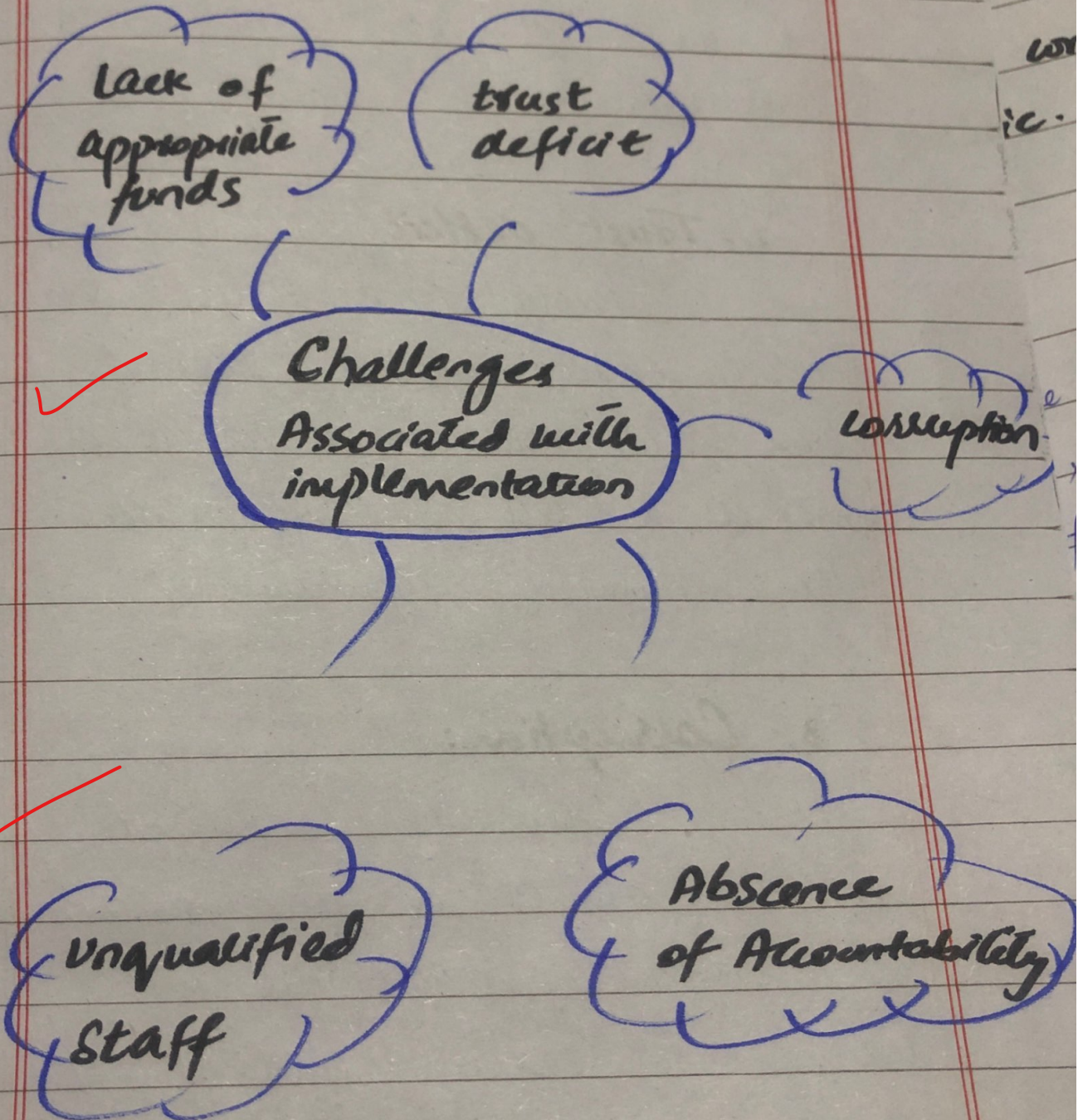
✓ The Women desk is also made for facilitating women.

CHALLENGES ASSOCIATED WITH IMPLEMENTATION

✓ Being an developing country, having political and economical

crises, Pakistan faced number of challenges while implementing this strategy.



1. Lack of appropriate budgeting:

✓ Police department of Pakistan receives very less percentage in the budget. Police officers receive less salaries and no incentives.

2. Trust deficit

✓ Public lacks trust in police. Police officers do not treat the public in a righteous manner. So lack of trust hinders the community cooperation.

3. Corruption:

✓ Due to lack of resources, absence of accountability and transparency, corruption is leading in police department of Pakistan. So if such strategy is proposed, officers keep their personal

Interest above.

4- Inadequate Education:

Lack of educated police officer is one of the major hurdle in implementation of such new strategy. They continue to follow the rule of thumb, instead of understanding the situation.

5- Absence of Accountability:

There is no proper check and balance on police officers.

with public. So such treatment

fosters hatred, feeling of mistrust towards police authority.
