Therefore, a force-based approach, rather than eradicating terrorism, often entrenches the conflict and prolongs the suffering of innocent civilians. For instance, in the context of Hamas-Israel conflict, the repeated military actions have led to significant civilian casualties in Gaza. Hence, military force may provide temporary relief, it does not address the root cause of terrorism.
