Introduction:

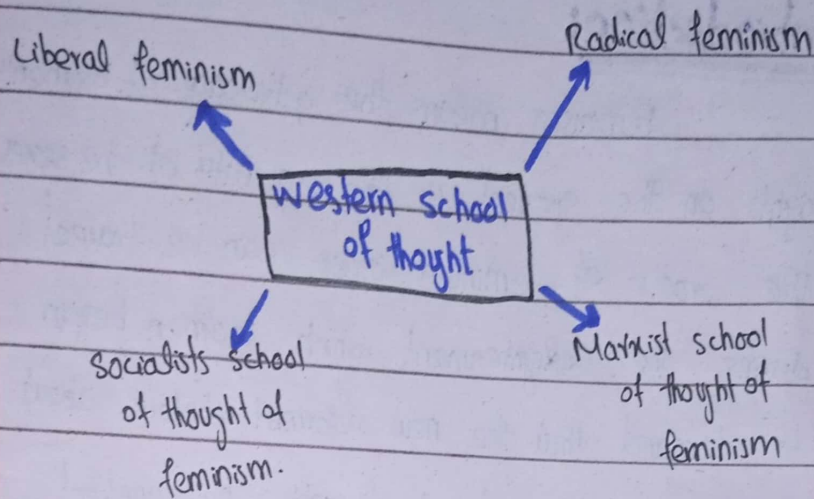
Feminism means the advocacy of women's rights on the ground of the equality of the sexes. The roots of feminism voices can be traced during the Enlightenment which women began to demand that the new reformist rhetoric about liberty, equality and natural rights be applied to both sexes. In 1792 Mary Wollstonecraft had published "A vindication of the rights of women" in the seminal English language feminist work published in English. Sojourner Truth famous "Ain't I a woman" speech was delivered in 1851.

Western School of thought about feminism



Two main school of thought of feminism are discussed below:

Liberal Feminism

Historical background:

Liberal feminism conceives of freedom as personal autonomy living a life of one's own choosing and political autonomy being co-author of the conditions under which one lives. According to Rosemarie Tong, Liberal Feminism began in 18th and 19th centuries and has continued through to the present day. Its long history is a testament to how

Definition:

The main focus of liberal feminism is on gender inequality. This group of feminists observes that men and women are not treated equally, and that the inequality that exists between them is neither biological nor of personality difference but is rather socially organized.

Strands of Liberal Feminism

Individualism:

The core of liberal feminism is liberalism which in turn is based on idea of individualism. Individualism further believes that only those human beings fall in this category that has reason and is rational. They believed both men and women possess reason and rationality.

Discrimination:

As both men and women possess 'reason' and 'rationality' so there should be no discrimination on the base of sex.

Egalitarian and reformist in Nature:

or institutions, rather endeavors to refer them through women favored laws. It is the same reason liberal feminists are called reformists.

Public- Private Divide:

central to this ^{Perspective} is that division of labour which divide production in terms of ^{both} gender as private and public merely serves as domination over women.

Liberal feminism changed this perception and demand that government should participate in the private sphere to safeguard the lives of women.

Goals and issues:

The goal of liberal feminism is to create a "just and compassionate society in which equality and freedom flourishes." only in such a society can women and men thrive equally. Liberal feminism's primary goal is the gender equality in the public sphere equal access to education, equal pay, ending job segregation, better working conditions won primarily through legal changes.

Radical Feminism

Historical background: Radical schools of thought arose during the second wave of feminism in the 1960s.

The radical feminism argue that subordination, exploitation and oppression experienced by women throughout human history is sustained largely through the institution of family where patriarchal ideology is maintained through the process of socialisation. For the radical feminists, therefore, patriarchy is identified as the most significant structure of social domination and oppression of women.

Definition:

Radical feminists see society and its institutions as patriarchal - most of which are dominated and ruled by men. Men are the ruling class and women are the subject class.

- ✓ Legalization of abortion and reproductive rights
- ✓ Overcoming belief that men are superior to women.

Criticisms:

- ✓ During early years, the radical feminists were criticized for emphasizing sex based discrimination at the expense of race and class based discrimination.
- ✓ Radical feminism was criticized because it tended to be white and middle-class.
- ✓ Ignores the progress that women have made in many areas e.g. work, controlling fertility, divorce.
- ✓ Too unrealistic due to heterosexual attraction separatism is unlikely.
