To maintain reliability of investigation the depostment should made investigator independent.



i) Propessionalism of innestigator: Investigator should be adhere to high level of éthical standards, maintain compidentiality and respect legal and procedural requirements. During investigation, investigator must follow brocedure which includes, interviewing the obtender, collection of evidence, checking background of offender and remain focus on relevent fails. in) Officer should be compélent: Investigator must posses the necessary skills, knowledge and training to handle complex cases. Investigator should be well aware regarding legal aspects and posses technical skills to gåther and analyze evidence.
