# Economic inequality is the worst form of social injustice

In 1996, a strong revolutionary movement erupted in the Republic of Congo, demanding equal economic opportunities. The revolutionary movement was led by an individual named Nelson Mandela, who was the first individual to raise voice against economic injustice in Congo. Mandela demanded the basic societal and economic rights for those living in devastating conditions in the rural areas of Republic of Congo. The harsh reaction of the government of Congo could not stop its citizens from demanding their rights,

hence, the movement forced the government to fall on its knees. Laws for equal distribution of economic resources were enacted, and people started receiving multiple social and economic resources. The equal division of resources lead to prosperity and sharp incline in the realm of development of the state. It illustrates that economic inequality deprives the people from their basic needs and rights. Unequal economic opportunities force the people of any country in the world to adopt illegal ways to fulfil their basic requirements. At this point, one must think, is it the economic inequality, that is causing unrest in the world? Will economic equality cur the prevailing societal issues? Indeed, Economic equality plays a significant role to help people find their ways to diminish their problems in one way or the

other. The fact cannot be denied that economic inequality is the worst form of social injustice leading to devastating effects, such as minimum education opportunities, high poverty rate in the society, rise in terrorism, and suppression of women.

Economic equality plays a key role to bring social justice and curb all the prevailing challenges of a society. The prime reason of social unrest is the lack of economic opportunities. It can be further cleared by the excerpt from the Ola Joseph's opus, The prevailing issues of the society, states, "People of any civilisation, living in any society of the world have certain needs, which can only be fulfilled through certain laws and the prime one is economic prosperity." Economic inequality deprives people of getting basic education and health facilities,

curb their sources of legal income. It further deteriorates the infrastructure and legal income means of poor societies, forcing people to adopt illegal ways to generate income. Hence, economic inequality is the prime reason, and worst form of social injustice.

Proponents of opposite school of thoughts claim that economic inequality is not the worst form of social injustice. Considering basic human rights, food, shelter, and clothes are the prime needs of any society, which determine justice and strong rule of law of any state. Deterioration of such basic human rights **Prove to be** worst form of social injustice. As per the rules driven by the World Bank, it is the primary task of the state to ensure that all its citizens fall under the umbrella of basic human rights. Thus, economic

justice tends to be the secondary task of the states, keep human rights at the top.

Likewise they also claim that lack of proper income and job opportunities are creating social unrest in almost every society of the world. Engaging people in legal activities and providing them with job opportunities will tend to bring peace and social order. As per Human Development Index report 2023, over 300 million highly qualified individuals do not possess any legal source of income, hence, they are roaming jobless. Lack of job opportunities will lead to rise in poverty, and unfortunately rise in terrorism. It proves that governments must focus on providing job opportunities to curb the social injustice in societies.

Despite these claims, the fact cannot be undermined that



economic inequality is the worst form of social injustice because any prevailing challenge in society is directly or indirectly being linked with economic justice. The first and the foremost factor leading to social injustice due to economic inequality is minimum education opportunities. Economically weak societies are deprived to get basic education because of lack of schools and colleges. Rwanda, for example, have one of the highest literacy rate in the world, surpassing 90% in Rwandan rural areas, and the primary reason is economic injustice. Hence, economic inequality is forcing people to lack behind in the realm of education leading to social injustice in society.

Similarly, lack of health facilities is also due to unequal distribution of economic resources. Devastating

health centres are unable to help reduce the rate of mortalities. As per A-Tegeera, the highest rate of mortality lies in the economically weak states of the world. In such states due to lack of health facilities, even the slightest diseases are difficult to cure. Thus, economic inequality in such societies are becoming the source of social injustice.

Furthermore, high poverty rate is also one of the devastating factors of economic inequality. Economic inequality curbs the means of people to generate legal income, thus, the poverty rate rises. The South Asian Association for Regional Cooperation (SAARC) generated a report in 2022, stated, "There are over 70% people living under extreme poverty in South Asia." It illustrates, high rate of poverty is due to economic inequality, which

is deteriorating the social structure of the society.

Likewise, unequal economic opportunities is causing rise in terrorism. Insufficient job opportunities, and lack of legal source of income due to unequal distribution of economic opportunities are forcing people to adopt criminal ways of earning livelihood, leading to rise in terrorism. Global Terrorism Index report states, "The top five most vulnerable countries to terrorism are among the economically weakest states of the world."

The report proves that the reason for the rise in terrorism, which is creating social injustice is due to economic inequality.

In the same way, the primary source for income of people of rural areas is agriculture, and unequal economic resources are deteriorating the

agriculture lands making the  
 lands unfruitful to grow crops.  
 As per the Economist Magazine,  
 the agrarian state's economy  
 depend upon the sale source  
 of enhancing economy ~~and that~~  
 through agricultural lands. Thus,  
 economic inequality deteriorates  
 agriculture lands leading to  
 unbearable social injustice in the  
 society.

In addition to that,  
 economic inequality is causing  
 suppression of women and having  
 no income by the male counterpart  
 leads to frustration, who find  
 women an easy target to <sup>take</sup> their  
 aggression out in the form of  
 violence. Global Gender Index,  
 reports that worst treatment  
 of women is taking place in the  
 five poorest states of the world  
 in terms of economy. Hence,  
 economic inequality is worsening  
 social justice by suppressing

women in the society.

However, there are multiple ways to curb the menace of economic inequality. Primarily, ensuring equity in economic distribution of resources must take place in order to give equal opportunities to all the citizens of any state to have legal means to fulfill their basic needs. National Financial Commission Articles in Pakistan is an example of ensuring equal distribution of economic resources to all the citizens of Pakistan.

In addition to that, governments must hold into account those individuals who tend to create economic inequality in nations. Governments ought to penalize the culprits, irrespective of their positions, who are drowning people in the quagmire of social injustice.
