The organization of Islamic Cooperation (OIC) is an intergovernmental organization that works to protect the rights and interests of the Muslim world. It has 57 members and 57 member states, 48 of which are Muslim majority.

To begin with, the ~~oic's~~ inability to resolve the Kashmir disputes has been a significant factor in its failure to protect the plight of Muslim minorities in the region. The OIC's response to the Kashmir conflict is often hampered by internal divisions. These internal divisions prevent the OIC from effectively coordinating efforts or pressuring India for a resolution. Despite strong pressures from Pakistan and other Muslim-majority countries, the OIC's response remains largely symbolic. OIC has made little effort in dispute between Pakistan and India. Therefore, OIC's failure to effectively resolve the Kashmir conflict has been a major ~~its~~ inability to protect the plight of minorities.

Additionally, the ~~oic~~ has been criticized for its inability to protect the rights of ethnic minorities within Muslim-majority countries. This failure is often linked to internal divisions, political expediency and inconsistent approach to human rights. silent on the plight of the Kurds, largely due to the complex political relationships within its member states. Moreover, the OIC has faced significant challenges in addressing Islamophobia. The OIC frequently issues statements and resolutions condemning Islamophobia but largely relies on symbolic rhetoric rather than tangible actions to combat it. The OIC condemned the incident but failed to mitigate strong diplomatic pressure or mobilize collective action across member countries. Thus, the weak and often fragmented responses to the growing issues of Islamophobia.

Muslims. Despite widespread protests and international condemnation, the OIC did not take any significant action. The OIC's reluctance to challenge India is partly due to the geopolitical considerations of member states that have strong economic and trade relations with India. For instance, the BSP-RSS regime in India against Muslims and violence on Muslim population in Kashmir by locked mosques, banned organizations.

Thus, the OIC's inaction in addressing the plight of Indian Muslims is a reflection of internal division and lack of effective response.

Besides this, the OIC has faced significant criticism for its failure to protect the plight of Muslim minorities, particularly in Myanmar. The division within the OIC resulted in a weak and ineffective response with no concrete actions to hold Myanmar accountable. Despite the OIC's collective population of over 1.8 billion Muslims, it has ^{not} been able to translate this strength into significant diplomatic or economic pressure.

on Myanmar. So OIC not effective response to the Rohingya people who have experienced ethnic and religious persecution in Myanmar for decades. Thus, OIC's failure to effectively protect the Rohingya ^{Muslims} crisis can be attributed to a combination of inadequate humanitarian coordination.

Furthermore, the OIC has faced criticism for not adequately addressing the plight of Muslim minorities, particularly due to lack of education initiatives. The OIC has often prioritized political or religious issues over developing substantial education programs for Muslim minorities, especially those in dire situations. The OIC has largely focused on political diplomacy and humanitarian aid but has not fully embraced "educational diplomacy" as a tool for advancing the rights of Muslim minorities. Thus, the OIC's failure to invest in educational initiatives for Muslim minorities exacerbates their vulnerabilities.

Apart from this, the OIC has not played an effective role in combating the discrimination against Muslims. The OIC lacks robust legal and institutional frameworks to enforce the rights of Muslim minorities, either within its member states or globally. For instance, Muslims in France, Australia face challenges such as discrimination, homophobic attacks like bans on hijab etc. Thus, the OIC's inability in effectively protect the plight of Muslim minorities largely from its failure to take an active stance against discrimination.

Even more, the OIC has faced widespread criticism for its ineffective response to the plight of suffering muslim minorities in china. The OIC often focuses more on issues involving western nations or countries with weaker geopolitical relations neglecting violations in powerful nations like china. criticizing china

could lead to diplomatic isolation or retaliation for many member states, discouraging them from supporting a strong OIC position. For instance, inaction on China's repression of Uighurs in Xinjiang by intense surveillance, forced labor. (Council on Foreign Relations) Therefore, the OIC's inability to protect Uighur Muslims in China stems from economic dependencies and geopolitical constraints.

Moreover, the OIC also show ineffective news in addressing the plight of suffering Muslim minorities in the United States. OIC emphasizes the necessity to respect the rights of Muslims communities and minorities in non-OIC Member states. But Muslims in the US face challenges such as discrimination, surveillance, and hate crimes. Despite these issues, the OIC has not effectively launched campaigns or diplomatic efforts to counter rising Islamophobia in the US. For instance, according to AHA, Muslims in America faced fear such as violence, terrorism and Islamophobia. Thus, the failure of OIC to

Furthermore, the OIC aims to address the issues of suffering Muslim minorities in Russia. The aims of OIC to protect the rights of Muslim minorities in non-Muslim countries. But Russia holds significant global political influence, making it challenging for the OIC to exert pressure or condemn its actions. Several OIC member states, particularly those with close economic and military ties to Russia, avoid openly criticizing it. For instance, no response on Muslims in Russia, facing xenophobia, discrimination and integration related issues. (BBC) Therefore, OIC's reluctance to act on the suffering of Muslim minorities in Russia underscores its geopolitical limitations.

Last but not the least, the organization of Islamic Cooperation (OIC) has struggled to protect the plight of Muslim minorities in Sri Lanka. Sri Lanka's Muslim minority, comprising about 10% of the population, has faced many

issues. From OIC no significant diplomatic measures were pursued to engage the Sri Lankan government to safeguard muslim minority rights. Also the OIC did not establish any communications channels with Sri-Lanka's government to address growing anti-Muslim violence policies. For instance muslims in Sri-Lanka facing harassment and discrimination after the 2019 easter bombing. Thus, the OIC's limited diplomatic and advocacy efforts in Sri-Lanka highlight its challenges in effectively protecting muslim minorities.

To conclude this, there arguments prove that the OIC has been unable to protect the plight of suffering muslim minorities. To begin with, the OIC has faced criticism for its inability to adequately address the plight of suffering muslim or ethnic minorities.
