The term criminology was coined by Raffaele in 1885. Criminology is the study of the various aspects of crime. It literally means studying criminals and crimes. It is an interdisciplinary field that draws on various areas of study like psychology, sociology and law. It has the importance in identifying factors contributing to commitment of crime, criminal behaviour, and ^{and in} the policy making of preventing crimes.

2) Definition of criminology

Criminology can be define in terms of Edwin Sutherland. "Criminology is the body of knowledge regarding crime as social phenomenon. It includes within its scope the processes of making laws, breaking laws, and the response to breaking of the law."

Similarly Donald Tapp defined :
criminology in two sense

a) General sense:-

In general sense, criminology includes is the study of crime and criminals.

b) Specific sense:-

In specific sense, criminology is aim to study the criminal behaviour, reforming the criminal behaviour, and the conduct of an individual which society condemn.

Nature of Criminology

Criminology is an interdisciplinary subject. Its primary subjects are crime and criminal behaviour. It identifies the factors behind the commitment of a crime, analyzes the pattern of the criminal behaviour, formulates strategies for effective criminal justice system, and evaluate the effectiveness of the CJS. c) Policy formulation and evaluation

Criminologists formulate policies on the basis of the scientific findings, and evaluate these policies through scientific approach.

Importance of Criminology

a) Aids in understanding the causes of crimes:

As criminology came into existence to study the crime and the causes of crimes, so it has a crucial role in understanding the underlying causes of crimes. It helps in prevention of crimes in society.
