ICOs set a standard of global norms and acceptable behaviour for member countries. This standard ~~not~~ influences not only member states but also international entities. For example: UDHR (Universal declaration of Human Rights) was drafted under UN general Assembly. It has been recognized as a global standard for over 60 years.

International Governmental organizations create rules by the agreements between states. These are called treaties. ~~to the~~ These are legal bindings and all the states must abide by it once they have signed it. For example Kyoto protocol, nuclear proliferation treaty and convention against torture.

ICOs also perform supervisory role. ~~These~~ establish organizations to supervise. These establish supervisory organizations to ensure compliance of treaties or rules created.

ICIOs can also resolve the disputes arising from interpretation of ~~rules~~ or violation of rules. These also have powers to enforce treaties. This has enhanced its effectiveness.

ICIOs are responsible for operational functions, including direct action and delivery service. These collect resources, supplies and experts. ~~For~~ They assesses the global issues to be tackled. For example, UNHCR, United Nations Higher Commission for ~~ref~~ refugees, provide house, food and other essentials to refugees. It is responsible for planning and execution of ~~plans~~.
