"War is an extension of politics", said the former US president John F. Kennedy. Politics is a multi-faceted game of agendas that is marked by leaders, their ideologies and destructive events. Global History is replete with incidents that were based on politics and resulted in chaos. This dirty game does not regard moral practices of truth and honesty. Human rights are seldom considered during wars. The economic implications of divergent political narratives are unfair for certain actors. International politics does not provide the required attention to human development. Campaigns and rallies disregard any bit of morality when leaders address each other. The masses are used as tools to gather

sympathy and win the public support for unjust actions.

Pin-point agenda against targeted enemy results in non-recoverable losses.

It is a pertinent fact that International Politics does not regard moral and ethical values of justice, freedom and sovereignty.

International Politics is marked by events of war.

There is a visible divergence of interest between various countries.

Such differences lead to war which results in grave violation of human rights. During war

times, there is little to no regard of non-combatants. Children,

elderly and women, are unjustly affected by the occurrence

of disputes. Other immoral acts like rape, genocidal intent and amputation of organs

are also associated to events of war that are a result of political disdain. The recent war in Gaza served as a case study. The war of political ideologies led to over 50,000 civilian deaths.

Global Economy is interlinked to politics. A strain on political ties poses economic repercussions for countries. The powerful countries tend to offer economic assistance to poorer states for the extension of their interests. In case of double-crossing or non-compliance to the hegemon, economic sanctions are imposed.

These include higher taxes on imports, cancellation of agreements or curtailment of aid. In late 1990s, Pakistan faced harsh economic sanctions, termed the Pressler Amendment, for testing

its nuclear ability against US will. Such sanctions destroy stability on all fronts for the smaller state.

International politics is driven by idea of realism. This means states are inclined towards maximization of power. It is often witnessed that political entities spend huge resources and strategic abilities only a minute portion of budget is reserved for human development and social well-being. In order to pursue the latter aims, ethical values of equality are ignored and social evils of hunger, poverty prevail in the society. Harold Lasswell elaborated this very concept in his definition of "warrior State"; one where military spending is a core idea.

Political leadership is also devoid of any moral

values. Mocking, character assassination and exploiting each others deficiencies remain the driving factors of global politics. Leaders target their opponents by false narratives and dishonest projections. They use harsh and hurtful words in their election campaigns or public addresses. Recent US Presidential election campaign showed a heated exchange of morally objectionable words between Trump and Harris. Such events depict the moral decay triggered by global politics.

Misleading public sentiment for extension of political goals is a prevalent immoral practice. It means false portrayal of positive intent to legitimize use of force in the masses.

entity is a common practice in the International State system. There exists a harmony of interests between the ruling elite of core states and weaker nations. Such groups pay no heed to the moral considerations while formulation of policies. They plan to pursue their self-estimated interests on the blood and resources of the poor citizens. This phenomena is validated by Paul Prebisch's Dependency Theory of Global Politics. It is indeed devoid of any moral binding.

driven by US establishment's hatred for the former. The unfateful event was marked by protests, revolts and bloodshed.

Leadership nexus is the cornerstone of international politics. Parallel efforts to achieve a common agenda is often witnessed. In case a leader does not join hands to pursue a dominant idea or interest, they are eliminated. It is a morally corrupt practice of killing a leader in order to pave way for extension of political interests. The recent plane crash of Iranian President Ebrahim Raisi has erupted certain propagandas. It is not just below morality to kill for politics, but also inhumane.

an illegal but common political activity. The affluent countries extend support to various actors in this regard. The rise of non-state actors, their backing by interest groups in order to maintain status quo do not abide by any ethical norms. The powerful try to crush the weaker ideologies or engage them in chess in order to dominate policy making. The US funding of VNSAs (AQ and TTP) to counter Communist USSR disregarded morality. Such unfortunate acts have been centre of politics.

In summary, it is a visible practice that political ideologies and actions are triggered by selfish agencies that do not consider moral or ethical rules. The operation of businesses of war and

generating income out of blood is one such activity. The evil connection of rich people's interests and their dominance in global decision making is also an illicit practise. Individual level differences and divergence of interests result in regime changes and undue killing or assassination of leaders.

The financing of terror groups and violence on foreign lands blur all limitations of morality. With the emergence of critical thinking and globalized economies, there is still hope but future of world politics would be inclined towards cooperation rather than conflict.
