Introduction:

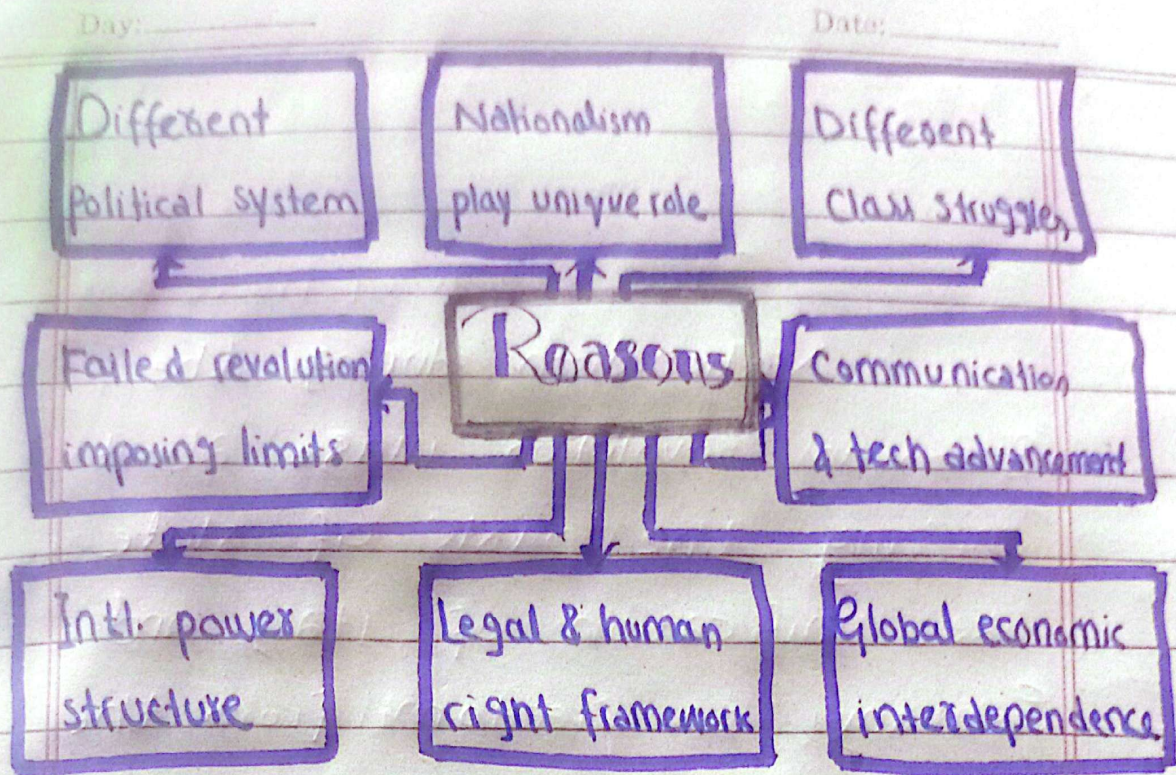

III) Brief overview of revolutions of 1830s and 1840s:

July revolution of France was against the repressive policies of Charles X. He imposed censorship and limited voting rights. The revolutions of 1840s were the ignorance of Working Class by the Louis phillipe who only considered the interest of rich middle class. So, the revolutions of 1830s and 1840s were basically to achieve fundamental rights.

(II) Reasons why lesson cannot be drawn from European Revolutions:

Lessons cannot be drawn from the European revolutions of 1830s and 1840s due to following reasons:



i) Different political systems during the European revolution and 21st Century:

The European Revolutions of 1830s and 1840s were against the absolute monarchy and feudalism. Nowadays, countries have democracies, constitutional monarchy and dictatorship. So, fighting against the monarchy is not same as challenging the government in 21st century.

ii) Nationalism plays a unique role during both the time periods:

Nationalism during the European revolution was about unifying the parts of state like unification of Italy and Germany or freedom from the foreign rule. But nowadays nationalism is about unique feelings of nationhood, and anti-immigration sentiments.

iii) Different class struggle limit the universal lesson to be drawn:

The working-class during the European Revolution was emerging due to the newly established industrialization. So, the revolution during this time

period was to achieve basic rights of workers. But during the 21st century fundamental rights for the working-class exist in the modern democracies.

The protest can be held to demand better-workings conditions not for basic rights.

iv) Failed revolution during 1830s and 1840s imposing limits on universal lesson:

Some revolutions during 1830s and 1840s were successfully suppressed by the rulers. This implying that when Europe itself was unable to replicate success of revolution during this period than how universal lesson can be drawn from these revolutions.

v) Communication and technology advancement during both time period creating distinctions:

The technology and communication resources were not as advanced to quickly suppress revolution. But nowadays technology and communication has made progress and government can suppress any uprising using media and AI surveillance and stated by Hans J Morganthau in his book "Politics among Nations".

vi) Different international power structure:

When revolution happen in any country different super powers like Russia, Britain, and France might sent troops to crush it. But now world

is more globally connected. So, in order to prevent any violations US and EU might impose sanctions or imposing tariffs on the country to influence them. So, the strategies of revolution time period can not be imposed these days.

vii) Legal and human rights framework of Modern day not allow to draw lesson;

During the revolution time period no legal and human rights framework was available to demand rights. So, the violence and revolution was the only way to bring reforms during this time. But now legal & human Rights framework

exist in the form to United Nations to stop violations of human right and bring peace in the world. So, revolution tactics are not suitable in this democratic world.

viii) Global Economic interdependence limiting countries to act individually:

During 1830s and 1840s countries act at their own to respond any revolution. But in this world which is economically interdependent countries have to act carefully. Because any mistake made by one country would result into global economic crisis like Great Depression of 1929.
