Q) What is the Aristotle Classification of state?

Introduction

"Man is by nature a political animal. He who does not live in a state or does not need a state is either an animal or beast"

Aristotle.

Aristotle is an ancient philosopher. He called state a natural form not an ideal form. He is called as a Father of Political Science. According to him state is comes into existence by observation and state is a natural. So he was the first philosopher to collaborate state and nature exist into each other and referred politics to political science. However, Aristotle was the father of biology and political science. He observed 158 constitution with in Greek city-state, and gave his theory of "Constitution" in which he classify state. In this theory he describe the ideal and worst form of government.

2) Aristotle's classification of State

Aristotle in his "Theory of constitution" described the different forms of government. According to him State should be ruled by one, few and many individuals. He further divides these forms of government into perverted forms and normal forms. According to Aristotle the state which is ruled by one individual is a Monarchy and Tyranny. In Monarchy, King would engage with virtue and power. A King would rule government according to rule of law. On other hand, Tyranny is a perverted form of government. Furthermore, a state can be ruled by few individuals. It includes two forms, Aristocracy and Oligarchy. A normal form of government and Oligarchy are perverted forms of government.

2.1) State ruled by Many individual
According to Aristotle State would be ruled by many individuals, Polity is the normal form of government and democracy is the perverted form of government.

2.2) Monarchy: Ruled by one individual

Aristotle's classification of state was borrowed by Plato but Aristotle further explains the classification of state

Monarchy According to him a best form of government but virtue and power cannot work together. So, it is an ideal form of government.

2.3) Tyranny: Ruled by one individual

This state also ruled by one individual but rules ruled in this state for his own

benefit. Hence, it is a perverted form of Monarchy.

3) State ruled by few individuals

Aristotle explains that state would be ruled by two or few individuals. He explains two theory in this context.

- ① Oligarchy 2) Aristocracy.

3.1) Aristocracy: A state ruled by few individuals

A form of government in which few individuals rule for the benefit of state and public.

It is a form in which national benefits are prior.

3.2) Oligarchy: A state ruled by few individuals

A perverted form of Aristocracy. A government ruled by few individuals which have their own benefits from state and fulfil their own desires.

4) State ruled by many individuals

A form of governments or constitution ruled by many individual for their own benefits and state benefits

4.1- Polity: ruled by many individuals

According to him this is a best particular form of government. A government in which a rule of middle class brings stability. Polity is offered as a today modern Democracy.

According to him it is a perverted form of polity in which many individuals gain their own benefits and fulfil their own desires. Democracy is a government by poor. Hence it is the second worst form of government

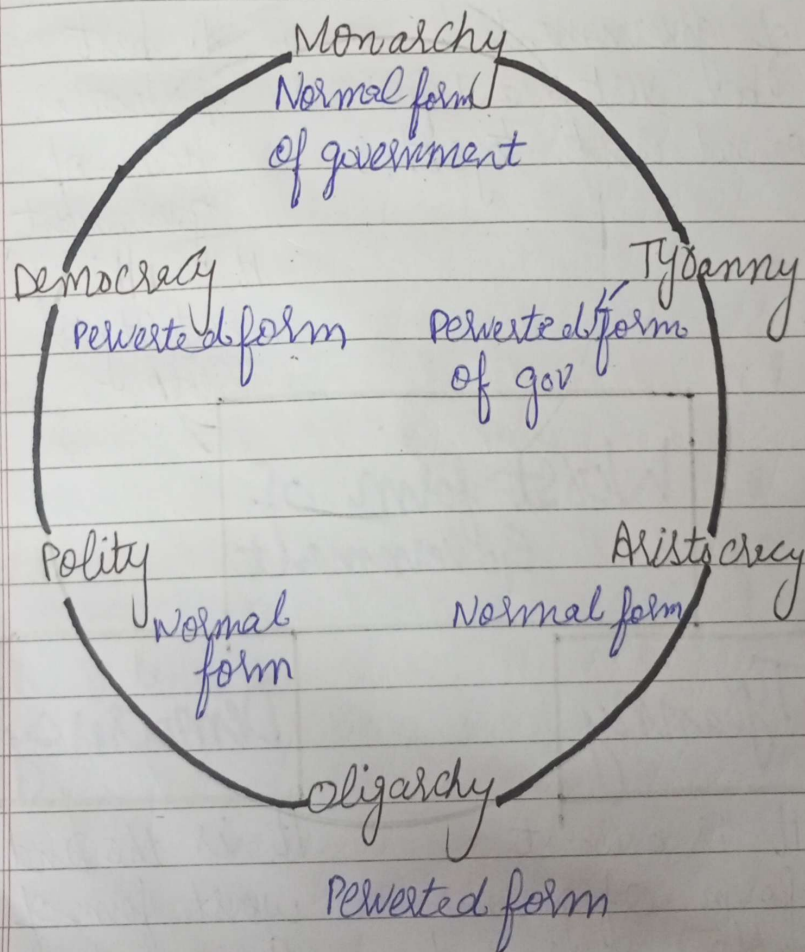

Aristotle explains that virtue and power cannot work together so Monarchy converted into Tyranny

Monarchy $\rightarrow$ Tyranny

According to him a slightest change in a government can bring revolutions. A Monarch King would face hypocrisy and jealousy by other leaders which is also a reason of change. Furthermore, An absolute power to Monarch turned him to Tyranny.

6.2) Tyranny convert into Aristocracy

An absolute King with power and virtue work with its own benefits, A revolution by few virtuous individuals which work from ~~everyday~~ and state development. Kick out Tyranny and establish a Aristocracy.
