Under this initiative 70+ countries pledged to cut cooling emissions by 2050. Hence, in this manner, with many more initiatives of collaborative efforts like these, humanity can ensure a prosperous future in context of global warming.

Another important effort to combat this growing problem of global warming is via sharing the responsibility through generations.

Intergenerational responsibility is crucial in dealing with this difficulty. The solutions and efforts of one generation carry a legacy for the generations to come. It is then, that coming generation's responsibility to further the cause and also providing innovations and novel solutions. of natural habitats of all life forms. The rising sea levels bring about floods. These floods, when strong enough, can completely obliterate human habitats. The 2022 floods in Pakistan are a prime example of this where millions of people were displaced from their homes according to WHO reports. The destruction of their homes caused two fold problems. First they had to be relocated somewhere else and secondly they had to be provided with all the basic facilities. Animal habitats are famously known to be destroyed by global warming. One prime example of this is marine iguanas who are natives of Galapagos Islands. Intensive heat in these islands severely impact their food source, the is the green algae which turns brown. Due to this reason, ~~iguana populations are increasingly becoming extinct in recent years.~~ ^{have excessively become} Both of these case studies provide ample evidence to prove that lack of coordinated effort ^{to combat global warming} can be disastrous for habitats of all life forms.

Lack of coordinated effort to tackle global warming can also create health problems and make the planet uninhabitable for human and other species. ~~Due to global warming~~

Temperature sometimes rises to unprecedented levels. This causes massive changes in precipitation levels. According to WHO report, temperature and precipitation changes enhance the spread of vector-borne diseases. Without preventive actions, deaths from such diseases may rise to 700,000 annually. Unfortunately, not much attention is being paid to this cause especially in the climate-vulnerable developing and underdeveloped countries. So, we can conclude that without active and coordinated efforts towards mitigating global warming induced climatic conditions, mankind is risking the lives of hundreds and thousands of people annually.

Additionally, global warming can become a direct cause of resource conflicts in the near future. Due to global warming, water bodies like rivers, lakes, seas and oceans are frequently drying up. Some of these water bodies originate in one country and flow into other countries. Which means that these water bodies are a shared resource for those countries. But as the effects of global warming are becoming more visible, and

the water bodies are shrinking there is a trend of water conflicts between upper and lower riparian states. This is the most common trend in Asia where upper riparians like China and India frequently cause trouble for their neighbouring countries. ~~A significant case study of this is the Indus Water Treaty signed between Pakistan and India in 1960. The waters were~~ equally distributed between the two countries according to this treaty, but as the climatic conditions in both countries are worsening both want full resource control. India often violates the treaty by constructing dams on the river flow, which significantly impacts life in Pakistan. ~~Countries elsewhere like in the Middle East also have major water conflicts exacerbated by global warming. Unfortunately governments of~~ India and Pakistan are not doing much to solve the problem in totality. ~~This negligent~~ behaviour has put both countries especially Pakistan in extreme paranoia about water scarcity and complete blockade by India in the longer run.

Subsequently, there is an upward trend of militarization of climate impacted zones

As ecosystems are disrupted and resources become scarce or newly accessible, global warming intensifies state competition and militarization of previously stable regions. The Arctic, Sahel and South Asia are key examples of this climate-security nexus. According to NASA, The Arctic sea ice is declining and warming faster than the global average. This has led to opening up of new sea routes, untapped mineral, oil and gas reserves and greater access to fisheries. Russia has reopened Cold-War era bases, air fields, radar stations and brigades. NATO and US have also increased surveillance and naval exercises in Alaska, Norway and Greenland. As half of the countries surrounding The Arctic aren't doing much to control global warming in the region it has led to militarization and the region is becoming more conflict prone by every passing year.

Human negligence has added to another misfortune induced by global warming. The developing and underdeveloped countries of the Global South are already paying the price for climate change which they did not bring about during industrialisation. The

industrialized North brought this hell upon these poorer and underdeveloped countries. The Global North under the global climate regime often pledges to compensate for this destruction but little progress has been made in this regard so far. The Green climate fund under this regime pledged \$100 billion but only \$12 billion has been collected so far, which is negligent compared to what these climate-hit regions have to cope against. Moreover, the carbon credits are also a sham as rich countries frequently buy them from poorer ones. This is a textbook case of how exploitative is the nature of climate regime. Negligent and selfish human behaviour is further widening this gap which is leading to erosion of such poor and fragile democracies.
