ANSWER: ① INTRODUCTION:

Political parties are the organizations of society, not state itself. They organize diverse societal demands into coherent policy frameworks. Without these parties, mass interests fragment and fail to translate into government action. They have mobilized public around civic participation and engagement. In Pakistan, they have led the democratization drive in the 1980s-90s. They provided the platform to labor unions, student organizations, and rural cooperatives, turning isolated protests into organized social movements.

② Political parties as Drivers of social change

(i) Articulate Social Interests

Parties gather diverse demands from almost all segments of society and convert them into structured policy platforms. Labor groups, students, and minorities are bridged with mainstream politics. They translate their social grievances into political agendas.

(ii) Increase Civic Participation and Democratic Awareness

Parties educate citizens, foster political engagement, and cultivate collective identities through campaigns, rallies, and local branches. Parties in Pakistan and India educate citizens on their political rights and duties.

(iii) Enable Large-Scale Societal Change

Political parties act as intermediaries, conveying public grievances to the state and state policies to the public. They are rather transmission belts of democracy. In South Asia, parties like PPP and INC performed this connective role during moments of crisis.

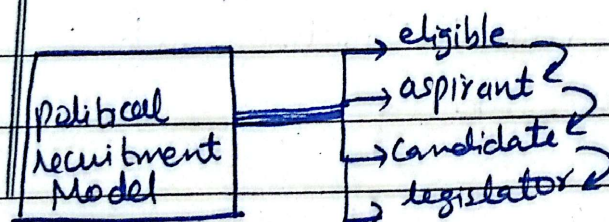
(V) Form Political Narratives and Collective Identity

Parties shape national debates on social issues. The way Muslim League as the sole representative party of Indian Muslims crafted the ideology of Muslim nationalism speaks volumes of political parties being change drivers.

Engines of Political Recruitment

(1) Ensure Supply of capable leadership for Governance

Parties act as gatekeepers. They select, train, and recruit capable leaders individuals, and turn them into leaders for efficient governance. They filter political talent and groom individuals capable of leadership.



For instance, Singapore's PAP uses meritocratic 'talent spotting' to recruit technocratic leadership.

(II) Parties Structure Government and Policymaking

The winning party forms the government & assign ministers & implements policies. While the opposition parties critique and provide accountability & both horizontal and vertical. For instance, in parliamentary systems, ministers and committee chairs shape legislative directions and agendas.

(III) Hold Politicians Accountable

Political parties frame complex socio-political debates into coherent manifestos & making electoral choices meaningful. They streamline politics through ideologies and collective

consciousness.

(iv) Institutionalize Ideology and National Identity

political parties fuse religious-cultural symbols with modern-policy agendas. This way, they enable social cohesion and propagate a shared national narrative to rally people around it.

(v) Ensure political socialization

Political parties run schools, youth camps and publications to inculcate civic values, political literacy, and the very democratic norms that sustain long-term participation.
