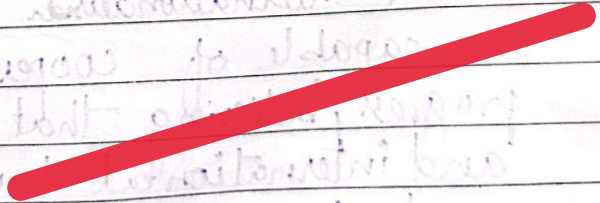
What are the essential differences between the Liberal Internationalist and Realist theories?

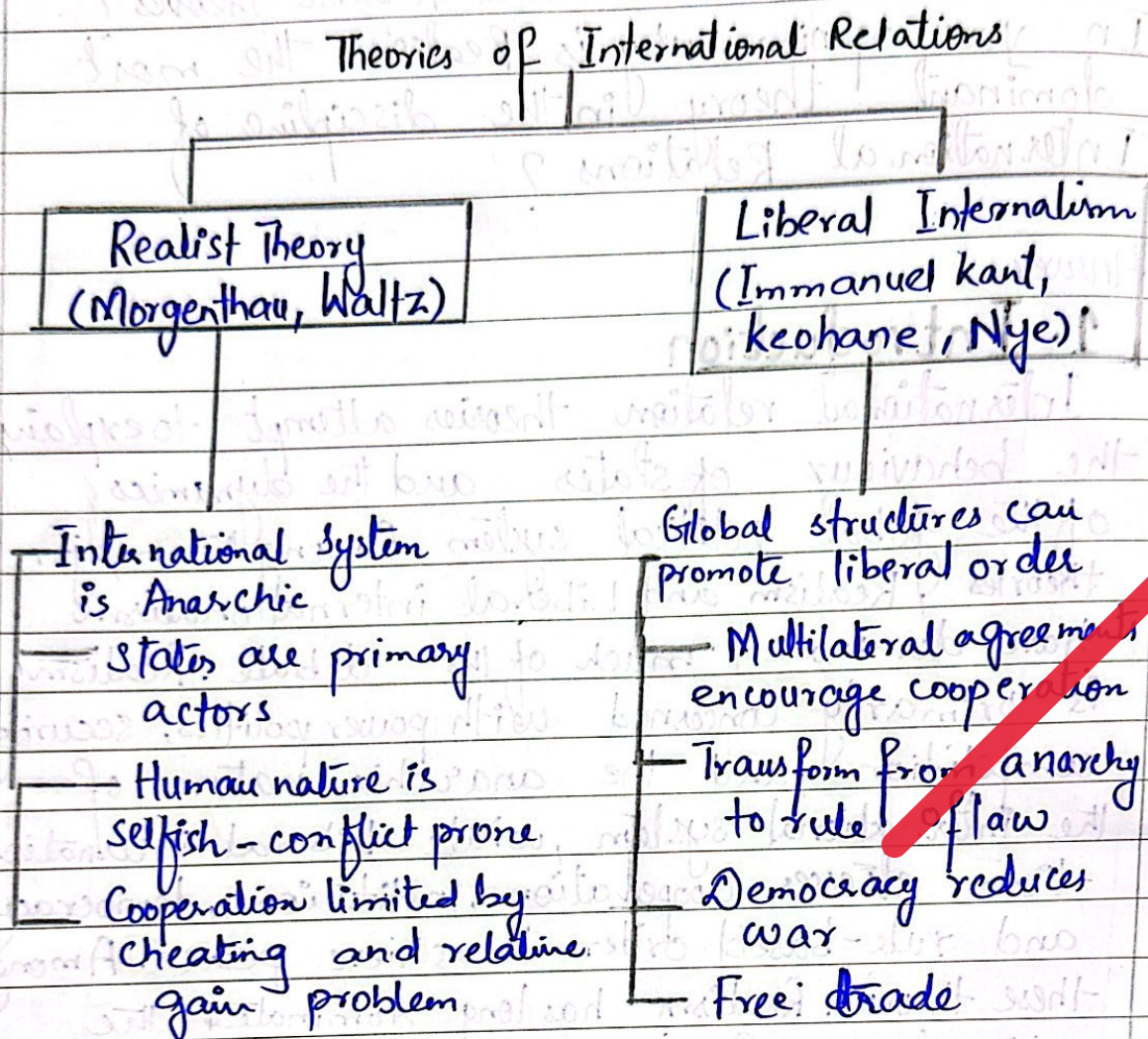

According to Keohane and Nye, globalization has increased interdependence among states, compelling them to focus on economic, environmental, and collective issues instead of security. This is the view of Liberal internationalist theories. ~~Waltz~~ Waltz, representing Realism, argues that the structure of the international system is anarchic, compelling states to focus on security and self-defense strategies for survival.

3.4 Conflict vs Cooperation

Liberal internationalism is optimistic about international cooperation, as illustrated in the Prisoner's Dilemma, where institutions and agreements can help states overcome mistrust and achieve common gains. Realism, particularly Neo realism, argues that cooperation is

fragile, due to fear of cheating, lack of trust, and security dilemmas, making power struggles and arm races more frequent.

3.5 Relative Gains vs. Absolute Gains

Liberals believe that absolute gains; mutual benefits for all states, should guide international relations, promoting prosperity and stability. Realists emphasize relative gains, where states only cooperate if they do not risk another state gaining more power, making cooperation rare.
