ANS INTRODUCTION

After the death of sixth mughal emperors, Aurangzeb Alamgir, the muslim rule became very weak. The people started living a luxurious life and ignored the teaching of Islam. This led to decline of muslims in sub-continent. Shah waliullah was an eye witness of muslim decline in subcontinent. He was born in 1703, when muslim rule was at its peak. The muslim rule gradually started to decline in subcontinent. So he started effort for revival of muslim values and identity in sub continent.



## LIFE OF SHAH WALIULLAH

Shah Waliullah belonged to a noble family. His father, Shah Abdur Raheem was a bureaucrat in Aurangzeb Alamgir's court. His father also ran a Madrasah, Madrasah-e-Rahimiya. His father died at the age of 17. He got his initial education from Madrasah-e-Rahimiya. He started teaching and preaching Hadith in Madrasah-e-Rahimiya. He went to Hajj and <sup>when he</sup> came back, he realized the condition of Muslims in sub continent is on alarming situation. The invasion of Nadir Shah shook the foundations of Mughal dynasty in India.

## PROBLEM AT THE TIME OF SHAH WALIULLAH

### 1 - WEAK MUSLIM RULE

After death of Aurangzeb Alamgir, Muslim rule in sub-continent had become really weak due to

## 2- RISE OF HINDUS

After death of Aurangzeb, the Marathas and Rajputs in South became powerful. They started attacking muslim states and weakened muslim rule.

## 3- FOREIGN INVASIONS

Foreign invasions also played a vital role in weakening muslim rule. The attack of Persian king Nadir Shah was a nightmare for people of sub-continent. The invasion of Nadir Shah led to indiscriminate bloodshed and shook the foundations of muslim rule.

6- Moral degradation of society - due to luxurious lifestyle

The people at that time had started to live a luxurious life, which led to moral degradation of muslim nobility.

7- Division of society

The muslim society was divided on various grounds like Sunni-Shia and ethnic grounds.

8- PREVALENCE OF BIDDAT

Another problem at that time was prevalence of Biddats due to misinterpretation of Sufi mystics. This posed a threat to true spirit of Islam.

9- Not following the religion in true letter and spirit

Due to all above factors, people were not following the religion in true letter and spirit in its original form.



## SERVICES OF SHAH WALLI-ULLAH

Shah Waliullah took the responsibility of revival of Islam values in true spirit. According to Shah Waliullah, the major cause of muslim decline was not following the religion in its true spirit.

So according to Shah Sahib cause of decline was not other than aloofness from religion so he started his efforts to let the common people know the true message of Islam. For this purpose he rendered the following services

### 1 - Translation of Quran-e-Pak to Persian

Firstly, he translated the Quran-e-Pak to Persian so that muslim must understand the real message of Allah (SWT)

## 2- Efforts to Reduce Divide in Muslim Society

He wrote a number of books to let the people understand the causes of sectarian differences. Through his literary work, he tried to reduce the division in society on basis of minor issues. He wrote books to synthesise the conflict between Sunni and Shia sects on Khilafat. He also rendered literary services to <sup>give</sup> synthesis for different school of thoughts (Hanfi, Shafi, Malaki, Hanbali).

## 3- Letters to Ahmed Shah Abdali

To reduce the Marathas influence, he wrote letters to Ahmed Shah Abdali to come here and conquer Marathas. Abdali came and third battle of Panipat was fought which decreased the Marathas powers.



## 5 - Hujjat-ul-Balgha and Muslims Renaissance

Shah Waliullah wrote his hall-math book Hujjat-ul-Balgha in which he explained why Islam is only religion suitable for every human and how it can solve all problems of humanity.

## 6 - Taqleed over Ijtihad

Shah Waliullah emphasized on Ijtihad rather than blind following (taqlid). He is therefore quoted as first original thinker of Islam by "S.K. Islam".

## SAVING MUSLIMS FROM POLITICAL AND RELIGIOUS DEGENERATION

### 1-POLITICAL ANNIHILATION

He saved Muslims from political annihilation by inviting Ahmed Shah Abdali. The first battle of Panipat weakened Mughals.

ANS INTRODUCTION

After the war of independence, 1857, muslims came under the wrath of British. No stone was left unturned to keep muslims away from state <sup>affairs</sup>. This was because British considered muslims sole responsible for the war. The shared history of conflicts between christians and muslims was also a cause of British wrath. Furthermore, British snatched the rule from muslims. Therefore, to undermine muslims, they had a discriminatory behavior towards muslims. Muslim very devoid from the elite jobs. The only jobs open for muslim were either peon or sweeper. Muslim on other hand were reluctant to get modern education and considered modernity as a threat to their religion and cultural

In this critical time, Sir Syed came forward to rescue Muslims. He started an educational movement - Aligarh. Though initially Aligarh was a pure educational movement but it deeply impacted the politics of sub-continent in ~~later~~ earlier decades of 20th century.

## EDUCATIONAL CONTRIBUTIONS

Aligarh movement tried to ~~end~~ provide Muslims the modern education so that they may become able to regain their lost status. For this purpose two schools in Muzadabadabad and Ghazipur were opened. Similarly M.A.O school in 1874 and M.A.O college in 1876 were opened, which later gained the status of a Aligarh university. Aligarh university provided the modern education to Muslims and enabled them to survive the British wrath.



## POLITICAL IMPACTS OF ALI-GARH MOVEMENT

Though initially Sir Syed Ahmad Khan stressed on aloofness from politics in his trinity policy, yet the movement had great impact on political developments took place in first half of twenty first century.

### 1- ALIGARH SHARPENED THE POLITICAL ACCUMEN OF MUSLIMS

Aligarh, through the provision of modern education, was able to increase the political accumen of muslims. Hence they survived the British wrath and Hindis conspiracies.

### 2- ALIGARH - AS A DIPLOMATIC PLATFORM

Aligarh movement proved to be a diplomatic platform as <sup>some of</sup> the staff members ~~was~~ were British. So it provide opportunity to convey the muslim



point of view. For example, the vice head of Aligarh University played a vital role in Shimla delegation.

#### 4- ALIGARH IN DECREASING TENSION BETWEEN BRITISH AND MUSLIM

Aligarh played a pivotal role in reducing the tension between British and Muslims. For example, the Scientific Society and other Aligarh platforms prepared literary work to let British know their point of view.

#### 5- Aligarh and Women in politics

Aligarh had a women wing which played a pivotal role in politics of sub-continent later on.



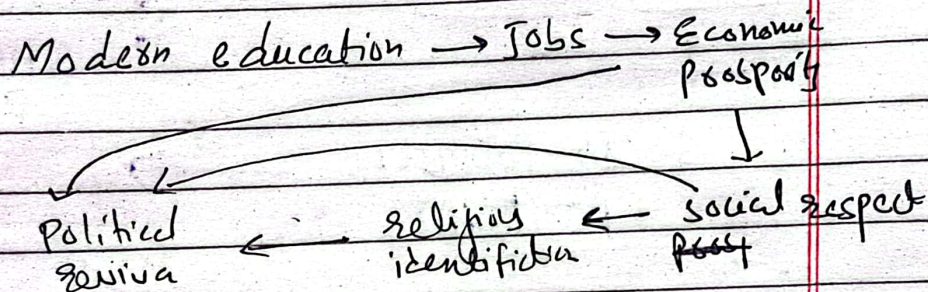

Aligarh provided modern education, through which muslims were able to get the respectable jobs and hence it improved their socio-political status and respect.

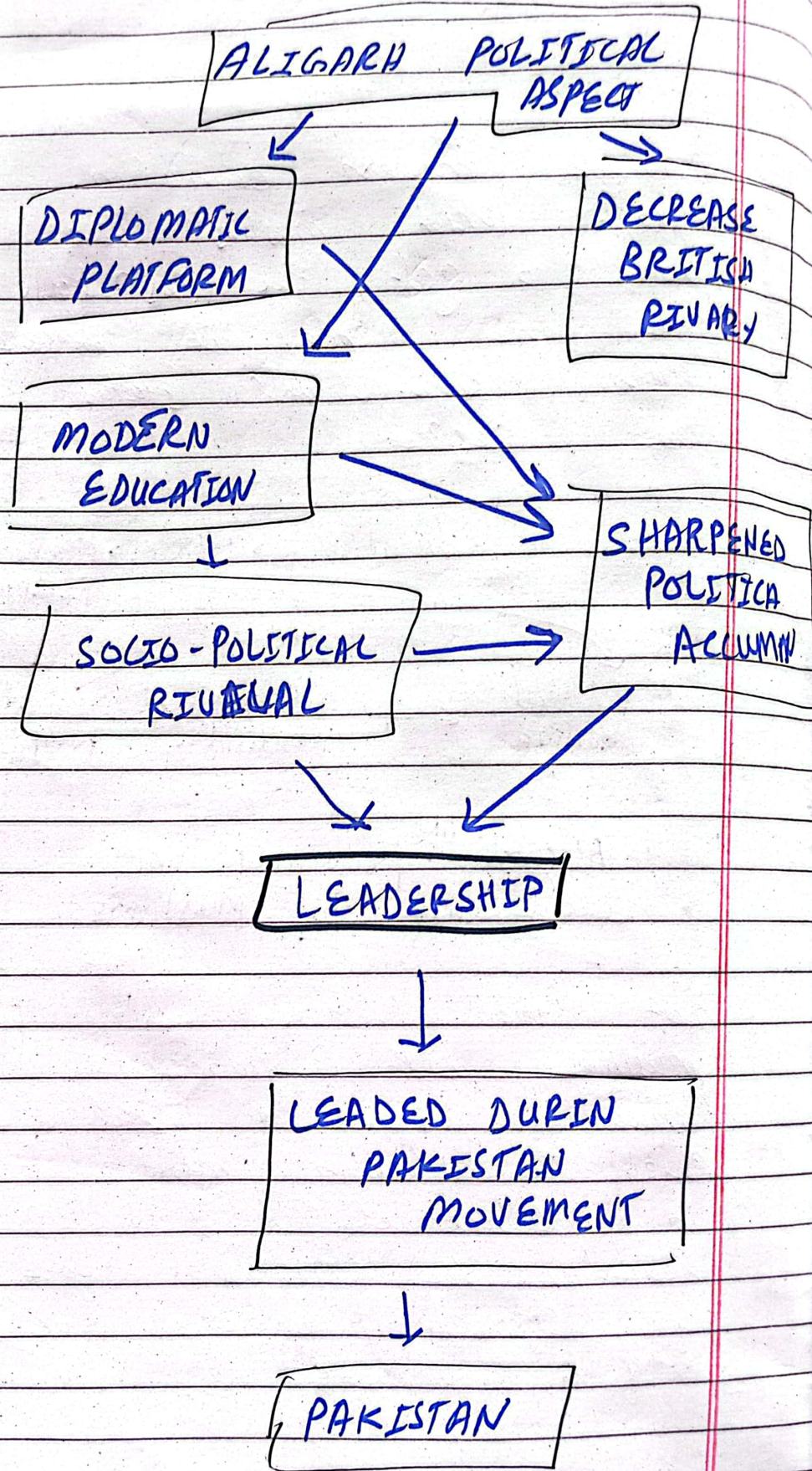


## 7- Aligarh <sup>AND</sup> PROVISION OF Leadership to Muslims

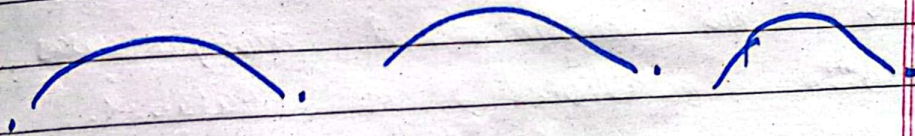

### INTRODUCTION

Since the time of Prophet (PBUH) muslims had great interest in subcontinent to spread the divine message of Islam. During the time of second and fourth caliph, various commanders came to sub continent. A mosque was also established in Malabar. But none of the areas were under the Muslim Caliphate till 712.

### ARRIVAL OF ISLAM - (712) IN SINDH - ROLE OF MUHAMMAD BIN QASIM

As muslim traders came to Ceylon, <sup>the</sup> muslims and had families. Some of Arab traders died due to a pandemic. The bodies of deceased, their family members and gifts for caliph were sent by Ceylon's governors. But these steps

were captured by pirates. Governor of Ray Huggay bin Yousaf asked Raja Dahir to save ships from pirates but he gave a colder shoulder. So Huggay sent his nephew Muhammad Bin Qasim, who defeated Raja Dahir.

### POLICIES OF MUHAMMAD BIN QASIM AND SPREAD OF ISLAM IN SINDH AND PUNJAB (NORTH INDIA)

Unlike the other warriors, Muhammad Bin Qasim treated people with great respect. No indiscriminate bloodshed was made. Properties of locals were not confiscated. This led to a soft corner for Islam and people started embracing Islam in large numbers. Arab missionaries were called to preach Islam. The locals, who were fed up with caste system entered the circle of Islam and Islam flourished in North India (present day Punjab and Sindh).

## Role of Khwaja Mueen-ud-Din Chisti

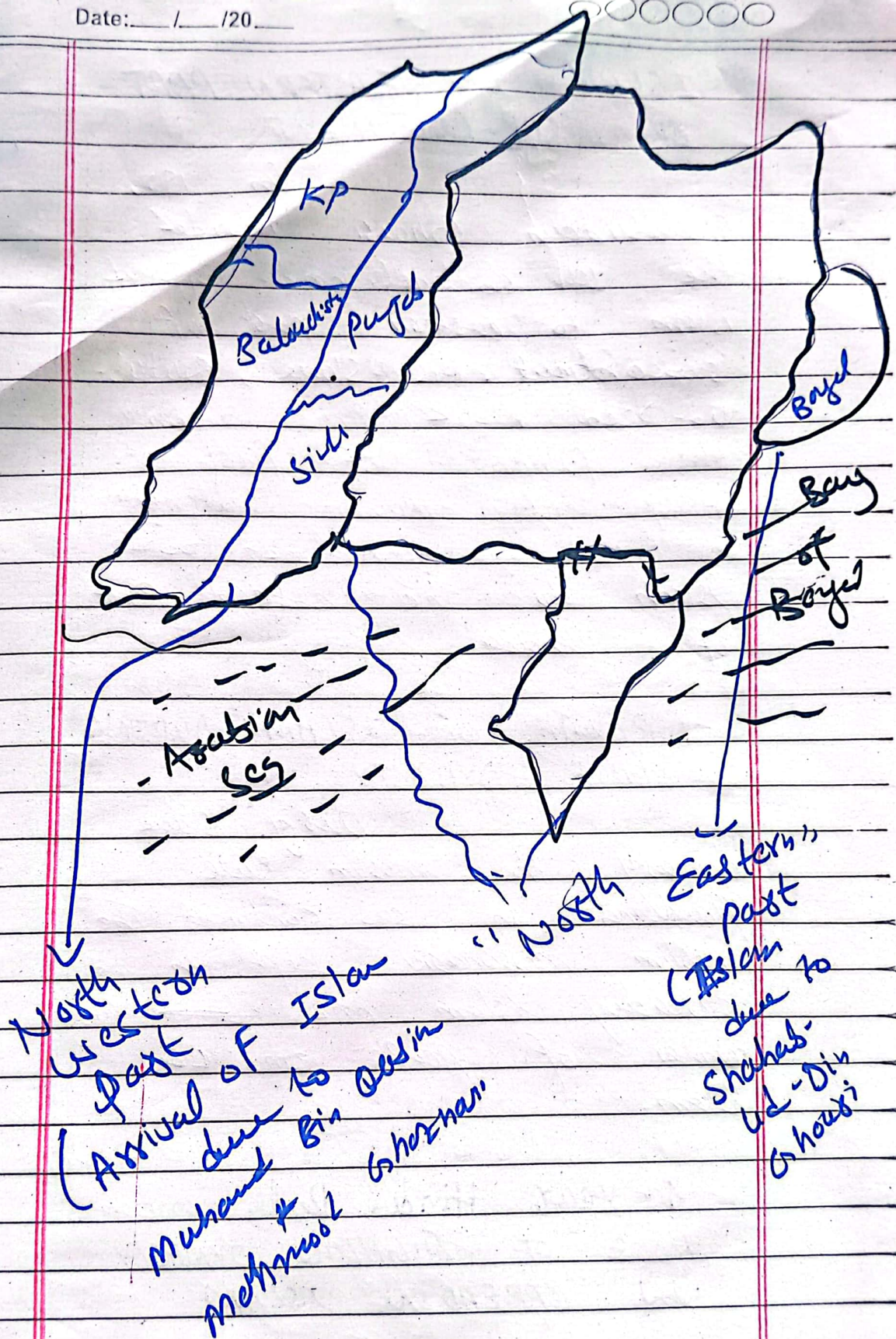

### SPREAD OF ISLAM IN MUGHAL ~~ERA~~ ERA

Islam kept flourished in sub continent in mughal Era, though it faced some challenges.

### AKBAR - ROLE OF MUJADDID ALIF SANI

In order to appease the Hindus and consolidate his rule, Akbar made matrimonial alliances with Rajput princess, allowed Hindus in Royal court as per his Salal e kul policy and introduced deem-e-ilahi. This posed an existential threat to



Islamic Identity. Mujadid Alif Sand
