She is strong enough to give birth, brave enough to break stereotypes, and smart enough to lead revolutions - yet society still romanticizes her as "frail". Frailty thy name is women is a famous line from William Shakespeare's play Hamlet.

Prince Hamlet says this line when his father, king of Denmark, dies, and his mother marries his Hamlet's uncle. The prince considers his mother as emotionally and morally weak. However, women are neither ~~frail~~ frail in reality nor Shakespeare calls them weak. Women are equally capable as men. They have even surpassed men in various fields. Women have played pivotal role in politics, economy, sports, science and technology, and medicine. Certain cultural norms and religious stereotypes emboldened this misconception. Besides this, religious illiteracy also contributes to this fabricated norm. However, this misconception



can be countered through global awareness about women rights. Hence, women are not frail. They are equally strong, capable, and intellectual as men.

Firstly, there are various factors in history and contemporary times that blend together and fabricate the concept of women as weaker as compared to men. Historically, women have played subjective role like cooking, cleaning, caring, nursing and obeying <sup>the men</sup>. The patriarchy and cultural norms place women as lesser creation of god. They were devoid of right ~~of~~ <sup>to</sup> vote, right to education, and even right to lead in any decision-making. Along with patriarchy, feudalism also suppressed women's rights and freedom. Women have faced these oppressions and challenges, and they have fought against patriarchal dominance. But still certain factors persist that subjugate women in the society. These traditional norms that are socially-constructed contribute to women's frailty.

Another reason that emboldens the misconception of frailty and women is illiteracy. Lack of awareness and illiteracy push the nations far behind as compared to that of ~~education~~ educated ones. Today, developed countries with high literacy rates ensure women's rights and empowers them. But illiterate nations lag behind. Along with illiteracy, religious scholars and clergyman misinterpret the religion and declare women as weak. ~~and~~ they exploit ~~the~~ religious teachings and



use them for their personal polarized interests against women. One such example is recent statement from Jamat-i-Islami leader who said that women either belongs to home or grave. These kinds of extremist statements oppress women's freedom and contribution for the betterment of any nation.

The contributions of women in politics and global leadership is widely apparent. Myriad of examples exists in the world where women's role is substantial in politics.

Some examples include: Angela Merkel (former chancellor of Germany), Sonia Gandhi (served as president of Indian National Congress with longest tenure), Margaret Thatcher (former Prime Minister of United Kingdom), Hillary Clinton (United States Secretary of State). These are worldwide examples that counter the misconception of women as weaker creatures than men. Women have also served in Pakistan<sup>in politics</sup> and broke stereotypes of male-dominated society.

These include Fatima Jinnah who stood side by side with Quaid-i-Azam, and she showed political activism when she stood against Ayub Khan during presidential elections. Another monumental personality is Begum Rana Liaquat Ali Khan who worked for women rights, and participated in Pakistan movement as well. Benazir Bhutto became first women Prime Minister of



democratic states. Recent example of Maryam Nawaz is also a prominent ~~argument~~ personality. She is the first female chief minister of <sup>the</sup> province. She leads hearts of the nation with her efforts for public welfare and her charismatic personality. Hence, women are fabricated as frail but in reality they are not.

Alongwith politics, women <sup>surpassed</sup> ~~lead~~ men in science and technology. They bring inclusivity, innovations, and significant inventions. If women are educated and empowered, they can dominate ~~lead~~ the world of technology. Despite hindrances of male-dominated society, several examples of power-<sup>ful women</sup> exist. For instance, the names of Marie Curie and Peire Curie are unforgettable. They discovered radioactivity that gave a new age to physics and Chemistry. Another example is Dr Sara Qureshi, the first female aerospace engineer in Pakistan. She is formally working on a plan to reduce negative impacts of air carriers on stratosphere to reduce global warming. Similarly, Aqsa Karim became a sensation and youngest Microsoft certified professional in 2004. <sup>Also</sup> Caroline Herschel, a famous astronomist who discovered several comets. These prominent examples reject the notion of frailty as women. In history, almost seventeen women have received nobel prize in physics, Chemistry, medicine and Philosophy. Hence, women have equal intellectual capability as men and frailty is not name of women.



Additionally, women participate in economic progress and resilience. They play different roles <sup>for</sup> behind economic development of a nation. As the great leader Quaid-i-Azam Muhammad Ali Jinnah said, "No nation can rise the height of glory unless their women are side by side with them". They serve as gynaecologist, nurses, dermatologist, physicians and lead these specialities. One historical example is of Dr Ruth Pfau who worked diligently and served Pakistan. She established almost 157 clinics across Pakistan and worked against Leprosy. Due to her immense dedication, WHO declared Pakistan as Leprosy-controlled in 1996. Women are serving across the country as residents, consultants, and heads of departments. This reflects their dedication, strength and resilience. It proves their intellectual capacity and counter the fabrication of women as frail beings.

The above contributions of women prove their strength and capabilities. However, the misconception of women as frail part of society can be countered through some steps. Firstly, the states should pass certain laws to



1) ensure women's rights and freedom. Those who violate these laws should be persecuted strictly. In this way, women will feel safer. Along with legal safety, the government should provide education to the public. Education is an important factor for widespread awareness of women's rights. Many uneducated men consider women as lower creations and treat them unjustly. Women are also unaware of their rights of freedom and speech, and they consider oppressed men as their fate.
