18TH AMENDMENT IN THE CONSTITUTION OF PAKISTAN AND POLITICAL DEVOLUTION

4.1) Key Provisions Of The 18th Amendment that Provide Political Devolution

(i) 18th amendment ensures fiscal provincial autonomy; The 7th NFC National Finance Commission Award (2010), as is linked with 18th amendment, enhanced the provincial share in the federal revenues. Thus 18th amendment provides significant fiscal provincial autonomy.

7th NFC Award allocates federal revenues to provinces on the basis of

(ii) 18th amendment increased provincial representation; 18th amendment enhanced the provincial representation in the legislature and decision-making bodies.

(iii) Abolition of Concurrent Legislative list by 18th amendment led to exclusive powers of provinces in certain matters; 18th amendment abolished concurrent legislative list. This resulted in providing provinces exclusive jurisdiction of legislature and policy-making on matters such as education, health, local government, and many more.

Persistent Challenges In The Manifestation Of 18th Amendment

(i) Fiscal Centralization; Despite the fact that the 7th NFC Award has increased the fiscal share of the provinces, the federal government has not provided appropriate resources to the provinces

(ii) Inadequate Administrative and Functional autonomy; The administrative powers of provinces such as education as given by 18th amendment has been interfered by the center several times.

(iii) Weak Local Government System; The provincial governments are reluctant of transferring the legal powers to the local government levels is the challenge to 18th amendment as well.

(iv) Inter provincial coordination challenges; The persistent and continuous conflicts
