The freedom of high seas is a fundamental principle of international law that ensures equal access and non-sovereignty over the parts of the ocean that lie beyond any national jurisdiction. According to Article 87(1) of UNCLOS high seas are open to everyone but for peaceful purposes. However, there are some restrictions on the freedom of the high seas under

International law such as prohibition of piracy, ban on slave trade, duty to protect the marine environment e.t.c. Further, there is another freedom of the highseas called hot pursuit, it allows some rights to coastal state.

2. The meaning of "freedom of high seas"

Freedom of the high seas refers to the right of all states to use the high seas for peaceful purposes, beyond the limits of any state's territorial sea, beyond 12 nautical miles from the baseline.

States must use high seas for peaceful purposes. There is restriction of doing military activities that threaten other states may violate this obligation.

UNCLOS, Article 88

→ (b) Piracy is ban on high seas and collaboration is crucial for oppressing sea pirates

Piracy is prohibited in high seas strictly. All states are required to show cooperation in the repression of piracy. Further, any state can arrest ship of pirate on high seas.

UNCLOS, Article: 100, 107

3 (c) All States shall suppress the trade of slave

It is obligatory to combat slavery at sea. Transport of slaves is crime no matter if ship is sailing under flag. Any slave reaching a ship automatically becomes free *Ipso facto*.

UNCLOS, Article, 99

3(d) Demaging marine environment and Sea life is prohibited

It is obligatory on all states to protect marine life and environment regardless of their jurisdiction. Further, it is duty of states, to take necessary measures to control and prevent all kinds of pollution from any source.

UNCLOS, Article, 192, 194

3(e) A Ship cannot fly in high Seas without flag

It is necessary for a ship to fly with flag of state.

Further, there are exceptions in which a ship can fly with U.N. flag. Moreover, a ship without flag is considered as piracy.

UNCLOS, Article, 91 to 94

3(f) Drug trafficking is prohibited on high seas

Drug trafficking is prohibited on high seas and all states cooperation is required to suppress trafficking.

A ship carrying drugs is subject to interdiction by its flag state or a suspect foreign-flagged vessel is can be inspected through flag-state's request.

3(g) A vessel shall rescue person in danger except if it endangers its own safety

It is necessary for every flying vessel to provide assistance to any person found in dangerous situation in sea. No matter if he is of any nationality, or ^{any} situation, until if do not endanger ships own safety.

4. Right of Hot Pursuit:

A critical enforcement power for a coastal States

Definition=

Hot pursuit is unique exception of international law that allows a coastal state to arrest, chase, and intercept a foreign vessel that violates its law within its maritime zones, even into international waters if necessary and chase must be uninterrupted.

Legal basis of hot pursuit

It is described in Article 111 of the UNCLOS.

4(a) The right of hot pursuit is permissible only under specific conditions

When a foreign vessel violates laws in the state's territorial sea, Exclusive Economic Zone and pursuit begins while the violating ship is still in coastal water.

Requirements for hot pursuit under international law

The pursuing vessel must give a signal like visual or auditory to stop suspect ship before leaving territorial waters. The chase must be uninterrupted if the pursuing vessel stops, the right ends.

4(c) Hot pursuit may only be conducted in specific maritime zones

The pursuit may continue into territorial sea to international water until interception. Pursuit must stop when vessel enters its own territorial waters or ~~third countries~~ state's waters.

4(d) The exercise of hot pursuit is illegal on certain grounds

If the vessel does not violate laws of coastal state. and If the chase is delayed or broken and finally using deadly violence without justification is wrong.
