

Realistically, the opponents' stances lack reality. Violation of human rights even exists in the presence of peace keeping missions. Also, human rights legal frameworks exist but lack implementation. Therefore, international bodies are failing to protect human rights around the globe.

Human rights have been considered the first objective of international bodies. International organizations such as UN, OIC and EU have established legal frameworks so as to protect human rights. The United Nations' Universal Declaration of Human Rights (UDHR) emphasizes the states to

to ensure human rights. Nation states violating human rights internally or externally are subject to Sanctions under international law. Although, International bodies lack the ability to hold accountable the violators. In short, International bodies regulate universal human rights.

to weak enforcement mechanism. International bodies such as the United Nations Security Council fails proper implementation of its resolutions. It depends upon the commitment of member states. In 2024, the United Nations Security Council (UNSC) passed resolution to implement ceasefire in Gaza. The resolution aimed to allow aids, protect civilians and establish peace. but the council failed to implement the resolution. Thus, international bodies are failing to protect human rights due to weak enforcement of mechanism.

Similarly, international bodies fail to prevent genocides. International bodies such as International Court of Justice (ICJ) and International Criminal Court (ICC) fail to prevent series of genocides. For example, Rwanda, Bosnia and genocide in Gaza have not been prevented by the international bodies. The genocidal wars killed millions of people in the 21st century. International bodies failed not only to prevent genocides but ~~also~~ ^{Avoid repetition of expression} failed to hold accountable the war criminals. Thus, international bodies are failing to prevent genocides.

Moreover, selective punishment of the nations are pushing international bodies into failure. International organizations lack capability to punish every state effectively for the violation of international laws. For example, International Court of Justice (ICJ) and International Criminal Court (ICC) have never arrested war criminals from the powerful nations. Russian and Israeli leaders have been accused for war crimes. The international bodies fail to hold accountable giant states. Thus, selective punishment of the nations fail the international bodies to uphold human rights.

Additionally, major states' influence on international bodies contribute to the failure of international organizations. Major states such as USA, China, France, Britain and Russia have a lot of influence on international bodies. These states use veto power for national interests rather than protecting universal human rights. Veto power are siding the human right for national objectives. For instance, J. John Mearnsheimer ascribed in his book "Israeli Lobby and U.S. Foreign Policy" that USA used 70 vetos to block resolutions on Palestine. Therefore, major states influence on international bodies failing the international organizations aim.

Furthermore, international bodies fail to provide humanitarian assistance. International aid organizations have been facing enormous failures to assist the civilians in war zones. According to

International Crisis Group (ICG) Gaza is being

declared a death zone where individuals are facing starvation, health crisis and risks to death. International humanitarian aid organizations are failing to provide aids to Gazans. International bodies are under the control of power politics. Thus, humanitarian crisis is the sign of failure of international bodies.

Moreover, refugee crisis is the consequence of international bodies' failure. People have been forcefully displaced from homes. According to UNRWA Israel has forcefully displaced 2.4 million population of Gaza at least three times. Consequently, in 2024, Gaza has experienced enormous refugee crisis. Even forced displacement is a war crime under international law. The international organizations such as International Court of Justice (ICJ) and International Criminal Court (ICC) failed to prevent the refugee crisis. Thus, international bodies are failing to prevent refugee crisis.

Unstoppable gender based violence is the sign of international organizations' failure. Despite legal frameworks and laws for the protection of humans, the violence is unstoppable. According to Global Human Development Index Report (GHDIR) Sudan crisis resulted in gender based violence such as rape and torture as weapons of war.
