"In Pakistan, 63% of the population is under 30, making it one of the largest countries in the world."

In the aforementioned statistics, a researcher, Muhammad Farooq, depicted in his study 'Consequence of youth bulge in Pakistan' that Pakistan possesses a significant number of youth people, which directly or indirectly affects the country. He explained that youth are extremely affected by political and economic instability. Statistics provide a grim picture of how this youth bulge comes with a downside in a country like Pakistan where youth unemployment rate stood at 8.5%, one of the highest in the region. As a result, this proves to be fatal for the country as youth indulge themselves in terrorist organizations in order to fulfil their bellies. The state of involving in the organization possesses a significant and expanding threat to society and the government. How is it possible to consider youth as an

asset when their potential remain untapped? Are young people not leaving the country due to unemployment? How can we say that youth is an asset when the ratio of contribution is less than 10%? Although Pakistan has great potential in the form of youth bulge, high unemployment and underemployment, education crisis, brain drain, and social unrest and extremism clearly indicate that the country's youth bulge is a liability.

In order to understand how Pakistan's youth bulge is a liability, it is important to contextualize the term youth bulge. The term "Youth bulge" refers to a population in which the proportion of youth people is much higher than other, older age group. It is the age range to 15-29 years old. (Imai et al, 2008)

This phenomenon occurs due to high birth rates and declining infant mortality, which eventually enhance the ratio of youth population. While youth

people are considered to be drivers of economic growth and progress, they can also possess a significant and expanding threat to the country when there is lack of employment, stability and opportunities. Thus, it is safe to assume that youth bulge can be a positive and a negative factor if they are not tackled cautiously and sensibly.

Some people argue that youth bulge is an asset. The most striking evidence of this is global workforce and remittance. The global workforce refers to the total number of employed and employable individuals worldwide. A key aspect of this movement is remittance, the money sent by migrant workers to their home countries, which significantly impacts economic growth and poverty. For example, in January 2025, Pakistan received \$3 billion in remittance from overseas workers. These remittances play a vital role for growth and

According to the International Labour Organization (ILO) 2024, the youth unemployment rate stands at around 11%. This indicates that a major portion of the young population struggles to find stable jobs. Many educated graduates remain jobless due to a mismatch between their skills and market demand. Without adequate opportunities of employment, frustrated young people may turn to crime, illegal activities, and migration. Hence, it shows that the country's youth bulge is a liability due to high ratio of unemployment.

Like unemployment and under employment, education crisis is another aspect of a liability. Pakistan faces a severe education crisis, which limits the potential of its youth and hinders economic growth.

Apart from this, brain drain is another factor which indicates that Pakistan's youth bulge is a liability.

Due to lack of opportunities, our youth is leaving Pakistan in great number. For example, in the first

half of 2023 alone, an unprecedented 800,000 Pakistani left the country, with significant portion comprising doctors,

In addition to this, Pakistan's youth bulge, if not utilized properly, it will lead to social unrest and extremism. When the large portion of youth is unemployed, they become frustrated which leads them in criminal activities and violence in order to fulfill their bellies. Not only this, but they can also indulge themselves in terrorist organizations and radical ideologies which pose a significant and expanding threat to the communities and the government.

Furthermore, the country's youth bulge is a liability due to increased dependency ratio. The youth seem to be burdened on economy when they are jobless and skillless. If youth remain unemployed, fewer people contribute to the economy. This places an economic burden on families and reduces overall productivity. Unemployed youth contribute little to national income while increasing demand for education, healthcare, and social services. If this continues, the country will suffer a lot. Therefore, it is not wrong to say that the youth of Pakistan is a liability due to excessive dependency on fewer people.

Moreover, Pakistan's growing youth bulge is placing immense pressure on infrastructure and resources, leading to economic and social challenges. The rapid increase in population has overwhelmed

~~Not only this, but also gender disparity and limited female participation is another sign of liability which proves that youth is considered as~~ burden. Among 63% of the young people, half of them are girls. In Pakistan, the rights of girls, such as education, healthcare, and workforce, are being denied. Due to societal norms and customs, gender discrimination and limited female participation are often seen in the country. For example, Ishaat Hussain writes in his book

'Governing the Ungovernable' that women's participation remains below 25% which eventually limits national productivity. Thus, this clearly demonstrates that how the country's youth bulge is a liability.

Inadequate digital and technological skills ~~is~~ also play an important role in enhancing a liability of youth people. Due to lack of proper education and understanding of IT sectors, youth are often seen as ~~unemployment~~ unemployed. This ultimately enhances burden on the economy of the country because they are not aware of modern technology. A World Bank report shows that ~~is~~ only 8% of Pakistani youth have adequate IT skills. How opponents can consider this youth as an asset when there are only 8% who contribute in economy.
