The most important feature of Germany's political system is its Mixed-Member proportional representation. This system was adapted to make the country more politically stable. However, the current dynamics are changing. On the other hand, France political system have some similarities with Germany's political system. But they hold semi-

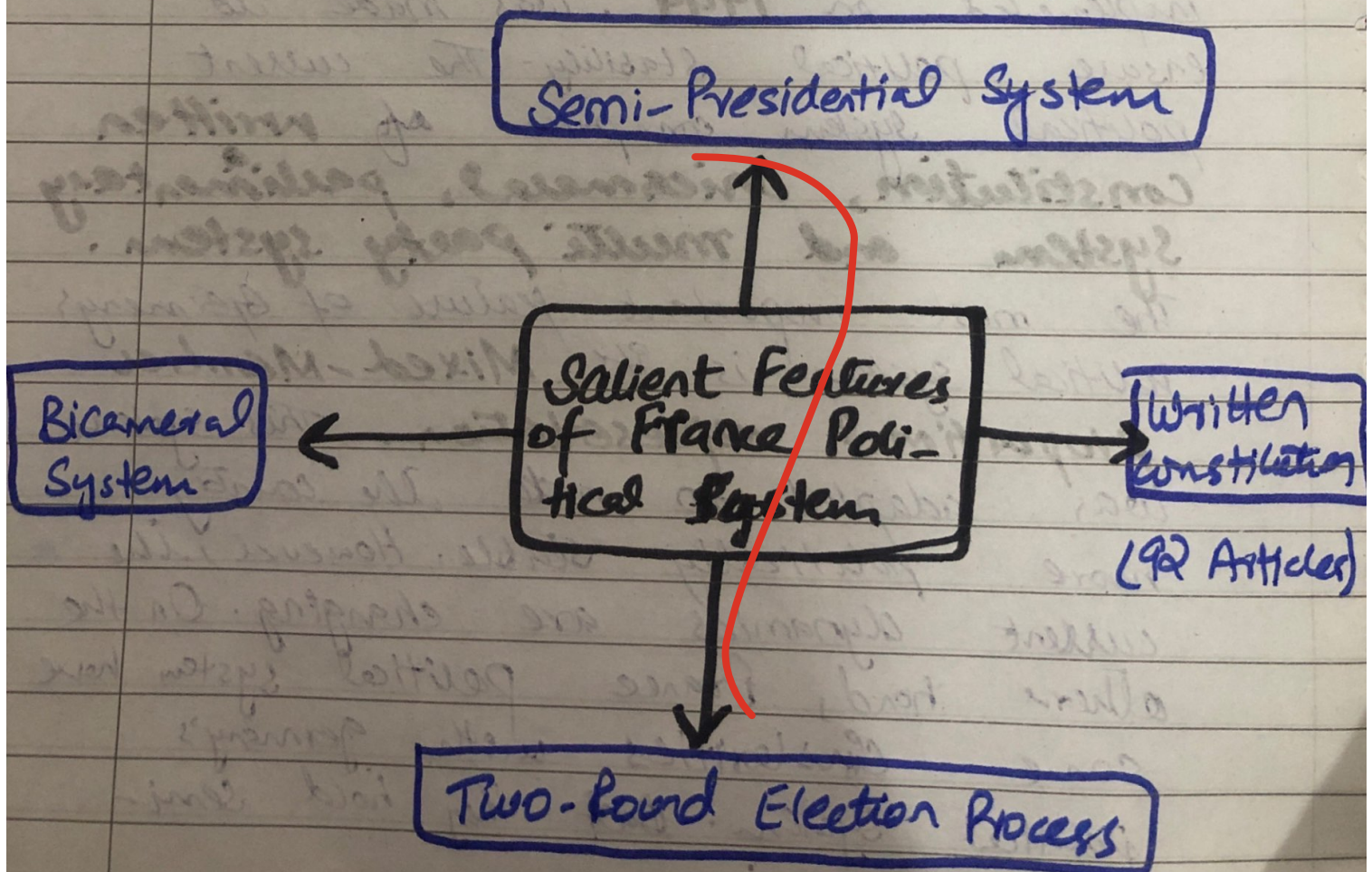
presidential system. In France, there is concept of **cohabitation** government which is proposed to make the country more stable.

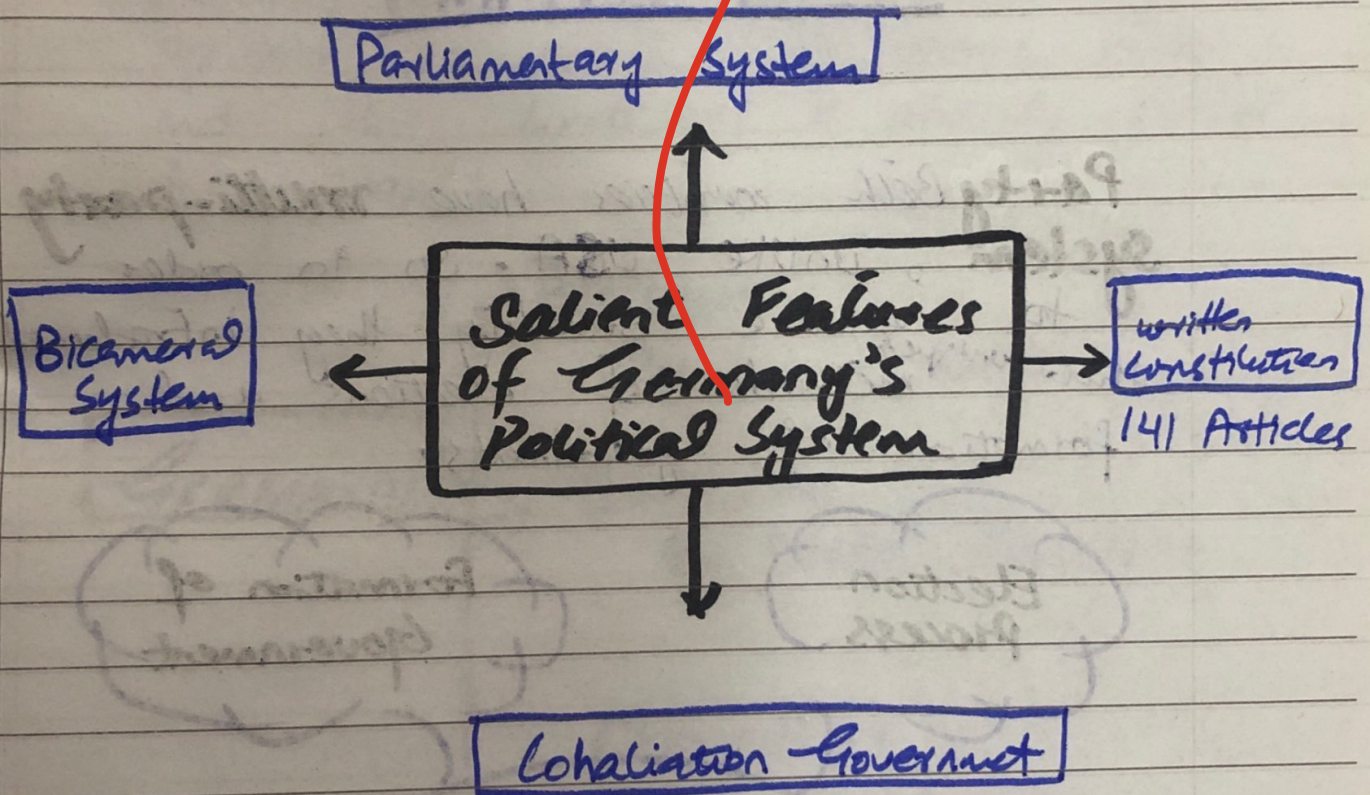

In France, President appointed Prime Minister and share power with him/her. The constitution of France is written - There are two house of France : ~~upper~~^{lower} house and Senate. Both are elected.

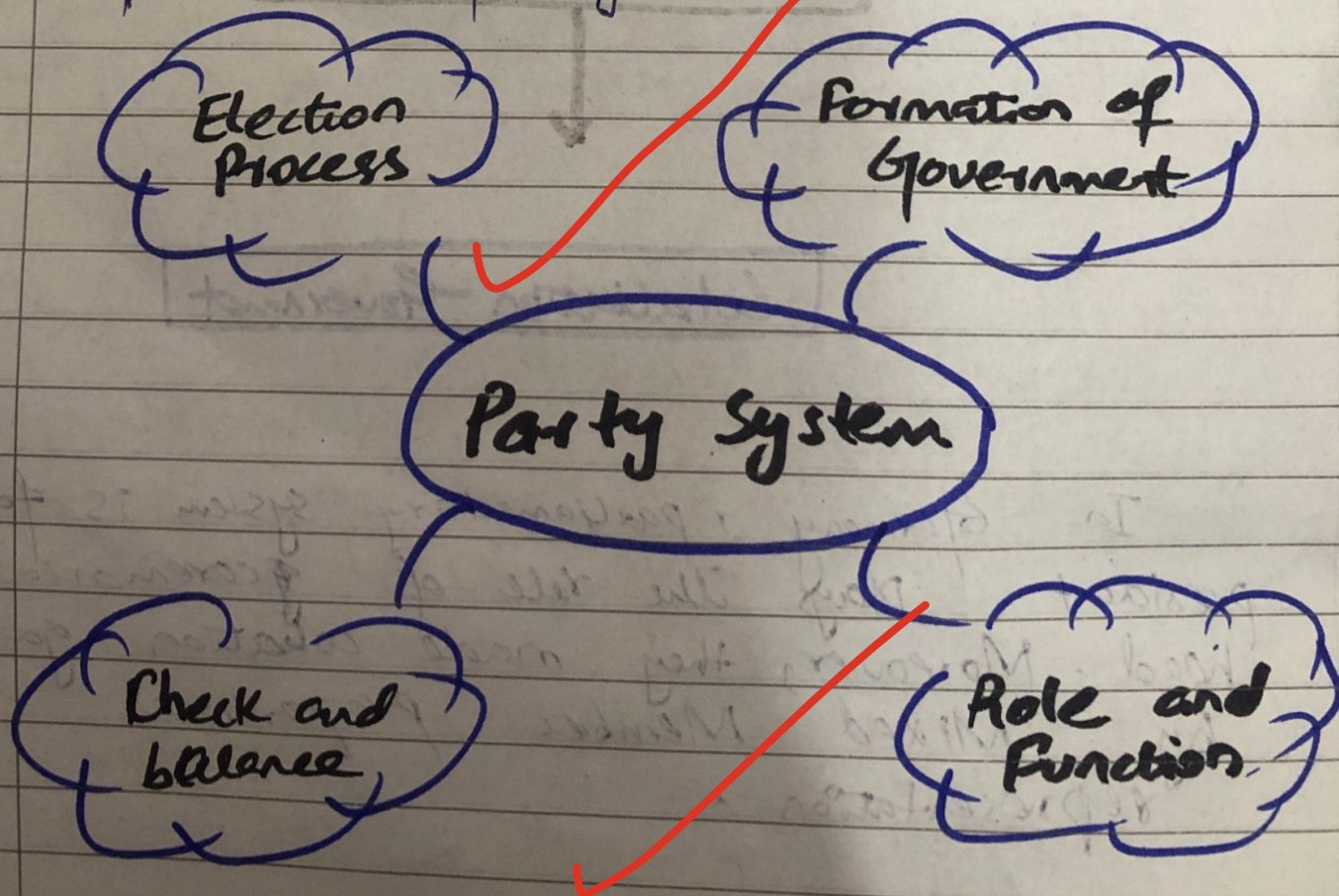


In Germany, parliamentary system is followed, president plays the role of ceremonial head. Moreover, they made coalition government by Mixed Member proportional representation.

PARTY SYSTEM OF FRANCE AND HOW IT IS DIFFERENT FROM GERMANY

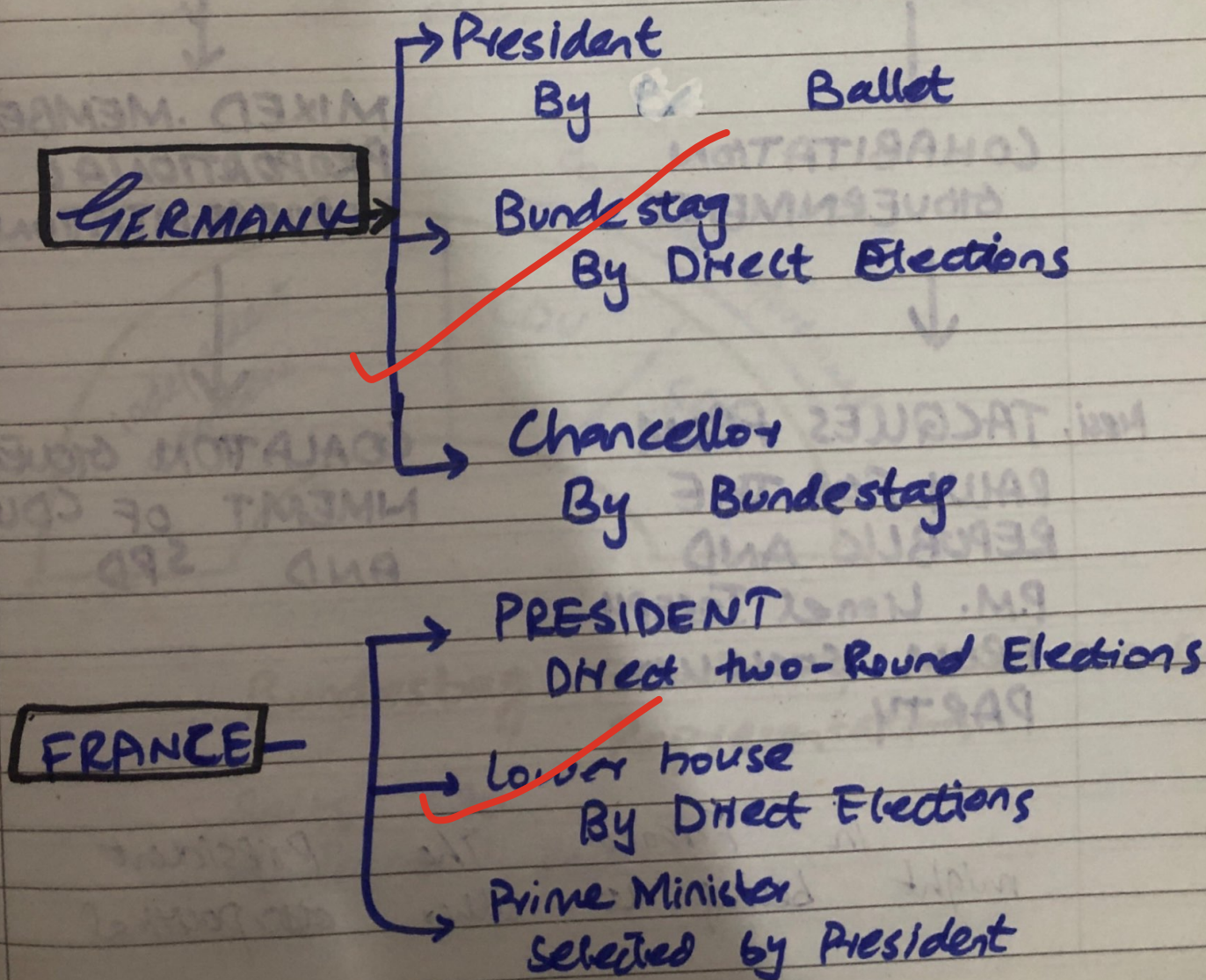
Both countries have **multi-party system**, unlike USA. So in order to ensure stability they introduced their ^{unique} methods of elections and formation of governments.

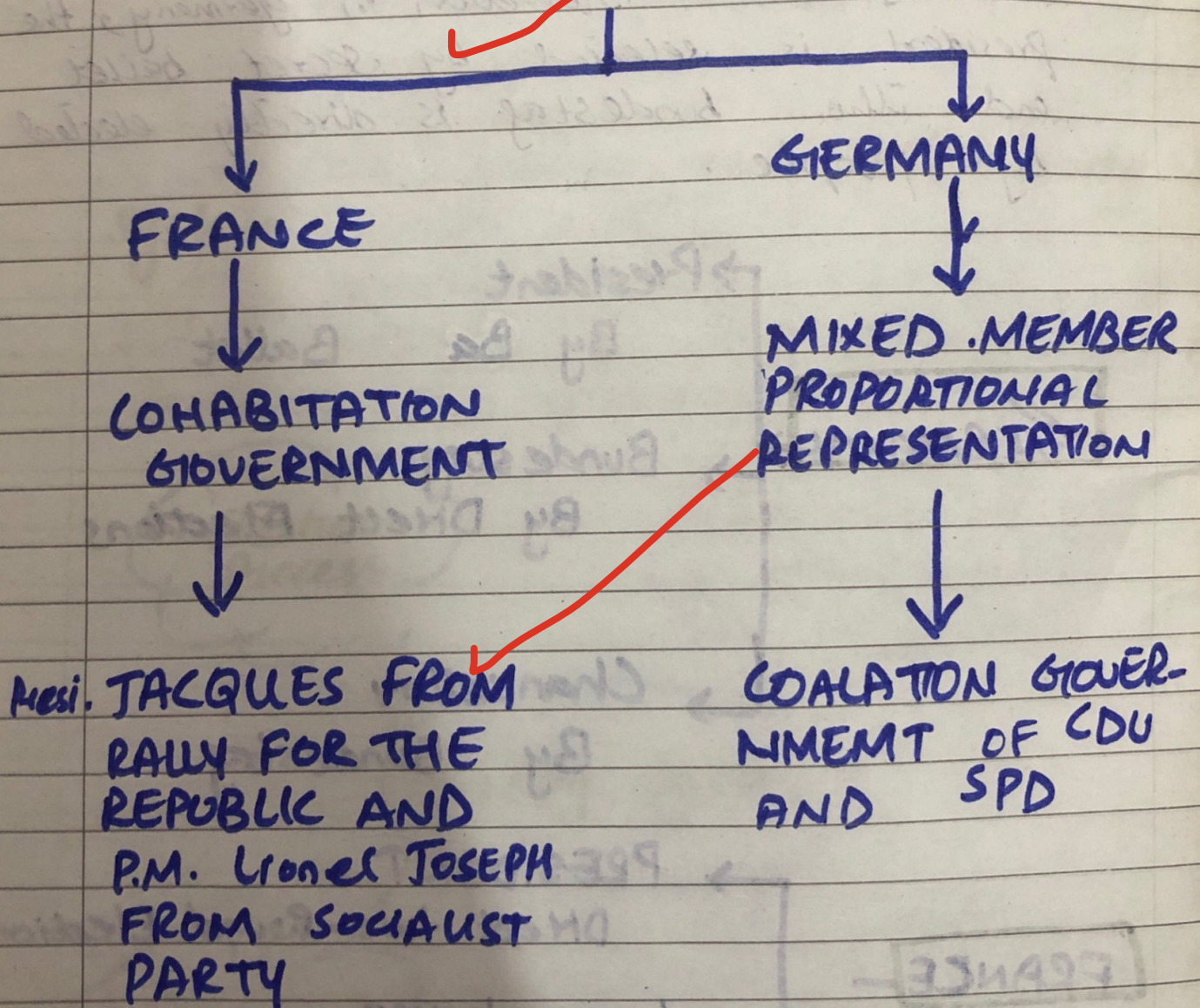
i- Election Process

In France, the members are directly elected by the people by two-round process. They become the members of lower house. The president is also elected by the elections. However, in Germany, the president is selected by secret ballot and the bundestag is directly elected by people.



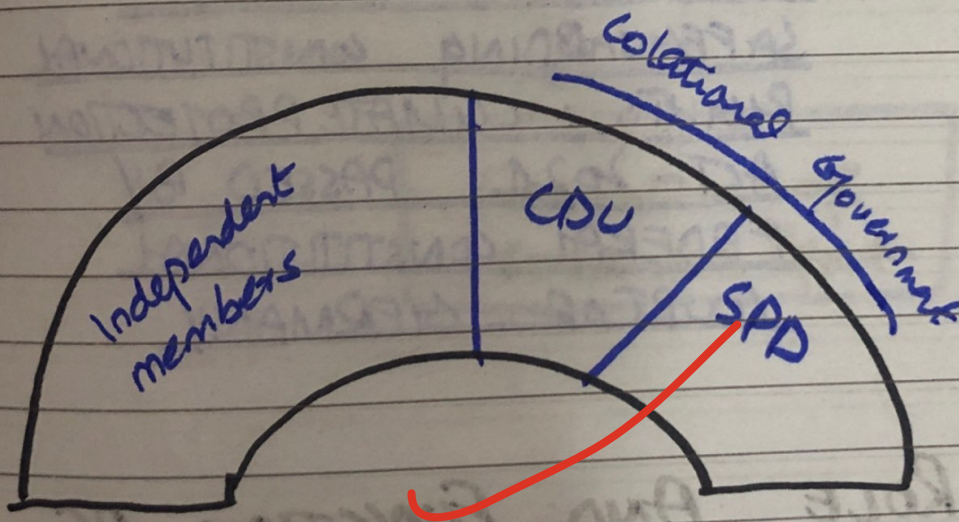
② Formation of Government:

Both countries have multi-party culture, so in order to bring political stability, they preferred to make mixed government.



In France, The President might belong to other ~~other~~ political

party and the other party might rule the lower house - As we can observe it several times. In this way, they ensure that these parties work in coordination and collaboration. Whereas in Germany, the formation of their lower house, **Bundestag**, consist of mixed members. The voters cast two votes: one for the party and other for members. The Bundestag is divided into two parts, half of the seats belong to party and other to the independent members -

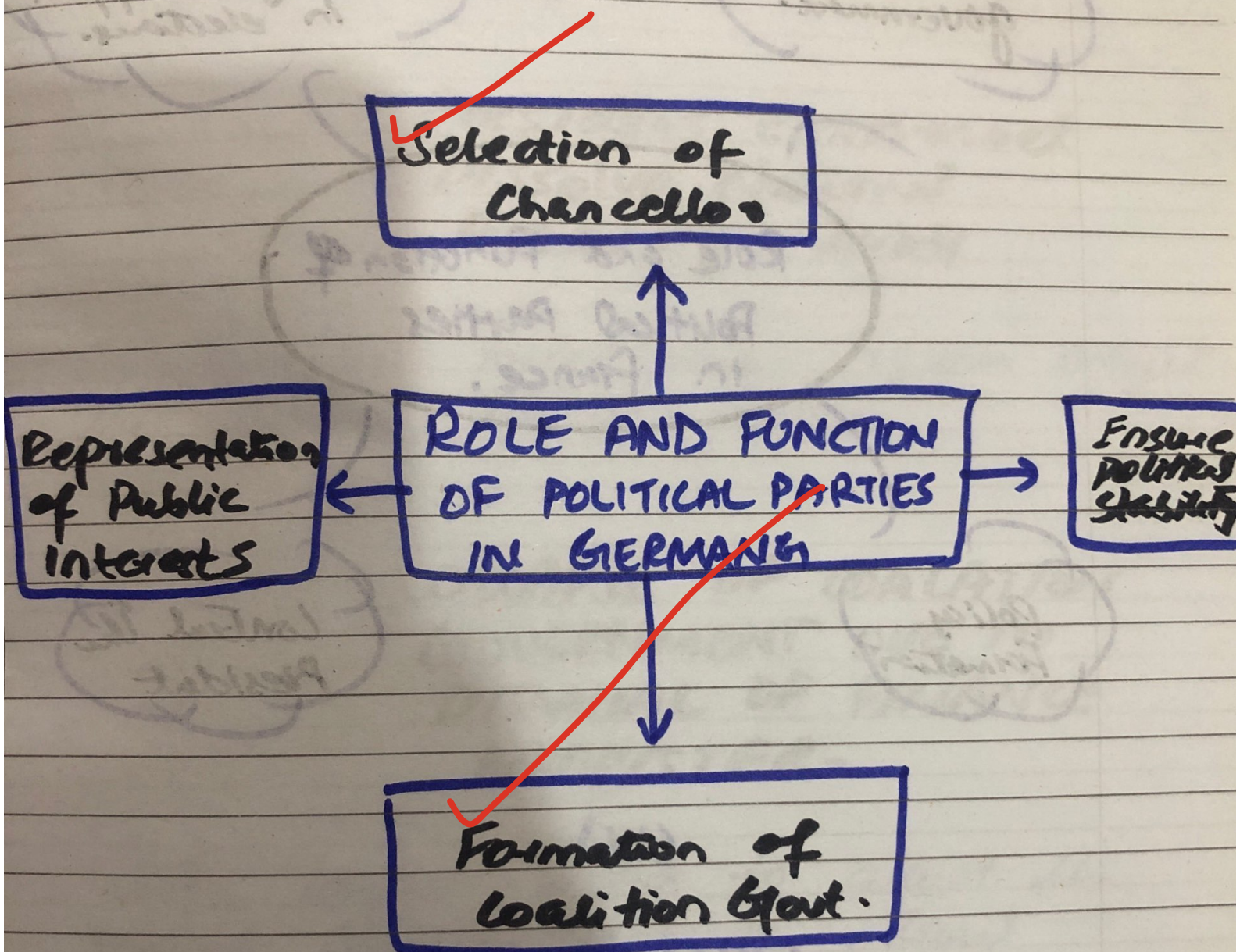
In France, the President exercise most of the powers and can dissolve the cabinet and dismissed the Prime Minister. The Judiciary check either the decisions are constitutional or not. However, in Germany, the check of judiciary is present. There are 16 judges, equally appointed by Bundestag and Bundesrat.

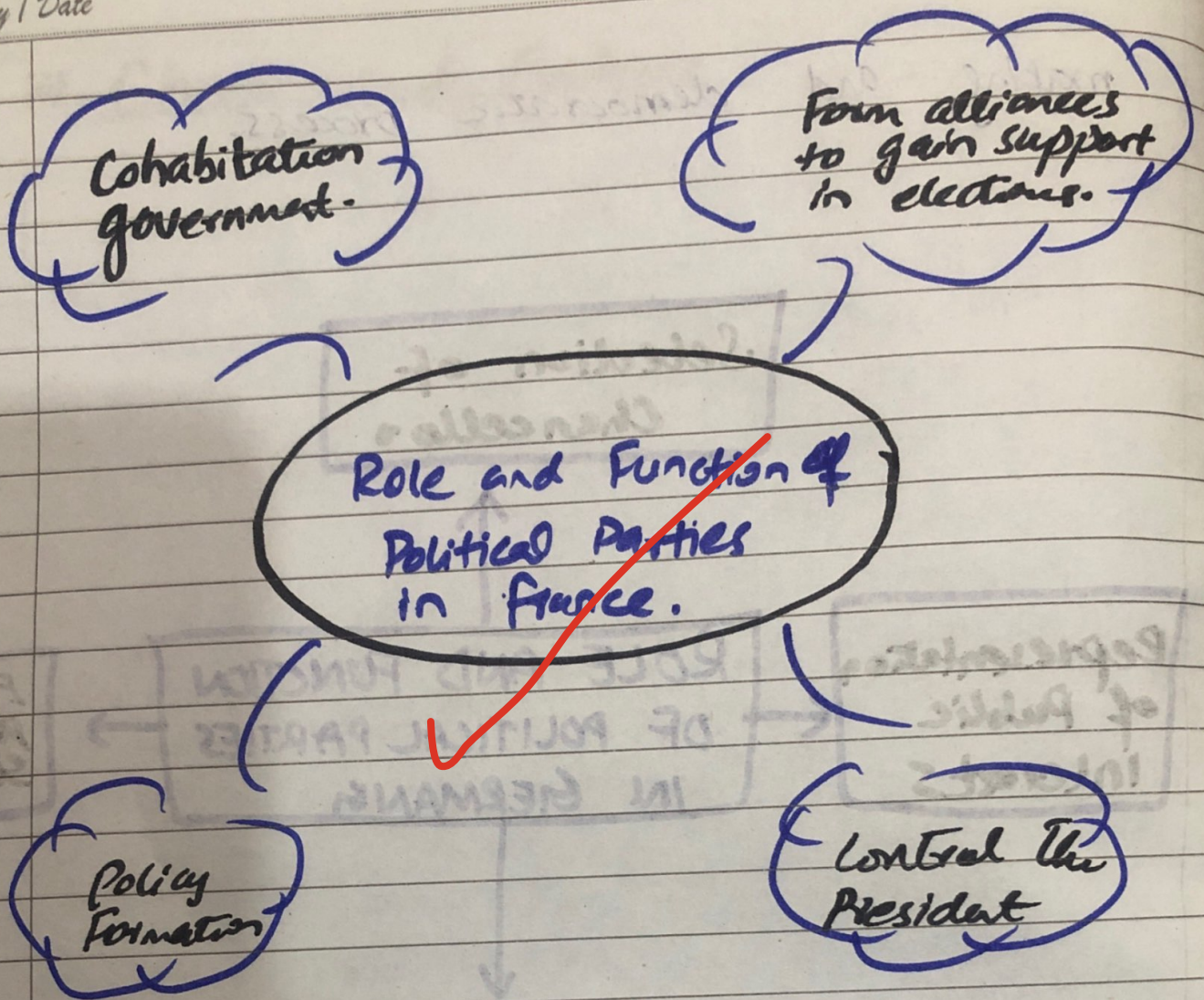
