I- Institutional constraints.

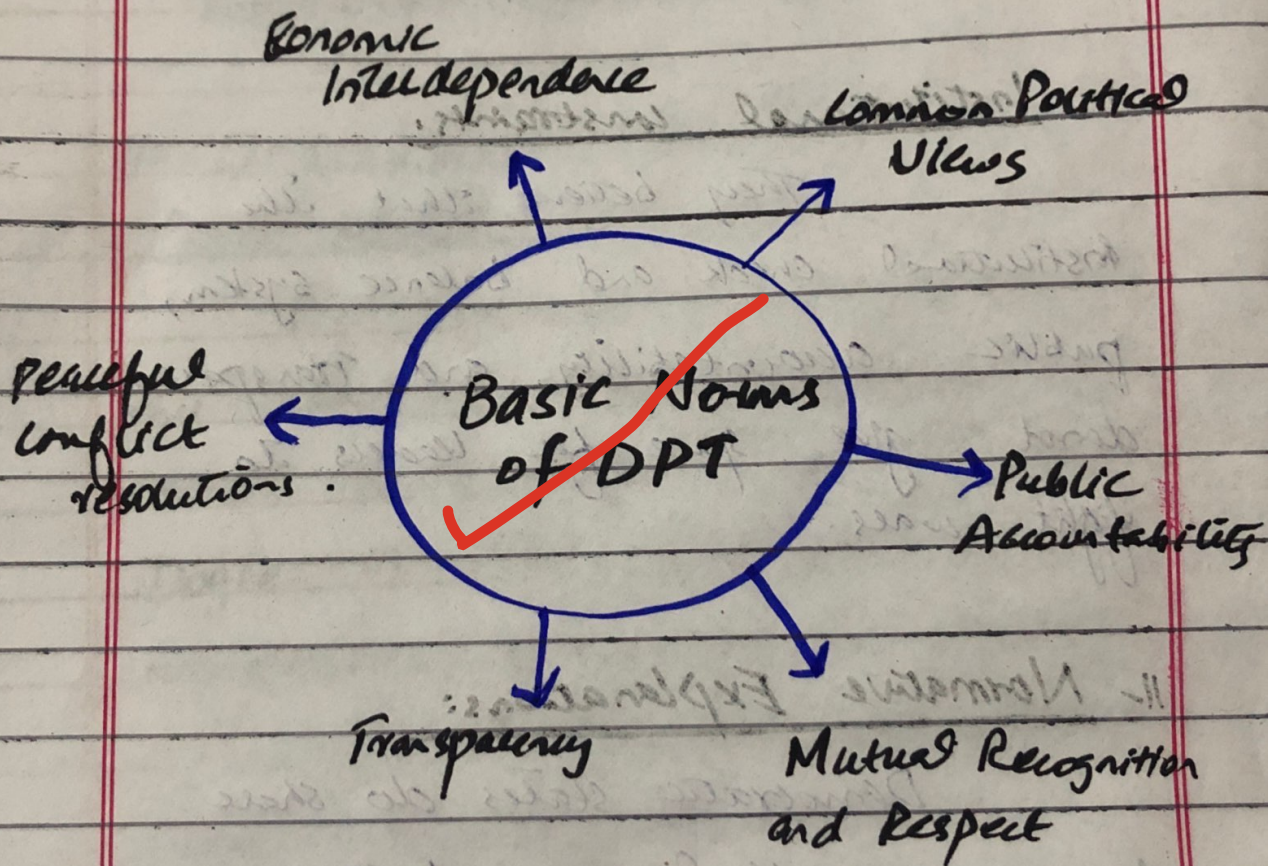
They believe that the institutional check and balance system, public accountability and transparency do not give space for leaders to fight wars.

II- Normative Explanations:

Democratic states do share common political views - Instead of relying on kinetic operations, they resolve issues through negotiations and preserve the democratic framework.

III- Basic Norms of Democratic Peace Theory (DPT) and European Union

European Union is the most successful model of Democratic Peace theory. All basic norms of this theory is aligned with EU.



a- Economic Interdependence:

EU works on the principle of Economic interdependence which was

Firstly done in 1951 through
European Coal and Steel Community.

of war.

b. Common Political Views

It is mentioned in Copenhegan
Criteria that these countries should
be democratic states. It paved the
way for negotiation and mutual
interests.

c- Public Accountability

EU ensures public accountability
by double majority ~~to~~ votes for
any decision. To practice the essence
of equality, ^{majority} the vote of both states

are required for any decision.

d. Transparency and Open debate:

EU practice the DPT in true sense. They practice transparency and one of the major example is referendum of Brexit.

f. Mutual Recognition and Respect:

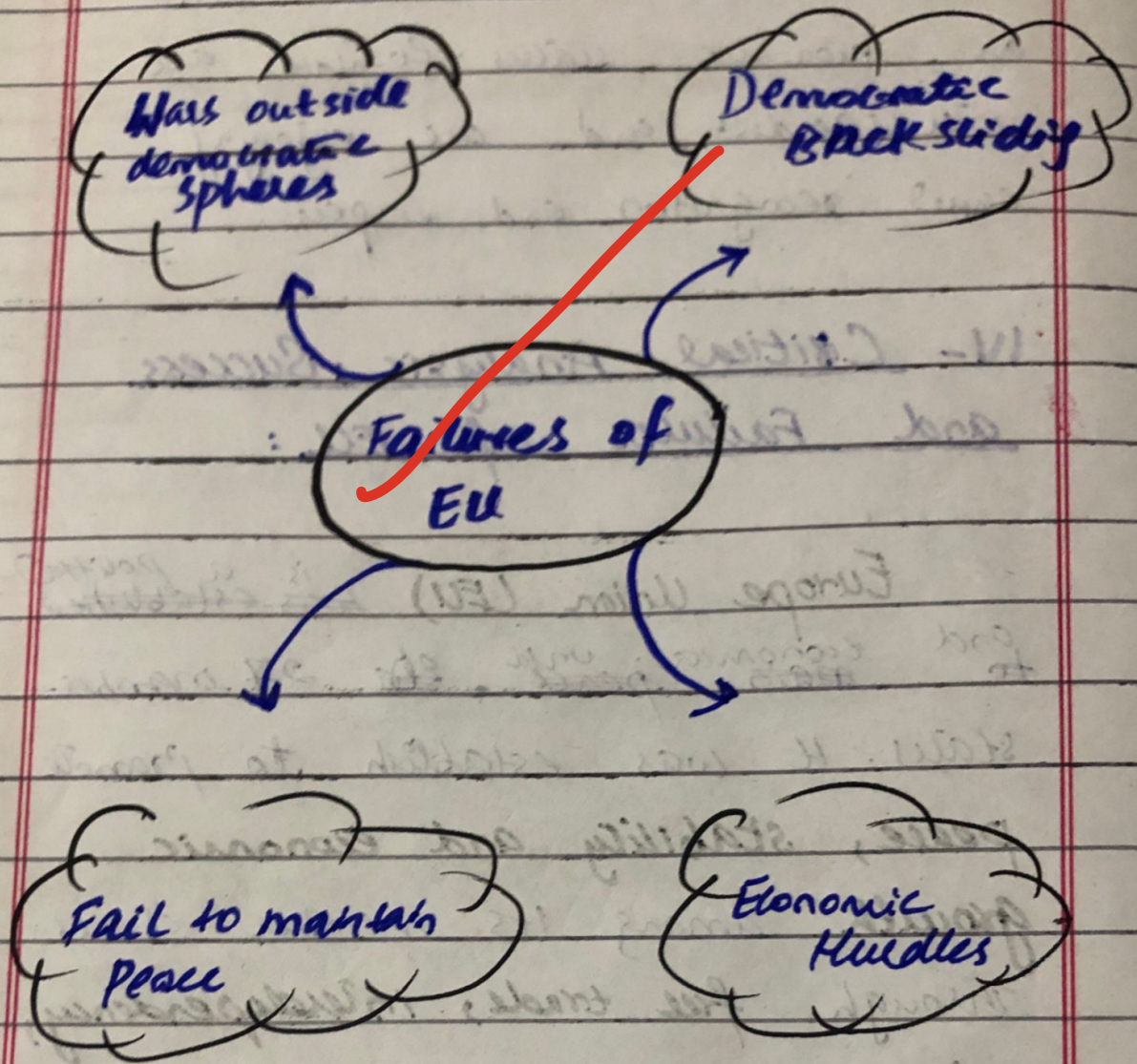
Each country has earned
