Strengthening Democratic Institutions has a directly role in bringing civilian supremacy because by bringing the leader of public choice and from common people will be better adapted to understand problems from civil lense. Civilian supremacy also limits the role of military in political interventions. For strengthening civil supremacy a legal framework which includes clarity of constitution and responsibilities of various government institutes which include proper check and balance of 3 pillars of state on each other. In democracy, the military is sub-ordinate to civilian govt and is responsible for national defence. By strengthening democratic institutions, the civilian government can effectively control the military and prevent it from becoming a political power.

It aims to create a system where civil servants are primarily focused on executing policies neutrally and efficiently rather than being swayed by political pressures or personal agendas. A depoliticized bureaucracy fosters public trust in government by demonstrating that policies are based on merit and expertise, not on political favoritism.

Public trust in government can erode when bureaucrats are perceived as being more powerful than elected officials.
