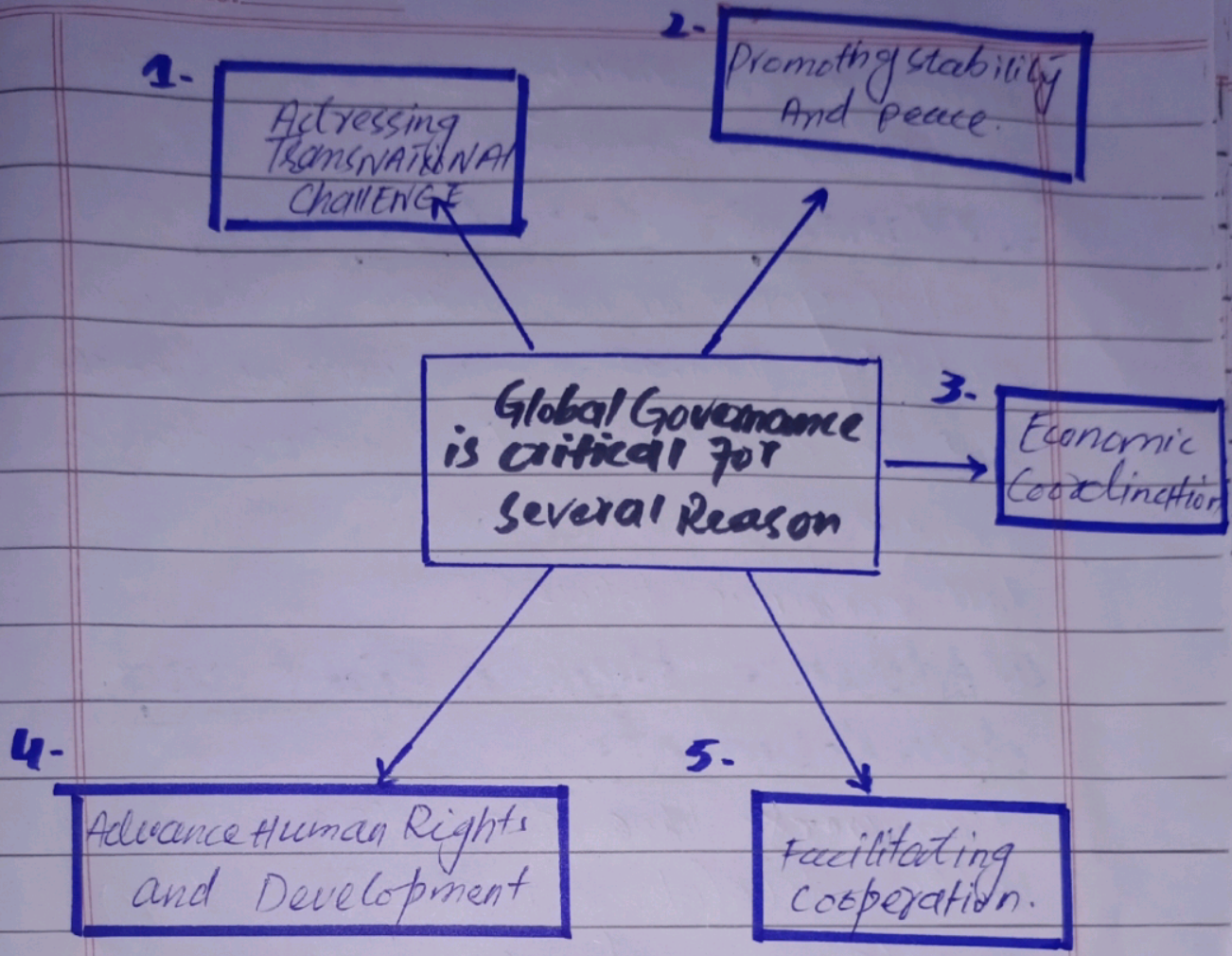

5. Migration and Security:

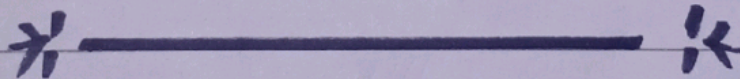
Increased migration and transnational security threats, such as terrorism or human trafficking, require cooperative frameworks to manage refugee flows and ensure global security.
