1. Introduction

Gender Studies explores how gender shapes identities, social roles, and power relations in society. It examines the intersections of gender with class, race, sexuality, and culture to understand inequality and social change. 2. Status of gender Studies in Pakistan

(i) Establishment of Center of Excellence for Gender Studies (CEWS)

To introduce the discipline in the country "Establishment of Center of Excellence for Gender Studies" was established as a project in 1989 by the ministry of women development. This project included educational development in gender studies like first M.A Gender Studies and Women Studies began in 1996 at the University of Karachi.

(ii) Ministry of Women Development (MOWD)

MOWD is committed to the overall development of women including their education. The aims and objective to enhance women's literacy rates, improve attainment level of women at all educational levels, to reduce gender gap.

(iii) National Commission On the Status of Women (NCSW)

NCSW also aims to encourage the generation of information, analysis and studies relating to women and gender issues. This institution has thus integrally related the status of women studies as a discipline and has a strong base in activism and implementation.

3. Status of Gender Studies in education

After the waves of

feminism, Some countries Successfully got their gender rights. In 1989, the Ministry of women's Development established women Studies centers in five universities initially as a five year project. These establishments such as Women's Studies Department at Allama Iqbal Open University, Women's Research and Resource Center at the Fatima jinnah Women University Rawalpindi. They work for the reorientation of existing curricula to include knowledge on women and contributions for female writers.

4- Research and publications on gender Studies in Pakistan

Research and publications on gender Studies in Pakistan work for the rights and issues on women in Society. Such as Alam-e-Niswan publish research on local gender issues. It is contributing to the body of knowledge and raising awareness. Besides, the (CEWS) at Karachi Universities also completed many major and

minor studies on socio-economic, legal, health and environment issues.

5. Professional Associations of gender Studies in Pakistan

The idea of first setting up a Pakistan women's Studies Association conceived by Sabheeha Hafeez in 1987.

The aim of this institution to provide the rights of women in policy making, programmers, and NGO's teachers. In 1992

"Pakistan women Studies Association" was

set up by the Tahira Aftab, Professor of history and Director of CEWS of Karachi University.

6. Current Status of gender Studies in Pakistan

The current status of gender studies in Pakistan in different institution and association providing knowledge and their vision in different

way. Gender Studies has moved from a five-year project to a well-established discipline offered at various national universities. And now most of the universities offering PhD programmes in Gender Studies. Moreover,

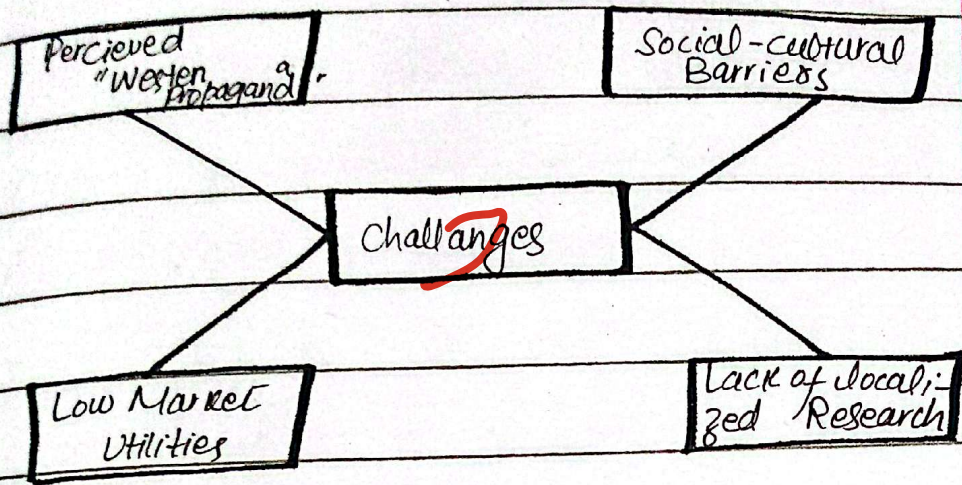
The Higher Education Commission (HEC) and government bodies have historically supported the field and also provide the gender studies subject as an optional in "civil services" exams.
