2 Causes of Forced Marriages

(i) Patriarchal and Cultural Norms:

Families often prioritize social status, property, or family honour over personal choice.

(ii) Economic Motivations

Dowry, land inheritance, and

financial settlements push families to force marriages.

iii. **Lack of Awareness and Education:**

Limited literacy especially among women reduces understanding of legal rights.

Misuse of religion to justify child marriage or forced unions.
