↳ Introduction:

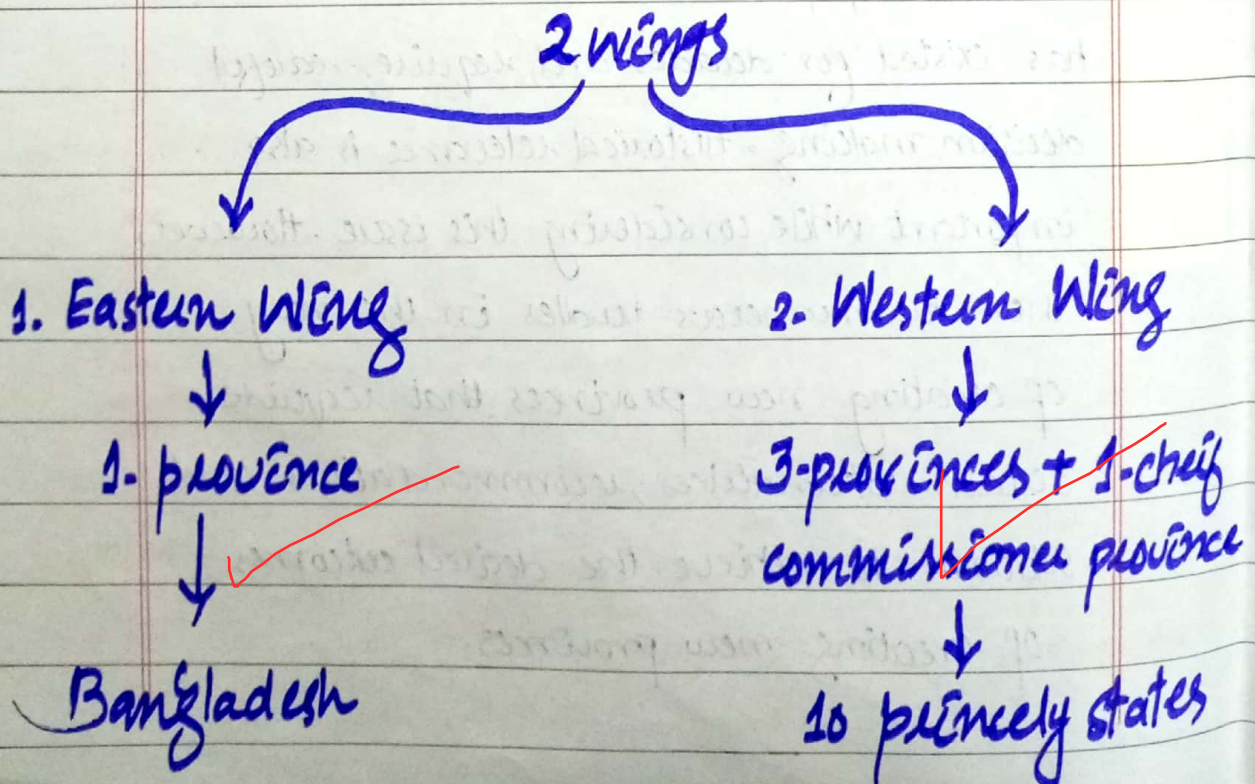

* While, Khairpur was spending 22% of its revenue on education at that time and even without constitutional safeguards.

* Pakistan even today is not spending that much on education as the education spending in approximately ~0.8% of GDP in FY2025 - FY2026.

* Khairpur worked on female literacy rate by founding Naz college and Naz High School.

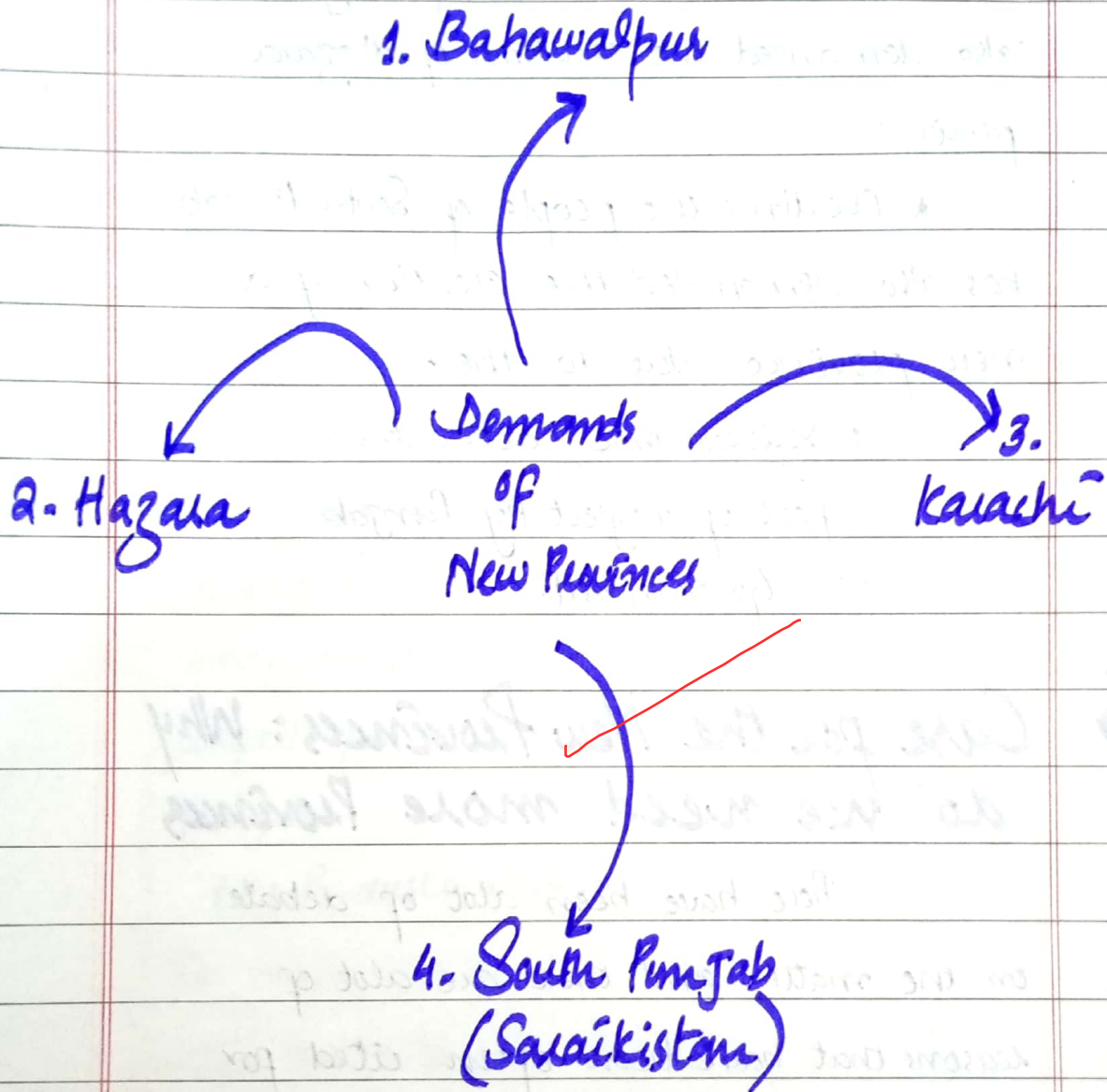
↳ Demand for the New Provinces over the course of history

* Bahawalpur was already a province before the creation of one unit formula. After the one unit formula was dissolved, the demand to establish the autonomous status of Bahawalpur was put forward.

* In Karachi and Hyderabad, urdu speaking community also demanded the creation of province

↳ Case for the New Provinces: Why do we need more Provinces

There have been a lot of debate on the matter and ✓ there are a lot of reasons that have been often cited for the need to create new provinces. Some of these reasons are given below.

(1) Large size of the existing units

The 4 provinces that exist in Pakistan today are ✓ very large in their territorial size.

It has been often quoted that even

if the Punjab were to become a separate country, it would be the 12th largest country in the world.

Therefore, this large territorial size of provinces necessitates the further division.

(2) Disparities among the existing units

(i) Income disparity: There is inequality in per capita income among various provinces. Urban centers of Punjab offers much more prospects for better income than the South Punjab.

(ii) Industrial development also varies. The major urban centers eg., Karachi have large industries that in turn creates more jobs and better income. These industries are also centered in some parts of the province, while rest of the Sindh ^{has} ~~has~~ less and even none industrial development.

(iii) Infrastructure development is also uneven across the provinces. Cities like Lahore has advance infrastructure whereas, most of the Balochistan is grappling with

poor infrastructure.

(iv) Access to quality education and healthcare facilities are also uneven across provinces and even within provinces.

These disparities and others like the availability of water for agriculture, demand for provincial autonomy, and security challenges and conflicts also necessitate the creation of new provinces.

(3) Performance of former princely states is also cited to reinforce the case of new provinces.

The state of Khairpur due to its educational vision, industrial development, and visionary leader is often quoted in arguments in favor of establishing new provinces.

(4) Smaller units have ensured good governance in the developed world.

Smaller units improve service delivery and have also established in the developed

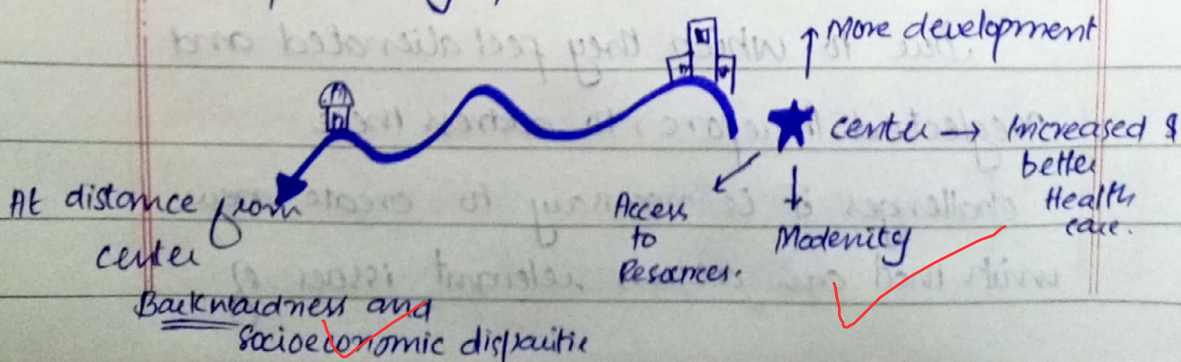

(5) Backwardness of remote areas as they are far away from the center

It is observed that as you start to move away from the center, the developments start to decrease. The more you move away the backwardness increases.

Example Rajampet is backward because it is far away from the center



(6) Inaccessibility to the seat of Government for the citizens residing in remote areas

The citizens that reside in the remote areas cannot easily access the seat of government and this also necessitates to divide the larger provinces into smaller units so that it can be brought near to the people for easy access and within their reach.

(7) Disfranchisement of people residing in remote areas

People who reside in remote areas often face

1. Socio-economic backwardness

2. lack of quality education

3. No healthcare facilities

4. lack of access to the seat of Government

Due to which they feel alienated and neglected. Therefore, to address these challenges it is necessary to create new units that can address relevant issues of

their units with urgency.

These are the reasons that are often used to build a strong case for the development of new provinces and these are genuine concerns that must be addressed effectively.

↳ Constitutional Procedure for the creation of New Provinces

It is a 2-stage Mechanism that must be fulfilled to create new provinces.

2-stages

1. Constitutional Amendment
Article - 238

If it is related to the boundaries of provinces then

2. Resolution from Provincial Assembly with 2/3rd majority
Article 239(a)

1. Constitutional Amendment

The organisation of territories in Pakistan is described by the province constitution. If the boundaries of the ~~pro~~ provinces has to change then the constitution should also be amended under the provisions of Article - 238 of constitution. ✓

2. Resolution of provincial Assemblies

And if the amendment is regarding the provincial boundaries then the province whose boundaries are to be changed:

Its provincial assembly must pass resolution with 2/3rd majority according to the provisions mentioned in Article 239 (a) of the constitution. ✓

This is the constitutional procedure for the creation of new provinces in Pakistan.

↳ Hurdles in the Creation of New provinces in Pakistan

(1) Constitutional Hurdles - Difficulty to forge political alliance or consensus necessary for the creation of new provinces

The constitutional rigidity makes it difficult to create new provinces:

a. Art - 238 ✓

b. Art - 239 (a) ✓

Achieving $2/3^{\text{rd}}$ majority is extremely difficult and it is a necessary requirement.

So, it is one of the major hurdles in creation of new provinces.

(2) Fate of existing National level agreements between the federation and provinces

There are various national agreements between the federation and provinces, like:

1. Water Apportionment Accord

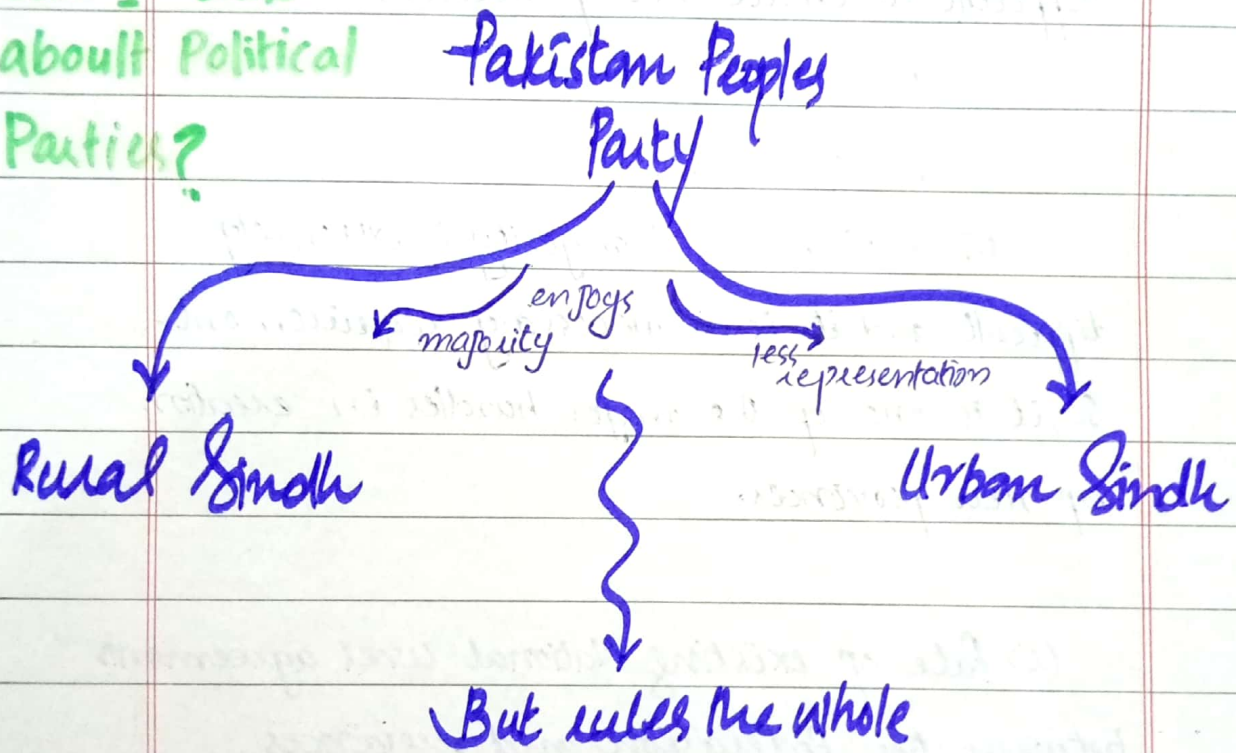
2. NFC ✓

If there are new provinces, these would become invalid and will create a number of other legal and administrative issues.

(3) Vested Political interests of certain political players also act as hurdle in the way of developing new provinces

There are many political parties that enjoy control over the whole province although their majority is centered only in one area in the province.

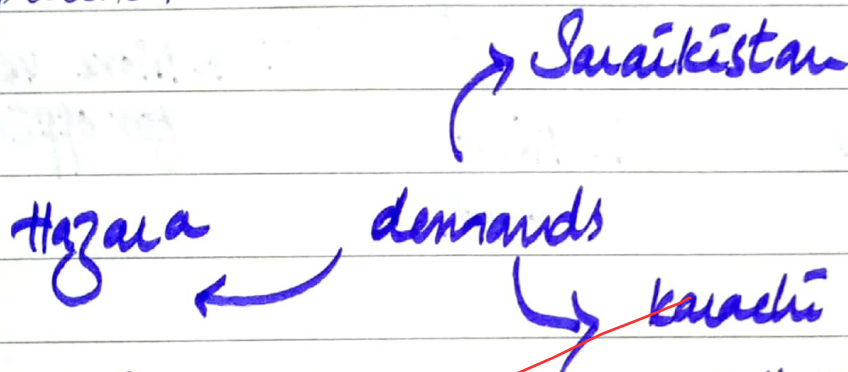

If the Karachi separates from Sindh then the Pakistan Peoples Party would find it difficult to get seat in that area due to different factors.

Therefore, the vested interests of political players is also one of the major reasons.

(4) Creation of new Provinces will open floodgates for demands for even more provinces

When just the name of NWFP was changed to Khyber Pakhtunkhwa in 2010, the different movements were started in different provinces.



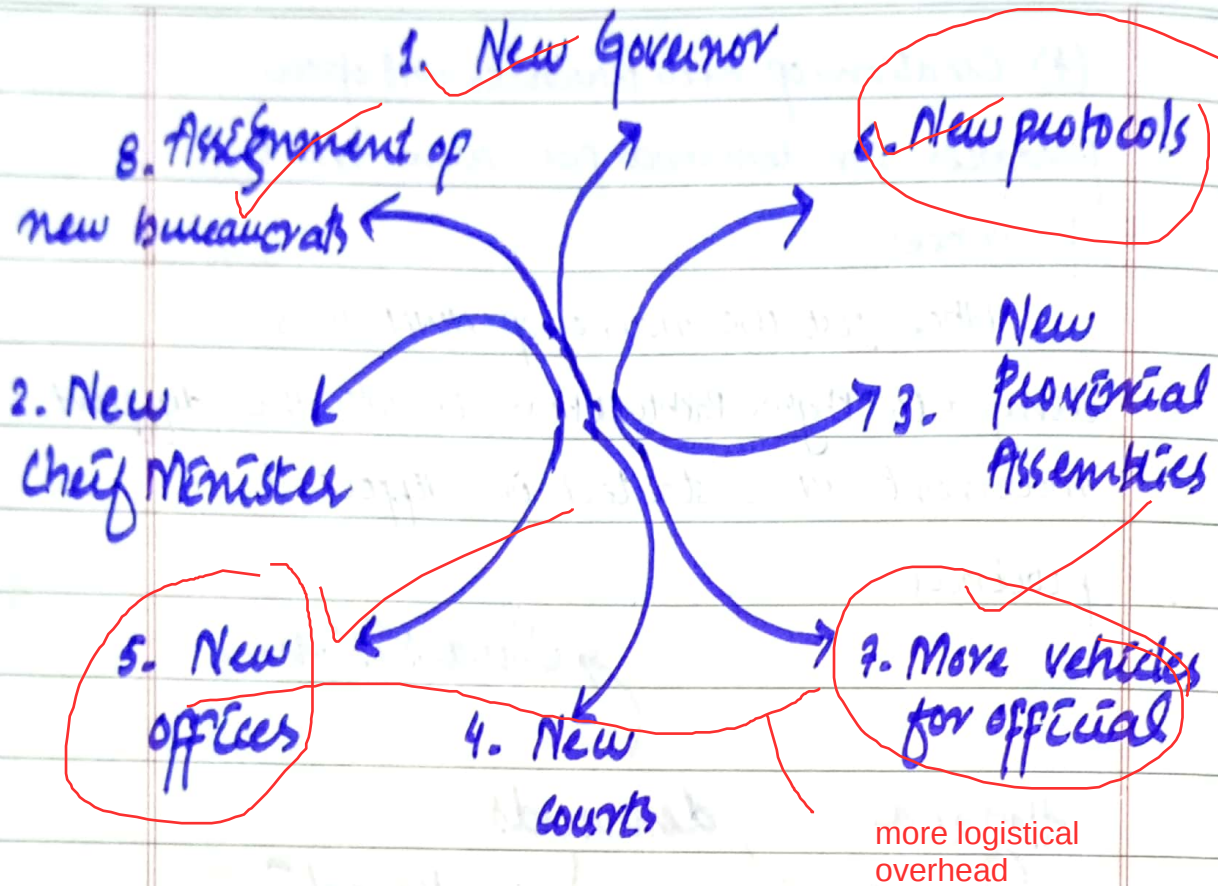
Therefore, it would become difficult to curb all the movements.

(5) Massive Increase in Public Expenditure

In 2010, the cost of just changing the name of NWFP → KP was almost **8 billion rupees**, and the creation of new provinces would lead to massive increase in public expenditure.

(8) Huge Administrative Disruption will be caused by the creation of new provinces

A number of administrative problems will surface with the creation of new provinces that will divert the attention of policy makers from economic growth. Issues like:

1. Division of assets and liabilities ✓
2. Settlement of legal issues ✓
3. Restructuring provincial administration ✓
4. Delimiting constituencies ✓
5. Redrawing provincial boundaries ✓
6. Reassigning civil servants ✓

(9) New provinces may worsen the intra-provincial or inter-regional inequalities

Well endowed areas will develop faster as compared to the other areas.

KP → Peshawar, Hazara

Quetta → Balochistan

whereas, the other areas may drift even more backward and will result in greater inequality.

(10) New provinces may lighten the conflicts when people become more divided

Pakistan's Provinces are already created along the ethnic and linguistic lines and these divisions already create a number of conflicts among provinces.

Reasons

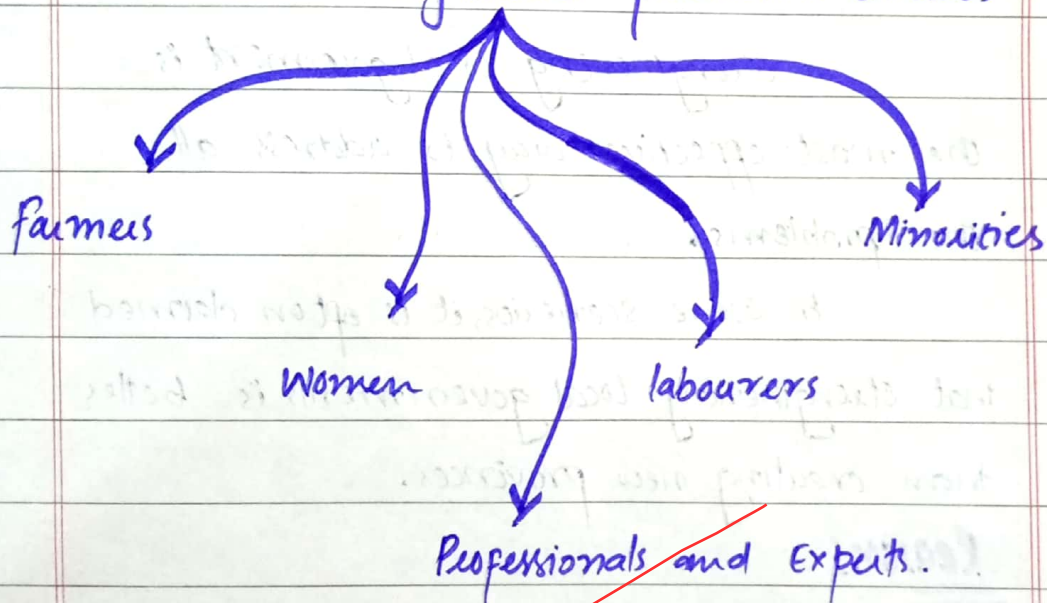
(i) local governments improve the service delivery at the grassroot levels as the basic services are within accessible range of common people.

(4) By according to Preferential treatment to the remote areas

It is recommended to accord to preferential treatment to the remote areas.

By promoting infrastructural development; increasing access to education, and healthcare services.

(5) By promotion of E-governance
