Cold war, the surge in terrorism and their

participation from the forefront appeared as new challenge. In history, the black slaves in USA and many other freedom demanding communities once targeted as terrorists. The dilemma lies in the difference of views of the same event. Moreover, the birth of International organizations and International Law is responsible for deciding whether a group is terrorist or freedom fighter. Ironically, UN has not yet clearly defined terrorism and became a tool to control weak forces. A weak force' freedom fighter can easily be claimed as terrorist. Whereas, a terrorist group with strong back blatantly awarded with title of 'freedom fighters'. Currently, the world is witnessing the Gaza-Israel and Ukraine-Russia rivalries. Firstly, the methods of wars, alliances and to control others has changed. Secondly, in every era different groups make alliances for different purposes and the shift and end of previous alliances after Cold war. Thirdly, the new tools of war

are emerged and now the battlefield is ruled by soft powers. Hence, the concept of labelling is also politicized.
