Summarize the ideas and views expressed by the American diplomat George F. Kennan. How did these views shape US containment policy during the Cold War?

Ans: 1. Introduction:

Kennan emerged as the intellectual architect of containment. Kennan argued that the Soviet Union's expansionist tendencies could be checked not through direct military confrontation but through patient, firm, and vigilant containment.

3. **Non-military Tools:** Kennan stressed the use of political, economic, and diplomatic instruments rather than military aggression.

4. **Selective Engagement:** He advised focusing on strategically vital regions such as Western Europe, Japan, and the Middle East, rather than attempting global intervention.

5. **Belief in Soviet Weakness:** Kennan predicted that if contained effectively, the Soviet system would eventually collapse under its own internal contradictions.

1. **Truman Doctrine (1947):** Kennan's ideas influenced President Truman's pledge to support Greece and Turkey against communist pressure, marking the formal adoption of containment.

2. Marshall Plan (1948): Economic aid to rebuild Western Europe reflected Kennan's vision of strengthening allies to resist Soviet influence.
3. NATO Formation (1949): The establishment of a collective security alliance embodied Kennan's call for firmness and vigilance.
4. Global expansion of Containment: While Kennan envisioned limited containment, U.S. Policy makers extended it worldwide, leading to interventions in Korea, Vietnam, and other regions.
5. Militarization of Policy: Kennan opposed excessive reliance on military force, but later administrations emphasized military alliance and interventions, diverging from his original vision.
