Major School of Thoughts :

① Consensus View :

According to this School of thought, Crime is referred to any act or omission which is considered as against law.

For Example: Murder, Theft etc

② Conflict view :

According to their point of view, power holders makes laws. In this way they label only those ^{acts as} crimes which is of not their concerns. Means any act which aligns to their interests are not considered as crime, although it may have sinister or harmful impacts on society.

Example: Cigarette is dangerous for health, but still cigarette e-company utilize almost \$89.4 million on its advertisement.

Scope of Criminology:
