The United Nations Security Council is the guarantor of global security, but it is paralyzed due to veto politics of its permanent members. For example, in Gaza, United Nations General Assembly passed a resolution for immediate peace in Gaza, but American vetoed the resolution. States used veto power for their geopolitical interest instead of peace making and peace building. International law exists. But the states considered it as optional. When states feel convenient they used them and if non-convenient, they ignored it.



States and international community can prioritize the conflicts on the basis of their interest. For example most of the states and media talking about Russian-Ukraine war, but not about the civil war in Sudan where almost half a million of infants were died due malnutrition and food shortages.
