Honour killing is a crime which is celebrated in Pakistan especially in rural areas. Every year numerous individuals are killed in the name of honour however, only a few cases are reported or brought to light. Most of these cases ~~are reported from rural areas. The religious~~ Molvis promote a wrong sense of honour and even support such actions. Sometimes honour killing is done on mere suspicion and false accusation without proper evidence or investigation.

There are numerous causes of honour killing. To begin with, honour killing is the result of illiteracy. According to Moeed Yousaf "rural areas in Pakistan have 90% illiteracy rate". Lack of education

paves way for numerous evils in the society. Honour killing is predominant in rural areas with low literacy rate.

In addition to that, poor social conditions often perpetuates honour killing. Underdeveloped areas often have high percentage of such crimes. Poor social conditions undermines human development both socially and mentally. In the absence of proper institutes, bad system dominates. Banned laws are created and enforced by Bani system. It legalizes honour killing and promotes such heinous crime.

Victims often lose their lives before being able to contact law enforcing agencies. Poor law enforcement and security conditions also leads to the continuity of this crime. Rural areas of Balochistan have a higher rate of honour killing due to poor security conditions.
